

Colombian Climate Finance Committee

The committee is one of the working groups of the Colombian Climate System - SISCLIMA

What is it?

The committe is an **advisory body** that facilitates the **coordination of public and private actors** to **mobilize financial resources** for mitigation and adaptation to climate change in Colombia

Visión

By 2030, climate change criteria will be incorporataed in the whole planning, implementation and assessment cycle of policies and investment projects. In addition, climate compatible development funding will be guaranted in a sustainable and scalable manner

Institutional framework and members

Colombia Policy Document CONPES 3700 - 2011 Recommends the creation of the National Climate Change System – SISCLIMA – which includes the Climate Financial Management Committee

Decree 298 of 2016

Establishes the SISCLIMA and formalizes the creation of the Climate Financial Management Committee

Agreement 001 of 2016 of the CICC

Adopts SISCLIMA's regulations and defines guidelines for the Climate Financial Management Committee (objective, members, functions)



Challenges and opportunities

Colombia unconditional NDC target component sets ambition to mobilize domestic climate finance

- Building the project portfolio for the NDC Partnership with sectors, subnational level governments, development banks and private sector.
