# Background

---

## ➤ *Mandate*

- Parties were invited to submit their views on the workplan of the forum and its KCI via the submission portal (Decision 7/CMA.1)

## ➤ *Submissions received (as of 10 June 2019)*

- 2 Parties (USA, South Africa)
- 2 group of Parties (EU, G77 & China)
- 1 intergovernmental organization (OPEC)
- 1 observer organization (ITUC)



# Approach to synthesis

---

- This synthesis captures key views of Parties and observers
- Views are presented with no judgement
- Some submissions proposed **annual themes** while some submissions proposed **workplan activities**.
  - To facilitate **simplified presentation** of views and to facilitate **discussions** on development of workplan, proposed **workplan activities** have been **grouped** under a proposed **theme**, as considered appropriate
  - The modality for the workplan activity and which body should undertake the activity have also been highlighted, wherever proposed in submissions



## General views on organization of work between the forum and the KCI

---

- Most of the Parties have a view that KCI engages in technical discussions whilst the forum serves as a platform for Parties to enable general sharing of experiences and allow discussions in an inclusive, collaborative environment.
- One Party had a view that the KCI proposes its workplan which is then evaluated by the forum to ensure its alignment with forum's workplan **vs** one Party had a view that workplan for the forum & the KCI is outlined by Parties



## General views on organization of workplans

---

- Most parties proposed six year workplan *vs.* one Party proposed 4.5 half-year workplan until review scheduled in 2023
- Most Parties proposed annual workplan/themes for each WPA *vs.* one Party proposed one annual thematic area
- Some Parties proposed to have 6-year rolling workplan with agreed themes with the first three years having fully developed activities and last three years being thematic-based and elaborated in future taking into account emerging activities and any follow up work.
- All Parties proposed that the workplan of the Forum and the KCI are synchronized and workplans to be inline with the forum's function, work programme and modalities

- Parties have proposed a modality for most of the proposed workplan activities
- All Parties have views to have workplan in tabular format with clear timeline, activity and output

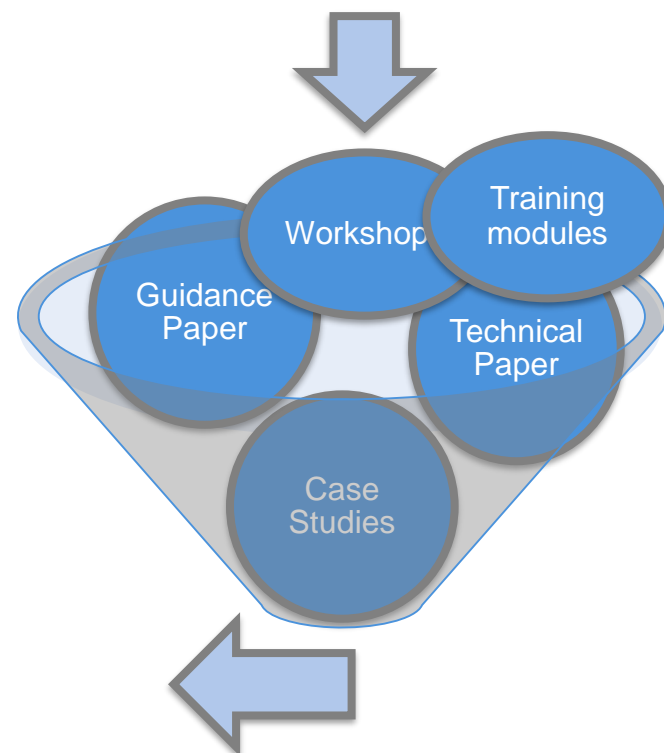


## Views for WP on WPA economic diversification and transformation

- J 1.2 Fostering mutually beneficial partnerships to create decent work and quality jobs in domestic manufacturing of renewable energy technologies and development of niche products and services with a view to creating inclusive growth of green value chains between developed and developing countries (KCI-WP)

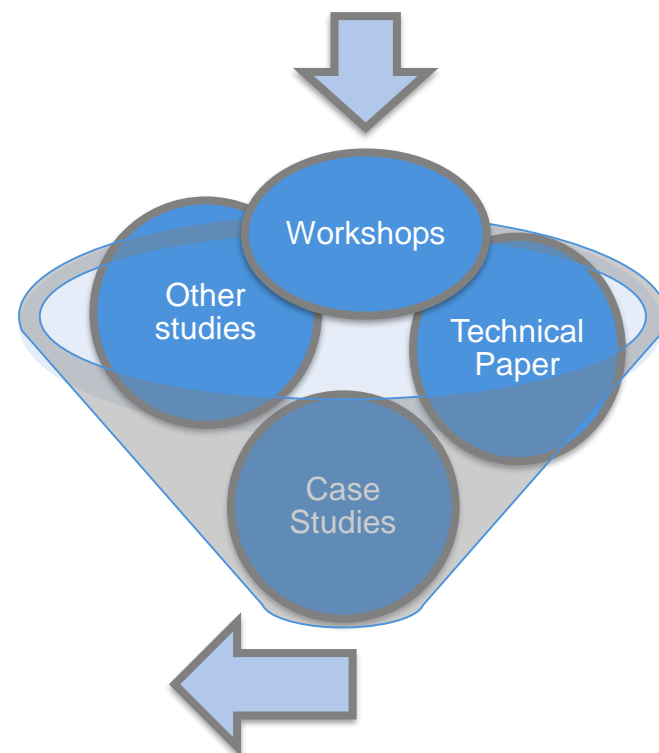

## Views for WP on WPA assessment & analysis of impacts of RM

---

### *Theme A1: Application of existing methodologies and assessment tools to inform decision making*

- A1.1 **Case studies/technical paper** on modelling and assessing the cross border impact of the implementation of response measures on employment, decent work and quality jobs **(KCI-WP)**

### *Theme A2: Understanding the co-benefits of response measures*

- A2.1 **Receiving inputs and exchange of views** on how Parties and non-Party stakeholders assess and analyse the synergies and trade-offs with other policy objectives (e.g. creation of decent work and quality jobs, health, access to clean energy, biodiversity, local air pollution etc.) associated with the implementation of response measures, taking into account the urgency to act on climate change, the costs of inaction, and based on the best available science
- A 2.2 **Comparative assessments and verification** of the co-benefits RM and what means of support are required for EmaRM to leverage such co-benefits **(KCI-WP)**



## Views for WP on WPA assessment & analysis of impacts of RM

---

### *Theme A3: Assessment and analysis of impacts of response measures*

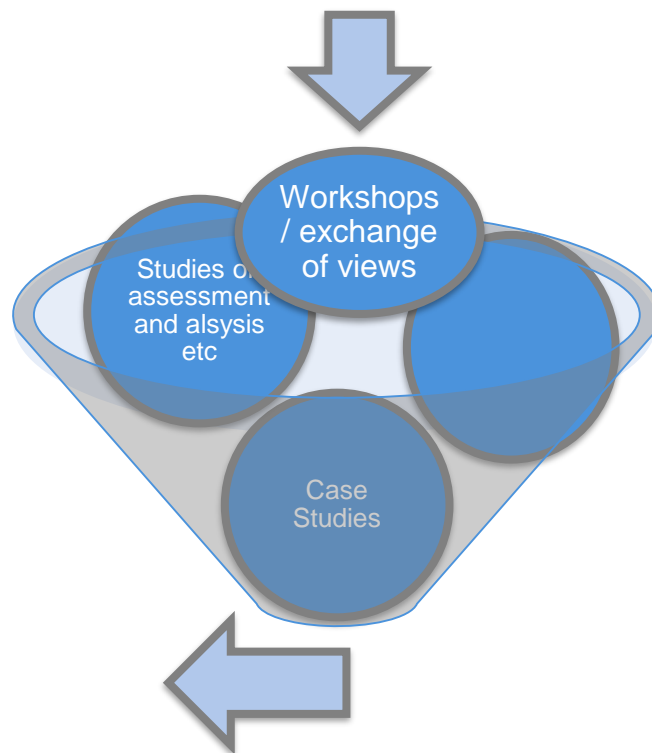
- A 3.1 **Identify response measures** targeting production and consumption and quantifying their cross border impacts, especially on their prospects of achieving economic transformation, inclusive growth and poverty reduction (KCI-WP)
- A 3.2 **Analyse and assess** strength and weakness of current reporting structures to enhance cooperation amongst Parties on understanding the impacts of response measures through the exchange of information through reporting and verification systems (KCI-WP)
- A 3.3 **Institute a systematic process** for periodic reporting of assessment and analysis of impacts of RM on EmaRM and reporting assessment and analysis of measures taken to minimize the impacts (KCI-WP)
- A 3.4 **case studies** on evaluating measures reported and taken to minimise the impacts of the implementation (KCI-WP)
- A 3.5 **Develop guidance** for assessing the environmental, social and economic impacts of policies and actions, including the use of existing tools and methodologies
- A 3.6 **Development of training modules** on assessing for assessing the environmental, social and economic impacts of policies and actions



## Views for WP on WPA assessment & analysis of impacts of RM

- *Theme A4: Across themes activities (forum-WP)*
  - E 4.1 Address response measures related implementation, monitoring, verification of provisions enjoining Parties to consider specific needs and concerns of Parties most affected by RM
  - E 4.2 Develop recommendations and specific actions to minimize the adverse socio-economic impacts of response measures taking into consideration work done by KCI and other processes under the Paris Agreement

## Views for WP on work programme area facilitating development of tools and methodologies for assessment of impacts

*Theme F1 : Overview of the current state of development of tools and methodologies to assess the impacts associated with the implementation of response measures.*

- F 1.2 Technical papers on existing modelling tools for assessment and analysis of impacts of climate policies and actions

*Theme F2: Promote cooperation and partnership to facilitate development of tools and methodologies*

- F 2.1 Workshop with other bodies to promote inter-body collaborations for developing technical support programs on assessments and analysis on policy issues of concern to Parties with EmaRM
- F 2.2 Develop initiatives with academia to develop tools and methodologies to assess the impacts of the implementation of response measures
- F 2.3 Develop initiatives with the private sector to develop tools and methodologies to assess the impacts of the implementation of response measures



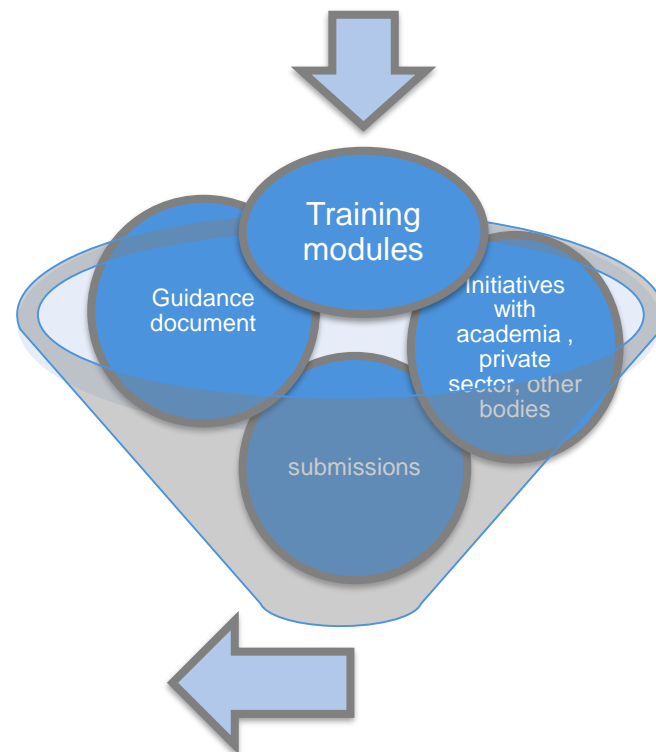
