


July 2019

- Together with a range of partners, the PCCB organized two Capacity-building Knowledge to Action Days during the UNFCCC regional climate weeks in Latin America and the Caribbean and in the Asia-Pacific. These full-day workshops provided a space for representatives of universities and research institutions to coordinate through the exchange of views and experiences on addressing capacity-building gaps and needs with relevant stakeholders involved in the preparation and implementation of national adaptation plans and nationally determined contributions, with a view to accelerating climate action and increasing ambition.

Technical inputs on capacity-building, and facilitation of a session at the 2019 SCF forum in Beirut, Lebanon

- Prior to the forum, the PCCB provided written technical inputs for the capacity-building sessions of the Forum, in the forum of proposals for session content, discussion guiding questions, case studies, tools and resource persons that could be considered
- The PCCB collaborated with the Standing Committee on Finance to moderate a session on 'Accelerating the mobilization and delivery of climate finance for cities'. This session focused on how cities can mobilize and access finance for their low-emission, climate resilient urban projects and opportunities to address the capacity constraints that city actors are facing. It explored ways to create the enabling environments and regulatory frameworks to unlock urban climate actions by the private sector.
