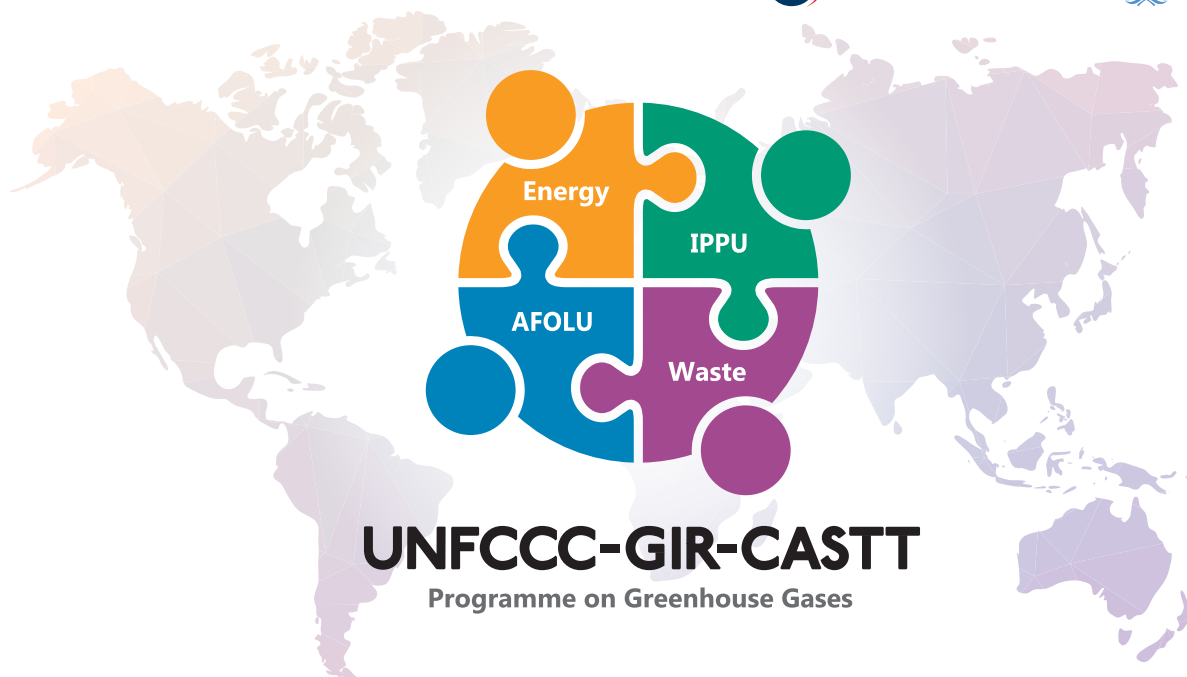

Offered in collaboration by the UN Framework Convention on Climate Changes (UNFCCC) Secretariat and the Greenhouse Gas Inventory & Research Center of Korea (GIR), UNFCCC-GIR-CASTT is a professional training on greenhouse gas (GHG) inventories to national experts from developing countries.

GHG inventories are a key source of information necessary to understand -and where each country, and the global community at large, stand in terms of GHG emissions. Through a tailored and focused approach, the programme aims to significantly boost the technical capacity of developing countries.

## About the GIR

As a government institute, the GIR serves as a think-tank on GHG inventory and mitigation. The GIR compiles national GHG inventory, supports establishing national and sectoral GHG reduction targets, and conducts research on the Emission Trading Scheme.

For global cooperation, the GIR organizes the Cooperative Green Growth Modeling Forum (C2GMF) and the International Modeling Conference (IMC) as well as its unique GHG training programme since 2011.
