#### I. Mandate

1. Decision 4/CP.22 provides recommendations regarding the review of the WIM.

# II. Objective

2. By the same decision, the 2024 review will consider, inter alia, progress on the implementation of the workplan of the WIM Executive Committee, as well as its long-term vision that guides ways in which the WIM may be enhanced and strengthened, as appropriate.

Inputs and possible additional elements for Objective

- i. How the ExCom continues to promote the implementation of the WIM
- ii. How the functions of the mechanism are implemented through ExCom and Santiago network
- iii. How the activities and workplans of the ExCom and the Santiago network made progress in the implementation of WIM's functions
- How the landscape for averting, minimizing and addressing L&D has evolved since the last review
- v. Suggestion for deletion of part of the **Objective** long-term vision that guides the enhancement of the WIM
- vi. Deletion of reference to ExCom to change the **Objective** to How the WIM continues performing its functions and how it continues to promote the implementation of approaches to avert, minimize and address L&D

# III. Scope

3. Parties will review the WIM since its establishment in 2013, taking into account those segments of the population that are already vulnerable in accordance with decision 3/CP.18, paragraph 7(a)(iii).<sup>1</sup>

- ii. Add 'synergy' to assess WIM's effectiveness and efficiency
- iii. Change 'effectiveness and efficiency' of the WIM with contribution of the WIM, for improvements in timeliness, etc.
- iv. Merge with 4(f) and delete from 5(a) all elements except for coherence and complementarity, and in particular with the funding arrangements for responding to loss and damage, including the fund
- (b) Barriers and gaps, challenges and opportunities, and lessons learned.

i. In the context of the implementation of the WIM

Inclusion of references to the Paris Agreement in the terms of reference does not prejudge the outcome of the consideration of matters related to the governance of the WIM.
