#### Annex

The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement at its fourth session launched the Sharm el-Sheikh dialogue between Parties, relevant organizations and stakeholders to exchange views on and enhance understanding of the scope of Article 2, paragraph 1(c), of the Paris Agreement and its complementarity with Article 9 of the Paris Agreement, and requested the secretariat, under the guidance of the Presidency of COP 27, to organize two workshops in 2023 in this regard.<sup>1</sup>

The first workshop under the dialogue, facilitated by Ambassador Tosi Mpanu-Mpanu, was held in Bangkok from 19 to 20 July 2023, co-hosted by the Government of Thailand and the United Nations Economic and Social Commission for Asia and the Pacific.<sup>2</sup>

The second workshop under the dialogue will take place at the International Conference Center Geneva in Geneva from **3** to **4 October 2023.** Further details, including the provisional programme and logistical information, will be made available in due course at <a href="https://unfccc.int/topics/climate-finance/workstreams/sharm-el-sheikh-dialogue">https://unfccc.int/topics/climate-finance/workstreams/sharm-el-sheikh-dialogue</a>.

Representatives of admitted NGOs nominated by constituency focal points must register for the dialogue using the online registration form, which will be communicated to the nominated participants. Kindly note that, owing to the limited capacity of the venue, only **two representatives per constituency** will be permitted to participate **in person**. Constituency focal points are requested to submit their nomination list no later than **Monday**, **14 August 2023** via cool@unfccc.int.

All other interested observers may participate virtually. The deadline for **registration for virtual participation** through the constituency focal points is **Friday**, **15 September 2023**. In view of the need to confirm arrangements for the workshop as early as possible, registrations received after the abovementioned deadlines may not be processed. Further details relevant to in-person and virtual participation in the workshop will be communicated directly to the registered participants.

In addition, to allow for further inputs to be reflected in the organization of the second workshop, we would like to remind Parties, relevant organizations and stakeholders to submit their views on the scope and focus of discussions on the dialogue to <a href="mailto:climatefinance@unfccc.int">climatefinance@unfccc.int</a> by Monday, 14 August 2023.
