

Recommendation

Appropriate levels of the share of proceeds for administrative expenses and its operation

Version 01.0



- 1. The share of proceeds for administrative expenses shall comprise:
 - (a) The fee to be paid for requesting for registration of an activity under the mechanism established by Article 6, paragraph 4, of the Paris Agreement (A6.4 Mechanism) (the registration fee), which is:
 - (i) Maximum USD 2,000 for an activity with annual average emission reductions or removals over the (first) crediting period up to 15,000 tCO₂e;
 - (ii) Maximum USD 6,000 for an activity with annual average emission reductions or removals over the (first) crediting period between 15,001 and 50,000 tCO₂e;
 - (iii) Maximum USD 12,000 for an activity with annual average emission reductions or removals over the (first) crediting period above 50,000 tCO₂e, or for a programme of activities;
 - (iv) To be consumed for processing the request for registration, and not to be deemed as an advance payment of the issuance fee referred to in subparagraph (b);
 - (b) The fee to be paid for requesting for issuance of A6.4ERs for an activity registered under the A6.4 Mechanism (the issuance fee), which is a maximum USD 0.20 per A6.4ER being requested for issuance;
 - (c) The fee to be paid for requesting for renewal of an activity registered under the A6.4 Mechanism (the renewal fee), which is at the same level at maximum as the registration fee applicable to the activity based on its scale of emission reductions or removals as referred to in subparagraph (a);
 - (d) The fee to be paid for requesting for approval of post-registration change of an activity registered under the A6.4 Mechanism (the post-registration change fee), which is at maximum USD 2,000 per request.
- 2. All the fees referred to in paragraph 1 above shall be waived for activities in the least developed countries and small island developing States.
- 3. The Supervisory Body shall determine a specific fee level for each fee type when implementing the fee structure and levels in this recommendation, and may modify the specific fee level as appropriate in the future, based on the review of the balance of funds raised from the fees and the expenditure, within the respective maximum levels referred to in paragraph 1 above.
- 4. The fees shall be paid at submission of the respective requests to initiate their processing under the activity cycle of the A6.4 Mechanism.
- 5. The paid fees shall be reimbursed partially or in full under certain conditions to be specified by the Supervisory Body.
