

Seventeenth meeting of the Adaptation Committee – approach and revised draft schedule (as of 24 March 2020)

One or two teleconference slots will be scheduled each day, to which registered observers are invited. These slots will be followed by offline time for AC members’ discussion on a dedicated collaboration space. The meeting will be broadcasted via Facebook Live and YouTube Live to enhance transparency and will also be available afterwards on demand.

Due to the limitations of a virtual meeting, it will not be possible to take decisions on all agenda items. Items will therefore be divided into two categories:

1. Key items that require more extensive inputs and guidance from the AC immediately, and
2. Other items to be advanced during the inter-sessional period and discussed in more detail at AC 18.

Only the key items will be introduced during the virtual conference slots. After this “live” exchange AC members will be invited to continue work on a dedicated collaboration space for AC members only. Key items are:

- All items addressing mandates from the CMA (agenda item 6 a, b, c, d and f)
- The AC’s technical paper on data for adaptation at different spatial and temporal scales (item 8.c).
