Status report of the annual inventory of Kazakhstan

1. This status report was prepared by the secretariat pursuant to decision 22/CMP.1 in conjunction with decision 4/CMP.11 as part of the initial check of Kazakhstan's 2023 annual greenhouse gas inventory, submitted in accordance with decisions 24/CP.19 and 15/CMP.1 in conjunction with decisions 3/CMP.11 and 2/CMP.8.

2. The report reflects the content of the inventory submission as submitted by the Party, which, in accordance with decision 24/CP.19, is due by 15 April each year (dates of submission are provided in the table on p.2).

3. In accordance with decisions 24/CP.19 and 6/CP.27, Parties report aggregate emissions and removals in carbon dioxide equivalent using the global warming potential values from the Fourth or Fifth Assessment Report of the Intergovernmental Panel on Climate Change over a 100-year time-horizon.
