## **Status report of the annual inventory of Cyprus**

### **Note by the secretariat**

The status report of the annual inventory of Cyprus was published on 29 June 2017. For purposes of rule 10, paragraph 2, of the Rules of procedure of the Compliance Committee (annex to decision 4/CMP.2, as amended by decisions 4/CMP.4 and 8/CMP.9), the report is considered received by the secretariat on the same date. This report, FCCC/ASR/2017/CYP, contained in the annex to this note, is being forwarded to the Compliance Committee in accordance with section VI, paragraph 3, of the annex to decision 27/CMP.1 and paragraph 49 of the annex to decision 22/CMP.1.



## Status report of the annual inventory of Cyprus

1. This status report was prepared by the secretariat pursuant to decision 22/CMP.1 in conjunction with decision 4/CMP.11, as part of the initial check of Cyprus's annual inventory, submitted in accordance with decisions 24/CP.19 and 15/CMP.1 in conjunction with decisions 3/CMP.11 and 2/CMP.8. It reflects the content of the 2017 inventory submission as submitted by the Party (dates of submission are provided in the tables on pages 2 and 3).
