### I. Opening of the session

(Agenda item 1)

1. CMA 4, convened pursuant to Article 16, paragraph 6, of the Paris Agreement, was held at the Sharm el-Sheikh International Convention Center in Sharm el-Sheikh, Egypt, from 6 to 20 November 2022. Sameh Shoukry (Egypt), President of CMA 4, opened the session on Sunday, 6 November.

### II. Organizational matters

(Agenda item 2)

### A. Adoption of the agenda

(Agenda sub-item 2(a))

- 2. At its 1<sup>st</sup> meeting,<sup>2</sup> on 6 November, the CMA considered document FCCC/PA/CMA/2022/1/Add.4 containing the supplementary provisional agenda and the revised list of documents to be considered under agenda item 8, "Matters relating to finance".<sup>3</sup> The President noted that the document reflected the outcome of intensive consultations and thanked all Parties for their constructive engagement. The President recalled the understanding reached among Parties outlined at the 1<sup>st</sup> meeting of COP 27.<sup>4</sup>
- 3. The President proposed that the agenda be adopted as contained in document FCCC/PA/CMA/2022/1/Add.4.
- 4. On the proposal by the President, the CMA adopted the agenda as follows:

On 26 September 2022, the secretariat issued document FCCC/PA/CMA/2022/1, containing the provisional agenda and annotations, prepared in agreement with the President of CMA 3 after consultation with the Bureau. On 30 September 2022, the secretariat issued document FCCC/PA/CMA/2022/1/Corr.1. On 28 October 2022, the secretariat issued document FCCC/PA/CMA/2022/1/Add.1 containing the supplementary provisional agenda. - 17. Administrative, financial and institutional matters:

- 20. Conclusion of the session:

- 5. The President welcomed the agreement of Parties to include the agenda item entitled "Matters relating to funding arrangements responding to loss and damage associated with the adverse effects of climate change, including a focus on addressing loss and damage" in the agendas for COP 27<sup>7</sup> and CMA 4 and expressed his appreciation to Jennifer Morgan (Germany) and Maisa Rojas (Chile) for their tireless work in conducting ministerial consultations on this matter. The President acknowledged that the inclusion of the agenda item reflects solidarity and empathy with the suffering of the victims of climate-induced disasters.

#### B. Election of additional officers

(Agenda sub-item 2(b))

- The CMA considered this matter at its resumed 10<sup>th</sup> meeting, on 20 November. No election of additional officers was required.<sup>8</sup>
- 7. The President informed Parties that nominations for election to bodies under the Paris Agreement were outstanding and urged constituencies to continue consultations and submit the outstanding nominations to the secretariat as soon as possible and by 28 February 2023 at the latest. On the proposal by the President, the CMA agreed that once the outstanding nominations have been received by the secretariat, the nominees will be deemed elected at CMA 4 in accordance with established practice.

### C. Organization of work, including for the sessions of the subsidiary bodies

(Agenda sub-item 2(c))

#### 1. Referral of work to the subsidiary bodies and organization of the Conference

- 8. At the 1<sup>st</sup> meeting, the President proposed that the CMA follow the organization of work agreed by the COP.<sup>9</sup>
- 9. At the same meeting, the President informed Parties that the CMA would take appropriate action on the basis of recommendations of the SBSTA and the SBI on the following items on its agenda:

- 10. On a proposal by the President, the CMA agreed to refer to the SBI consideration of the provision of financial and technical support to developing country Parties for reporting and capacity-building a matter under CMA 4 agenda item 5, "Reporting and review pursuant to Article 13 of the Paris Agreement", and to refer to the SBSTA and the SBI consideration of the review of the progress, effectiveness and performance of the Adaptation Committee a matter under CMA 4 agenda item 6, "Matters relating to adaptation".
- 11. The President recalled that the secretariat had prepared document FCCC/PA/CMA/2022/4 on nationally determined contributions in response to decisions 1/CMA.3, paragraph 30, and 1/CMA.2, paragraph 10, and document FCCC/PA/CMA/2022/8 on long-term low-emission development strategies referred to in Article 4, paragraph 19, of the Paris Agreement in response to decision 1/CMA.3, paragraph 34.
- 12. The President informed Parties that he would convene consultations on the overarching decisions<sup>10</sup> at the level of heads of delegation, facilitated by senior representatives of the Presidency.
- 13. The President also informed Parties that on Thursday, 17 November, and Friday, 18 November, the CMA would reconvene to consider draft decisions and conclusions for adoption.

14. The CMA agreed to proceed on the basis of the information presented by the President.

#### 2. Opening statements

15. On 6 November, a joint meeting of COP 27, CMP 17, CMA 4, SBSTA 57 and SBI 57 was held to hear opening statements.<sup>11</sup>

#### 3. Informal stocktaking

- 16. During the Conference, the President convened four informal stocktaking plenaries, on 14, 15, 17 and 18 November, 12 with the aim of enhancing the openness, inclusiveness and transparency of the negotiations. During the informal plenaries, the President provided an assessment of progress and shared his plans for advancing work in order to reach successful outcomes.
- 17. At the first informal stocktaking plenary, the President stated that he would appoint co-facilitators to lead technical discussions on items forwarded by the subsidiary bodies at the conclusion of their sessions and items under the governing bodies, with the aim of completing technical work by Wednesday, 16 November.<sup>13</sup>
- 18. At the second informal stocktaking plenary, the President stated that he would appoint ministers to assist him in facilitating discussions on the matters that were ready for higher-level political engagement.<sup>14</sup>

#### 4. Conclusion of work

- 19. At the 10<sup>th</sup> meeting, on 20 November, the President recalled that world leaders had gathered at the session under the theme "Together for Implementation" to deliberate on how to advance the global climate agenda and translate climate commitments into implementation. The President noted that the outcomes of the session provided a gateway to scaled-up implementation and transformation towards a future of climate neutrality and climate-resilient development. The President expressed his deep appreciation to Parties for their willingness to work constructively to deliver the achieved results.
- 20. At the resumed 10<sup>th</sup> meeting, on a proposal by the President, the CMA adopted decision 1/CMA.4, entitled "Sharm el-Sheikh Implementation Plan".
- 21. Also at the resumed meeting, the President informed the CMA that no consensus had been reached in the Presidency consultations on including the following matters in the agenda for CMA 4:
- (a) "Matters relating to Article 2, paragraph 1(c), of the Paris Agreement" a matter proposed by France on behalf of the European Union and by Switzerland on behalf of the Environmental Integrity Group;
- (b) "Seventh review of the Financial Mechanism" a matter proposed by the United States of America:
- (c) "Limiting global warming to 1.5 °C" a matter proposed by Switzerland on behalf of the Environmental Integrity Group;
- (d) "Implementation of decisions 1/CP.26, paragraph 11, and 1/CMA.3, paragraph 18, on adaptation finance" a matter proposed by Pakistan on behalf of the Group of 77 and China.

### D. Approval of the report on credentials

(Agenda sub-item 2(d))

- 22. At the 9<sup>th</sup> meeting, on 17 November, the President referred to the report on credentials, <sup>15</sup> which the Bureau, in accordance with rule 20 of the draft rules of procedure being applied, had examined and approved.
- 23. On the basis of the report of the Bureau, the CMA accepted the credentials of Parties attending the session. In addition, the secretariat received credentials from Senegal on 18 November 2022, the Marshall Islands on 19 November 2022, Côte d'Ivoire on 16 December 2022, Namibia on 22 December 2022 and Kenya on 3 January 2023.

#### E. Attendance

- 24. Information on participation in the sessions in Sharm el-Sheikh is available in document FCCC/CP/2022/INF.3.
- 25. According to decision 2/CMA.1, the admission of organizations as observers as decided by the COP also applies to the CMA. Observer organizations newly admitted to the sessions of the COP, the CMP and the CMA are listed in document FCCC/CP/2022/7.<sup>16</sup>

#### F. Documentation

26. The documents that were before CMA 4 are available on the UNFCCC website.<sup>17</sup>

### III. Reports of the subsidiary bodies

(Agenda item 3)

### A. Report of the Subsidiary Body for Scientific and Technological Advice (Agenda sub-item 3(a))

- 27. At the 9<sup>th</sup> meeting, the SBSTA Chair, Tosi Mpanu Mpanu, introduced the draft report on SBSTA 57<sup>18</sup> and gave an oral report on the results of SBSTA 56 and 57.<sup>19</sup>
- 28. On a proposal by the President, the CMA took note of the report on SBSTA 56,<sup>20</sup> the draft report on SBSTA 57 and the oral report provided by the SBSTA Chair. The President noted that recommendations of the SBSTA would be adopted under the relevant agenda items.

### B. Report of the Subsidiary Body for Implementation

(Agenda sub-item 3(b))

29. At the 9<sup>th</sup> meeting, the SBI Chair, Marianne Karlsen (Norway), introduced the draft report on SBI 57<sup>21</sup> and gave an oral report on the results of SBI 56 and 57.<sup>22</sup>

- 30. On a proposal by the President, the CMA took note of the report on SBI 56,<sup>23</sup> the draft report on SBI 57 and the oral report provided by the SBI Chair.
- 31. On a recommendation of the SBI, the CMA adopted decision 22/CMA.4, entitled "Action plan under the Glasgow work programme on Action for Climate Empowerment".<sup>24</sup>
- 32. The President noted that other recommendations of the SBI would be adopted under the relevant agenda items.

# IV. Matters relating to the work programme for urgently scaling up mitigation ambition and implementation referred to in paragraph 27 of decision 1/CMA.3

(Agenda item 4)

- 33. At its  $1^{st}$  meeting, the CMA noted that this matter was on the agendas of the SBSTA and the SBI.<sup>25</sup>
- 34. At the 10<sup>th</sup> meeting, the President thanked the Chairs of the SBSTA and the SBI for forwarding the outcomes of the work of the SBSTA and the SBI<sup>26</sup> and stated that he had undertaken further consultations on this matter.<sup>27</sup>
- 35. A representative of one Party speaking on behalf of the Environmental Integrity Group made a statement.<sup>28</sup>
- 36. At the same meeting, on a proposal by the President, the CMA adopted decision 4/CMA.4, entitled "Matters relating to the work programme for urgently scaling up mitigation ambition and implementation referred to in paragraph 27 of decision 1/CMA.3".

### B. Budget performance for the biennium 2020–2021

(Agenda sub-item 17(b))

- 103. At its 1st meeting, the CMA noted that these matters were on the agenda of the SBI.75
- 104. At its 9<sup>th</sup> meeting, on a proposal by the President, the CMA endorsed the following decisions of the COP:
- (a) Decision 26/CP.27, entitled "Administrative, financial and institutional matters":  $^{76}$
- (b) Decision 27/CP.27, entitled "Administrative, financial and institutional matters". $^{77}$

105. At the resumed 10<sup>th</sup> meeting, the President recalled that he had appointed Paul Watkinson (United Arab Emirates) to hold consultations on his behalf regarding the proposal by Zambia on behalf of the African Group to include in the provisional agenda for CMA 4 an item entitled "Special needs and special circumstances of Africa", and to report back to the CMA, under this agenda item, on the outcomes of the consultations and any other issues raised.

106. The President informed the CMA of the following outcomes and issues raised:

- (a) Written inputs on this matter were received from Chile on behalf of the Independent Association for Latin America and the Caribbean and from the African Group;<sup>79</sup>
- (b) Parties acknowledged the urgent and immediate needs of developing countries that are particularly vulnerable to the adverse effects of climate change, including the special needs and circumstances of Africa, and underlined the messages in the contribution of Working Group II to the Sixth Assessment Report of the Intergovernmental Panel on Climate Change;<sup>80</sup>
- (c) Parties expressed an interest in having a space to discuss wider needs and general matters related to the special circumstances of developing countries at the regional level; however, the President noted that this did not fulfil the purpose of the consultations, which was to consider the proposal to include an item on the special needs and circumstances of Africa in the agenda;
- (d) Despite the constructive engagement of all Parties, there was no consensus on either the original proposal or any of the other proposals made during the consultations.
- 107. At the same meeting, a representative of one Party on behalf of the African Group made a statement requesting that the matter regarding the special needs and circumstances of Africa be considered at the next session of the CMA.<sup>81</sup> The President took note of the statement.
- 108. The CMA noted that no other matters had been raised under this agenda item.

#### XX. Conclusion of the session

(Agenda item 20)

109. At the joint 11<sup>th</sup> meeting of COP 27, CMP 17 and CMA 4, on 20 November, the President, the Executive Secretary and representatives of groups of Parties and observer organizations made closing statements.<sup>82</sup>

### A. Adoption of the draft report on the session

(Agenda sub-item 20(a))

- 110. At its resumed 10<sup>th</sup> meeting, the CMA considered the draft report on the session<sup>83</sup> and, on a proposal by the President, authorized the Rapporteur to complete the report under the guidance of the President and with the assistance of the secretariat.
- 111. The Deputy Executive Secretary informed the CMA that the decisions it adopted under nine agenda items have financial and human resource implications beyond the provisions included in the budget for the biennium 2022–2023, and that funding estimates and categorization of activities are preliminary and based on the information available at the time:
- (a) Under agenda sub-item 3(b), "Report of the Subsidiary Body for Implementation", EUR 889,000 will be required in 2023 to to implement relevant activities of the action plan under the Glasgow work programme on Action for Climate Empowerment, including providing in the annual summary report under the Glasgow work programme information on materials, resources and findings as set out in the action plan. The same estimate was reported under the equally titled COP 27 agenda sub-item 3(b). This activity is

recurring or long-term<sup>84</sup> and would therefore be funded from the core budget in future (post-2023) bienniums if approved by the appropriate governing bodies;

- (b) Under agenda item 4, "Matters relating to the work programme for urgently scaling up mitigation ambition and implementation referred to in paragraph 27 of decision 1/CMA.3", EUR 1.2 million will be required in 2023 to organize and prepare a report on work programme dialogues, including investment-focused side events. These activities are temporary or short-term and would therefore be funded from supplementary funds;
- (c) Under agenda sub-item 5(b), "Options for conducting reviews on a voluntary basis of the information reported pursuant to chapter IV of the annex to decision 18/CMA.1, and respective training courses needed to facilitate these voluntary reviews", EUR 467,000 will be required in 2023 to conduct voluntary reviews and develop and implement training courses. These activities are recurring or long-term and would therefore be funded from the core budget in future (post-2023) bienniums if approved by the appropriate governing bodies;
- (d) Under agenda sub-item 6(c), "Glasgow-Sharm el-Sheikh work programme on the global goal on adaptation referred to in decision 7/CMA.3", EUR 545,880 will be required in 2023 to hold all the workshops under the Glasgow-Sharm el-Sheikh work programme in person with the option for remote participants to actively take part. These activities are temporary or short-term and would therefore be funded from supplementary funds;
- (e) Under agenda item 7, "Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts", EUR 325,000 will be required in 2023 to support the process of selecting the Santiago network secretariat host, including the convening of an evaluation panel and assistance with the preparation of the evaluation report, as well as for continuing to provide support to developing countries that are particularly vulnerable to the adverse effects of climate change which may seek or wish to benefit from the technical assistance available from members of the Santiago network until the Santiago network secretariat is operational. In addition, EUR 575,000 will be required in 2023 to service and support the five-year rolling workplan of the WIM Executive Committee. The same estimate is provided under the equally titled COP 27 agenda item 7. Some of these activities are recurring or long-term and would therefore be funded from the core budget in future (post-2023) bienniums if approved by the appropriate governing bodies, and some are temporary or short-term and would therefore be funded from supplementary funds;
- (f) Under agenda sub-item 8(f), "Matters relating to funding arrangements responding to loss and damage associated with the adverse effects of climate change, including a focus on addressing loss and damage", EUR 1.8 million will be required in 2023 to support the activities of the transitional committee on the operationalization of the new funding arrangements for responding to loss and damage and the fund established in paragraph 3 of decision 1/CP.27, including at least three meetings, two workshops and two synthesis reports, one on existing funding arrangements and innovative sources relevant to addressing loss and damage and one on the outcomes of the activities and deliverables. It would additionally support ministerial consultations to be convened by the current and incoming COP Presidencies to advance the consideration of this matter at the next session. The same estimate is provided under the equally titled COP 27 agenda sub-item 8(f). These activities are temporary or short-term and would therefore be funded from supplementary funds:
- (g) Under agenda item 12, "Report of the forum on the impact of the implementation of response measures", EUR 459,000 will be required in 2023 to compile submissions from Parties as input to the global stocktake and to organize a regional workshop on activity 2 of the forum's workplan. The same estimate is provided under the equally titled COP 27 agenda item 12 and CMP 17 agenda item 9. These activities are temporary or short-term and would therefore be funded from supplementary funds;
- (h) Under agenda item 13, "Guidance on cooperative approaches referred to in Article 6, paragraph 2, of the Paris Agreement", EUR 962,000 will be required in 2023 to set up an Article 6 database and related infrastructure, organize a workshop on a draft version of

the agreed electronic format prior to SBSTA 58 and implement and maintain a training programme for technical experts. These activities are recurring or long-term and would therefore be funded from the core budget in future (post-2023) bienniums if approved by the appropriate governing bodies;

- (i) Under agenda item 14, "Rules, modalities and procedures for the mechanism established by Article 6, paragraph 4, of the Paris Agreement", EUR 105,000 will be required in 2023 to compile submissions for consideration at SBSTA 58 and to expedite the implementation of the capacity-building programme referred to in paragraph 14 of decision 3/CMA.3. These activities are recurring or long-term and would therefore be funded from the core budget in future (post-2023) bienniums if approved by the appropriate governing bodies.
- 112. The Deputy Executive Secretary also informed the CMA that resource requirements for 2024 and beyond resulting from decisions taken at this session will be treated in line with the established budgetary process.

#### B. Closure of the session

(Agenda sub-item 20(b))

- 113. At its resumed 10<sup>th</sup> meeting, on a proposal by a Party, the CMA adopted resolution 1/CMA.4, entitled "Expression of gratitude to the Government of the Arab Republic of Egypt and the people of the city of Sharm el-Sheikh".
- 114. The President then declared CMA 4 closed.
