#### 摘要

本报告应第 1/CMP.3 号决定编写,该决定请适应基金董事会向作为《京都议 定书》缔约方会议的《公约》缔约方会议(CMP)的每届会议报告活动情况。本报 告涵盖 2022年7月1日至 2023年6月30日期间的情况,主要介绍适应基金的进 展,特别是 CMP 和作为《巴黎协定》缔约方会议的《公约》缔约方会议(CMA) 所授予任务的执行情况,并介绍适应基金董事会作出和采取并由 CMP 和 CMA 酌 情予以注意的决定和行动。适应基金董事会第 41 次会议后将印发一份增编,介 绍从7月1日至2023年10月12日的情况。

## 一. 导言

#### A. 任务授权

- 1. 《联合国气候变化框架公约》缔约方会议第七届会议(COP 7)决定设立适应基金。¹作为《京都议定书》缔约方会议的《公约》缔约方会议第三届会议(CMP 3)决定,适应基金的经营实体为适应基金董事会(董事会),由一个秘书处和一个托管人提供服务。²
- 2. CMP 3 请董事会在 CMP 各届会议上报告活动情况,并邀请全球环境基金向董事会提供秘书处服务,请世界银行担任适应基金托管人,这两项均为暂行安排。<sup>3</sup>
- 3. 作为《巴黎协定》缔约方会议的《公约》缔约方会议第一届会议(CMA 1)和 CMP 14 决定,自 2019 年 1 月 1 日起,适应基金应为《巴黎协定》服务,在所有涉及《巴黎协定》的事项上遵循 CMA 的指导并对 CMA 负责。CMP 14 还决定,适应基金将继续为《京都议定书》服务,直至《巴黎协定》第六条第四款规定的收益分成到位。4

#### B. 本报告的范围

- 4. 本报告详细介绍适应基金取得的进展,特别是 CMP和 CMA 委派的各项任务的执行情况,以及供 CMP和 CMA 酌情采取行动的各项建议。除非另有说明,报告涵盖 2022 年 7 月 1 日至 2023 年 6 月 30 日这一时期。
- 二. 供作为《京都议定书》缔约方会议的《公约》缔约方会议第十八届会议和(或)作为《巴黎协定》缔约方会议的《公约》缔约方会议第五届会议采取行动的建议
  - 5. CMP 和(或)CMA 不妨注意到董事会对 CMP  $17^5$  和 CMA  $4^6$  提出的指导意见的回应(见附件九)。
  - 6. 董事会请 CMP 和(或)CMA 注意报告所述期间的下述关键数字、行动和决定:

- (a) 董事会通过了 2023-2027 年第二个适应基金中期战略(中期战略)<sup>7</sup>,并批准了实施计划。<sup>8</sup> 该战略侧重于促进地方主导的适应行动;扩大项目规模并推广其成果;加强行动、创新、学习和共享等战略支柱之间的联系和协同作用。董事会向适应基金利益相关方广泛传播了新中期战略;
- (b) 董事会为 2023 年设定了 3 亿美元的资源调动指标,捐助方的数量将超过前一年;
- (c) 董事会通过了一个改进的提案提交程序,以加快对收到的越来越多的 提案的审查。这一进程使独立实体能够在滚动基础上提交所有供资窗口下的项目 或方案提案;
- (d) 适应基金信托基金的累计收入已达到 15.1720 亿美元,其中 2.1492 亿美元来自核证减排量货币化,12.3296 亿美元来自捐款,还有 6,931 万美元来自信托基金余额的投资收入。报告所述期间的收入总额为 2.8215 亿美元,其中 312 万美元来自核证减排量货币化,2.5097 亿美元来自额外捐款,2,806 万美元来自投资收入:
- (e) 收到了奥地利、加拿大、法国、德国、冰岛、爱尔兰、意大利、日本、新西兰、挪威、葡萄牙、大韩民国、斯洛文尼亚、西班牙、瑞典、瑞士、大不列颠及北爱尔兰联合王国、比利时瓦隆地区、加拿大魁北克省和秘书处的捐款,总额约为 2.5097 亿美元;
- (f) 已签署协议项下的未缴捐款有 1,851 万美元,认捐款中未缴付额达 2.1396 亿美元;
  - (g) 可用于新批准用资项目的资金达 3.5872 亿美元;
- (h) 2022 年的新认捐额达 2.43 亿美元。收到了下列国家的认捐: 奥地利、 法国、德国、冰岛、爱尔兰、意大利、日本、新西兰、挪威、葡萄牙、大韩民 国、斯洛文尼亚、西班牙、瑞典、瑞士、美利坚合众国、比利时瓦隆地区、加拿 大魁北克省、联合国基金会和秘书处;
- (i) 截至 2023 年 6 月 30 日,共有 55 个执行实体获得认证,包括 32 个国家执行实体(包括 10 个最不发达国家和 7 个小岛屿发展中国家的实体)、9 个区域执行实体和 14 个多边执行实体。在报告所述期间,适应基金董事会重新认证了 2 个国家执行实体和 2 个多边执行实体,使重新认证的执行实体总数达到 36 个(19 个国家执行实体、6 个区域执行实体和 11 个多边执行实体),并从经认证的独立实体名单中删除了 2 个国家执行实体;
- (j) 项目和方案累计核准额延续上升势头,增加了 14%,达到 10.6075 亿美元;
- (k) 新核准的供资总额达 1.3111 亿美元,包括具体的单一国家和区域性(多国)提案、中期战略下的赠款提案和准备工作赠款;

- (I) 执行实体提交的 8 个单一国家项目或方案提案获得批准,总额为 6,147 万美元。国家执行实体为不丹、哥斯达黎加、科特迪瓦和乌干达提交了四项建议,总额为 3,350 万美元;一个区域执行实体为瑙鲁和巴布亚新几内亚提交了两项建议,总额为 1,800 万美元;多边投资实体为蒙古和斯里兰卡提交了两项建议,总额为 996 万美元;
- (m) 为五个区域性(多国)项目核准了总额 5,819 万美元的资金,其中 1,324 万美元用于伯利兹、危地马拉和洪都拉斯; 1,400 万美元用于佛得角、几内亚比绍、圣多美和普林西比; 489 万美元用于柬埔寨、老挝人民民主共和国、泰国和越南; 1,204 万美元用于萨尔瓦多和洪都拉斯; 1,399 万美元用于印度和斯里兰卡;
- (n) 自适应基金投入运作以来,已核准的 156 个项目的累计付款达到 6.6496 亿美元,其中包括在本报告所述期间支付的 9,606 万美元。在执行的项目有 89 个,其中有 5 个项目已经开始执行,5 个项目已经完成。按部门划分,拨给粮食安全项目的赠款金额最多(19%),其次是农业项目(13.2%)和跨部门项目(11.9%);
- (o) 对适应基金资金的要求呈现积极增长态势,进入运作管道的项目和方案提案较上一个报告期间增加了近14%,总计3.785亿美元;
- (p) 适应基金董事会完成了第一个中期战略(2018-2022 年)的实施,并完成了创新、学习、项目扩大和强化直接获取资金的赠款供资窗口的第八和第九轮审查:
- (q) 董事会在执行创新机制活动方面取得了进展:批准了一个大型创新项目和两项小型创新赠款(总额为 550 万美元);适应基金气候创新加速器已进入运作的第三个年头,执行伙伴开发署和环境署-气候技术中心和网络分别发出了第二次和第三次提案征集呼吁;制定了执行实体应用适应基金创新指标的指南;
- (r) 董事会批准了专门用于强化直接获取资金的供资窗口的第一个项目(500万美元);
- (s) 继续在适应基金知识管理框架下开展活动,启动了关于强化直接获取资金的电子学习课程;作为国家交流的一部分,组织了一次虚拟知识博览会,由国家执行实体为印度尼西亚主办;出版知识产品;
- (t) 在适应基金准备方案下,继续通过关于创新、认证和强化直接获取资金等关键主题的虚拟和面对面活动,向经认证的国家执行实体和发展中国家提供获取和规划适应资金的准备和能力建设支持;南南知识交流和同行学习的方法;以及相关组织之间的协作和互补;
- (u) 董事会委托对适应基金的环境和社会政策进行独立审查,以便与相关的适应基金利益相关方协商,根据需要更新政策;
- (v) 董事会决定编写一份文件,其中载有关于性剥削和性虐待以及性骚扰的适应基金政策的备选方案;
  - (w) 继续实施经更新的适应基金性别政策和性别行动计划: 9

- (x) 董事会审议了关于加强民间社会参与的适应基金愿景和指导方针草案,并决定考虑设立"当选的积极民间社会观察员"地位;
- (y) 董事会修订了对 COVID-19 疫情的初步应对措施,<sup>10</sup> 并调整了已实施的适应措施,为各国和执行实体提供灵活性,以继续减轻疫情对适应基金组合的影响: <sup>11</sup>
- (z) 在适应基金下继续加强与其他气候基金的互补性和一致性,并与《气候公约》其他组成机构建立联系: 12
- (aa) 为适应基金利益关系方和广大气候金融界的利益,董事会发布了有针对性的信息通报,以展示适应基金项目、成功案例和实地的具体行动;提供有关新进展的信息,例如正在扩大规模的项目;并在 2023-2027 年中期战略中引入新的战略方向;
- (bb) 董事会注意到适应基金技术评价咨商小组(评价咨商小组)制定的初步指导意见,该指导意见将支持适应基金利益相关方执行适应基金新的评价政策;
- (cc) 董事会讨论了关于适应基金碳足迹的第一份概览文件<sup>13</sup>,并决定考虑减少基金碳足迹的备选方法。

# 三. 在报告所述期间开展的工作

7. 董事会在波恩举行了两次面对面会议: 第 39 次会议(2022 年 10 月 13 日至 14 日)和第 40 次会议(2023 年 3 月 23 日至 24 日)。有关会议的议程和说明(包括议程项目背景文件)以及详细报告可查阅适应基金网站。<sup>14</sup>

#### A. 选举适应基金董事会主席和副主席

8. 董事会第 39 次会议以协商一致方式<sup>15</sup> 选举 Antonio Navarra (意大利,西欧和其他国家)为主席,董事会第 40 次会议以协商一致方式选举 Lucas di Pietro (阿根廷,非附件一缔约方)为副主席。

#### B. 适应基金董事会的组成

9. 根据在 COP 27 和闭会期间举行的选举,董事会替换了几名成员和候补成员。董事会现任成员和候补成员名单载于附件一。由于没有提名新的代表,有几个席位仍然空缺。

#### D. 适应基金信托基金的资源

- 11. 截至 2023 年 6 月 30 日,托管人售出了 3,437 万适应基金核证减排量,收入 2.1492 亿美元。在报告所述期间,核证减排量货币化收入为 312 万美元,按照董事会通过的核证减排量货币化方案准则,仍有 1,215 万核证减排量可供出售。 16 截至同一时间,董事会已指示托管人向各执行实体转账共 6.6496 亿美元(见附件十)。
- 12. 可用于新批准用资项目的资金达 3.5872 亿美元。

#### E. 适应基金董事会的工作计划

13. 董事会第40次会议通过了2024财政年度的工作计划。17,18

#### F. 适应基金董事会、秘书处和托管人的预算

14. 董事会第 40 次会议审议并批准了用以支持董事会及其秘书处和托管人工作至 2024 年 6 月 30 日的资源(见附件二)。 19 2024 财年,董事会、秘书处、评价职能及托管人的核定行政估算为 12,726,851 美元,比上年增加 20.3%。核定预算用于执行中期战略下的一系列活动,以及评价基金的项目和托管人的业务。

#### G. 执行实体的认证

- 15. 认证小组在报告所述期间举行了两次会议。董事会选举 Patience Damptey (加纳,非洲国家)为主席, Kevin Adams (美国,附件一缔约方)为副主席。认证小组由这两名董事会成员和四名独立专家组成。
- 16. 董事会审议了认证小组的建议,重新认证了两个国家执行实体(亚美尼亚环境项目执行股;巴拿马自然基金会),一个区域执行实体(加勒比开发银行)和两个多边执行实体(亚洲开发银行和国际复兴开发银行)。董事会决定将两个国家执行

实体从经认证的实体名单中删除。在报告期结束时,共有 32 个国家执行实体、9 个区域执行实体和 14 个多边执行实体,其中有 10 个国家执行实体位于最不发达国家,7 个国家执行实体位于小岛屿发展中国家。截至 2023 年 6 月 30 日,还有来自最不发达国家的 19 个国家执行实体和来自小岛屿发展中国家的 7 个国家在申请认证。到 2023 年 6 月 30 日为止,在 55 个经认证的执行实体中,有 36 个(19 个国家执行实体、6 个区域执行实体和 11 个多边执行实体)已获重新认证。经认证的执行实体名单载于附件三。

#### H. 适应基金董事会各委员会

- 17. 在本报告所述期间,道德操守和财务委员会(EFC)以及项目和方案审查委员会(PPRC)在董事会第 39 次和第 40 次会议期间举行了两次会议。在第 40 次会议上,Mattias Broman (瑞典,西欧和其他国家)当选为 EFC 临时副主席,Sylviane Bilgischer (比利时,西欧和其他国家)当选为 PPRC 主席。
- 18. EFC 审议了下述事项并向董事会提出相应建议:适应基金 2022 财年的年度业绩报告;对适应基金进行全面评价的方法;董事会、秘书处、评价职能及托管人 2024 财年工作计划和行政预算;评价咨商小组主席的报告,包括为实施适应基金新评估政策提供指导的报告、关于管理层对评价咨商小组对适应基金创新经验进行专题评估的主要结果的回应的信息,以及关于为应对 COVID-19 疫情所采取临时措施的信息。
- 19. 在本报告期结束时,PPRC 审查了 45 份单一国家项目构想和 21 份完整的单一国家项目提案,包含 66 个独立的项目提案;涉及区域(多国)项目和方案的 5 份前期构想、4 份构想和 8 份完整的项目文件,包含 17 个独立的项目和方案提案;3 个关于创新的小额赠款提案;和 1 个学习赠款提案。
- 20. 鉴于向董事会提交的提案数量不断增加,为进一步强化和加快建议书提交程序,董事会决定允许执行实体在滚动基础上提交所有供资窗口下的项目或方案提案。<sup>20</sup>

#### I. 关于适应项目和方案的供资决定

- 21. 在报告期内举行的会议上,董事会批准了8项单一国家提案的供资申请,总额6,147万美元;5项区域(多国)提案的供资申请,总额5,818万美元(见附件七)。已批准或建议批准供资的单一国家提案涉及不丹、哥斯达黎加、科特迪瓦、蒙古、瑙鲁、巴布亚新几内亚、斯里兰卡和乌干达。已批准或建议批准在区域项目和方案供资窗口下供资的区域提案涉及以下国家:伯利兹、危地马拉和洪都拉斯;佛得角、几内亚比绍和圣多美和普林西比;柬埔寨、老挝人民民主共和国、泰国和越南;萨尔瓦多和洪都拉斯;印度和斯里兰卡。
- 22. 在报告期内举行的会议上,董事会核可了 22 项单一国家项目构想,总额 1.2918 亿美元,涉及下述国家:柬埔寨、乍得、科特迪瓦、斐济(2 个项目构想)、格鲁吉亚、格林纳达、几内亚、印度尼西亚(6 个项目构想)、老挝人民民主

20 董事会 B.40/59 号决定。

共和国、毛里塔尼亚、蒙古、尼日尔、秘鲁(2 个项目构想),图瓦卢和赞比亚;董事会还为国家执行实体提交的项目批准了项目编制款,总额为199,000美元。

- 23. 在区域项目和方案供资窗口中,董事会核可了 2 个项目构想,总额为 2,462 万美元,涉及以下国家的区域项目: 贝宁和多哥; 以及喀麦隆、中非共和国、乍得、尼日尔和尼日利亚。此外,董事会还核可了两个前期构想,总额 2,609 万美元,涉及以下国家的区域项目: 孟加拉国和尼泊尔; 以及萨尔瓦多、危地马拉和洪都拉斯。董事会还为已核可的前期构想和构想批准了 200,000 美元的项目编制款。已批准的完整提案和核可的前期构想和构想涵盖农业、海岸带管理、灾害风险减少和预警系统、基于生态系统的适应办法、粮食安全、农村发展、城市发展和水管理部门(包括跨界水管理)以及多部门项目(见图 VII.1-VII.2)。
- 24. CMP 11 请董事会在向 CMP 提交的报告中提供关于适应基金运作管道(包括处于不同阶段项目)的进一步信息。<sup>21</sup> 所要求的信息载于附件八。
- 25. 对适应基金供资的需求继续增长。过去一年进入运作管道的已提交但未获批准的项目和方案提案总额为 3.7855 亿美元,比前一年增加了 14%(见表 VIII.3)。
- 26. 应民间社会和非政府组织观察员的建议和要求,所有项目和方案提案均原文 张贴在适应基金网站上,感兴趣的利害关系方可以电子方式发表意见。通过秘书 处提交给董事会的对提案的评论意见<sup>22</sup> 张贴在网站上,并由 PPRC 审议。

#### J. 对项目组合的监测

- 27. 在报告所述期间,执行中的项目有89个,其中5个开始执行,5个已经完成(适应基金组合状况见附件 VIII)。到本报告期结束时,共向自适应基金运行以来批准的156个项目支付了6.6496亿美元,其中包括报告期内拨付的9606万美元。非洲是迄今获批赠款资金最多的地区,有55个项目,赠款额4.2470亿美元(40.2%);其次是亚太地区,有58个项目,赠款额3.2860亿美元(31.1%);拉丁美洲和加勒比,有35个项目,赠款额2.7180亿美元(25.7%);东欧,有7个项目,批准供资3,010万美元(2.8%)。在全球范围内运作的方案有两个,总额1000万美元,即由开发署和环境署运营的多边执行实体创新汇总方案。
- 28. 按部门划分,拨给粮食安全项目的赠款额最大,批准额为 2.002 亿美元 (19.0%),之后依次是农业,1.388 亿美元(13.2%);多部门项目,1.257 亿美元 (11.9%);减少灾害风险和预警系统,1.255 亿美元(11.9%);水管理,1.156 亿美元(11.0%)(见图 VII.3)。上述数据载于适应基金从 2022 年 7 月 1 日至 2023 年 6 月 30 日的第十三次年度业绩报告,董事会第 41 次会议将审议该报告。
- 29. 赠款额细目按适应基金层面的结果分列,可在适应基金战略成果框架下跟踪。最大一笔赠款供资额用于框架下的结果 4— "提高相关发展部门服务和基础设施资产的适应能力"(2.405 亿美元,占 28.9%);之后依次是结果 6— "实现目标地区弱势群体的生计和收入来源多样化并予以加强"(1.654 亿美元,占

19.9%)以及结果 5——"提高生态系统对气候变化和多变性所致压力的韧性" (1.649 亿美元,占 19.8%)。

#### K. 中期战略(2023-2027年)

30. 在本报告所述期间,完成了 2018-2022 年第一个中期战略。中期战略以多种方式提高了基金的雄心和影响力,包括设立了七个新的供资窗口,以加快适应行动、创新以及学习和分享,并提高其质量。基金的评价职能得出结论认为,第一个中期战略是一个良好、切合目的的战略,目标远大、具有前瞻性,能够应对适应气候变化的全球进程和当务之急。在中期战略下启动了七个新的供资窗口,以加快适应行动、创新以及学习和分享并提高其质量。

31. 董事会第 39 次会议上通过了 2023-2027 年第二个中期战略。<sup>23</sup> 这个中期战略 以基金的成就为基础,并借鉴了董事会执行第一个中期战略的经验,旨在进一步 巩固基金的相对优势,优化其影响。重点仍然是为适应行动、创新、学习和分享 提供资金,同时促进提高每一项战略支柱的力度,加强它们之间的联系和协同作用。此外,新的中期战略在战略上强调以地方为基础和地方主导的适应活动,将 其作为一个跨领域主题,并强调扩大受资助的活动和推广其成果。<sup>24</sup>

32. 适应基金的使命是通过加速有效的适应行动和有效的融资渠道,包括通过直接融资模式,响应发展中国家的紧迫需求和优先事项,为《巴黎协定》服务。适应基金支持国家驱动的适应项目和方案、创新和学习,以及在地方一级取得可以扩大的具体成果。基金的所有活动都旨在促进以地方为基础或由地方主导的行动,增加获得气候资金的机会,建设长期的体制能力,增强最弱势人民和社会群体参与的权能并使其受益,促进性别平等,鼓励和促进扩大和复制成果,加强与其他适应供资方和行为方的互补性、一致性和协同作用。

33. 为了促进 2023-2027 年中期战略的实施,董事会第 40 次会议批准了实施计划。 $^{25}$ 

#### 1. 地方主导适应行动和强化直接获取资金

34. 在中期战略的行动支柱下,适应基金为以地方为基础和由地方主导的具体适应项目提供资金。此外,适应基金通过一个强化直接获取资金的窗口,为地方主导的适应行动提供专门支持,从而能够将决策权下放到地方一级。在本报告所述期间,董事会审议了四项提案,批准了一项关于强化直接获取资金的提案(针对卢旺达),并核可了一项强化直接获取资金构想提案(针对秘鲁)。26董事会还与卢旺达环境部合作,为国家执行实体举办了第二次关于强化直接获取资金的培训研讨会。研讨会于2023年5月9日至11日在基加利举行,为国家执行实体提供了就成功的项目设计和地方主导适应行动可能模式交流知识的机会。

#### 2. 创新

- 35. 在适应基金创新融资机制下,董事会批准了关于执行实体对完整项目或方案 提案应用创新指标的指导意见。<sup>27</sup>
- 36. 在大额创新赠款供资窗口下,董事会第 39 次和第 40 次会议审议了 9 个大型创新项目提案,批准了一个单一国家项目(越南),核可了两个单一国家项目构想(伯利兹和不丹),核可了两个区域构想(一个针对肯尼亚和乌干达,一个针对冈比亚和坦桑尼亚联合共和国)。
- 37. 董事会在第 39 和第 40 次会议上审议了 8 项小额创新赠款提案,并批准为印度尼西亚的两个项目提供 50 万美元的小额赠款。<sup>28</sup>
- 38. COP 25 推出了适应基金气候创新加速器,作为专用融资机会,支持尚未建立国家执行实体的发展中国家以及私营部门和民间社会进行适应创新,目前加速器的运营已经进入中期阶段。在本报告所述期间,在开发署发出的第一次提案征集呼吁中,19 个国家的 22 个受赠方获得了资金。根据 2022 年 9 月至 10 月开放的第二次提案征集呼吁,开发署的目标是在 2023 年至 2024 年之间为 1.5 年的项目周期发放 20-25 笔新赠款。在加速器的环境署一气候技术中心和网络分支机构下,从前两次提案征集中选出了 12 个项目,目前正在实施之中。另外 13 个项目将通过环境署一气候技术中心和网络发布的第三次(最终)提案征集活动选出,征集活动于 2022 年 9 月 30 日结束。
- 39. 在 2023-2027 年中期战略的创新支柱下,适应基金的工作建立并扩大了在上一个中期战略下开展的工作,包括实施适应基金气候创新加速器。多边执行实体和区域执行实体应邀提交了加入加速器伙伴关系的意向书。在审查了这些意向书之后,董事会在第 40 会议上决定请五个执行实体各自编写一份方案提案,供董事会第 41 次会议审议。<sup>29</sup>

#### 3. 学习和分享

- 40. 《巴黎协定》对适应学习和分享给予了前所未有的重视,特别是发展中国家缔约方开展和参与的适应学习和分享。<sup>30</sup>在报告所述期间,在第一个中期战略的学习和分享支柱下实施了一些相关活动,第二个中期战略将对该支柱进行扩展:
- (a) 为对直接获取资金模式感兴趣的国家执行实体免费提供英文、法文和 西班牙文的强化直接获取资金窗口虚拟培训课程;
- (b) 正在开发一个关于减少灾害风险和预警系统的知识产品,概述在适应基金项目组合方面吸取的经验教训(在报告所述期间结束时接近完成);

- (c) 正在开发一个知识产品,概述适应基金在处理气候变化适应问题和加强脆弱国家和受冲突影响国家的长期复原力方面的经验教训(在报告期结束时接近完成);
- (d) 发布了一个知识产品,概述了从国家开发银行和信托基金的认证中吸取的经验教训,以及这些实体在为气候适应行动提供资金方面可发挥的作用;
- (e) 作为 Kemitraan (印度尼西亚)主办的国家交流活动的一部分,举办了一次关于基于生态系统的适应办法的知识博览会,与会的国家执行实体分享了实施该领域适应基金资助项目中的经验教训和挑战;
  - (f) 审议并批准了一项为秘鲁提供 15 万美元学习赠款提案。

#### 4. 气候资金准备方案

- 41. 气候资金准备方案为发展中国家提供支持,是适应基金在第一个中期战略的四个跨领域主题下取得成果的一个重要手段,特别是在加强长期机构和技术能力以实现有效适应这一主题下。本报告所述期间,在该方案下举行了以下活动:
- (a) 董事会批准了三项支持认证的准备工作一揽子赠款提案,并通过向所有经认证的执行实体提供准备工作一揽子赠款,扩大了中介机构在为国家执行实体认证提供支持方面的作用;<sup>31</sup>
- (b) 于 2022 年 9 月 26 日至 30 日在华盛顿特区为经认证的国家执行实体举办了年度气候资金准备研讨会。此次研讨会有 29 个经认证的国家执行实体和总共近 60 名与会者出席。与会者讨论了中期战略下的供资窗口,包括用于为项目扩大、创新、学习和强化直接获取资金的窗口;执行实体关于遵守适应基金性别政策的最新指导文件;提案制定;重新认证;直接获取资金实体实践社区(实践社区);以及 2023-2027 年中期战略;
- (c) 为执行实践社区的行动计划持续提供支持,这是一项由适应基金经认证的国家执行实体和绿色气候基金直接获取实体推动的举措。董事会通过其秘书处参加了2022年11月2日至4日在开罗举行的CPDAE年会;
- (d) 于 2022 年 12 月 7 日举行了一个全球认证培训虚拟工作坊,以加强对如何完成 AF 认证流程的了解。活动中,与会者讨论了执行实体应达到的认证标准和信托风险管理标准,以及认证方面的差距和挑战;
- (e) 第 14 次及第 15 次气候资金准备情况网络研讨会分别于 2022 年 12 月 8 日及 2023 年 4 月 24 日举行。网络研讨会的目的是为经认证的国家执行实体建设能力,使它们能够分享在强化直接获取资金和适应项目设计创新(第 14 次网络研讨会)以及在适应项目开发方面的气候变化依据(第 15 次网络研讨会)方面的经验教训:
- (f) 2023 年 5 月 24 日举行了一次关于性别问题的网络研讨会,与会者讨论了促进性别平等的项目和方案设计以及在适应基金项目周期内报告执行情况;
- (g) 2023 年 6 月 5 日至 9 日,与 Kemitraan (印度尼西亚的国家执行实体)合作在印度尼西亚举行了国家交流活动。国家交流力求通过南南知识交流和同行学

习,加强经认证的国家执行实体在基于生态系统的适应办法领域的项目设计、开 发和执行能力。

#### 5. 性别平等与增强妇女和女童权能

- 42. 促进两性平等和增强妇女和女童权能是第一个中期战略的四个跨领域主题之一,因此指导着所有适应基金活动和业务的设计。
- 43. 关于董事会组成中的性别平衡问题,到 2023 年 6 月 30 日,在 32 个席位中有 8 个由女性担任,占 25%(32 个席位中有 6 个空缺)。
- 44. 董事会在执行经更新的适应基金性别政策和性别行动计划方面取得了进展,包括为此加强努力,提高适应基金伙伴特别是执行实体的机构能力,将促进两性平等的办法纳入项目生命周期的所有阶段,并改进对项目和方案中与两性平等有关的进展的监测和报告。
- 45. 在本报告所述期间,举办了以下与性别有关的培训活动:
- (a) 在面向国家执行实体的年度气候资金准备工作研讨会期间举行一次会议(2022年9月);
- (b) 为执行实体举办了关于更新的适应基金性别政策和执行实体关于遵守适应基金性别政策的更新指导文件的网络研讨会,为与会者提供了一个机会,分享在进行性别评估、建立按性别分列的指标、设计促进性别平等的干预措施以及为项目和方案制定性别行动计划方面的最佳做法和挑战(2022年10月);
- (c) 为国家执行实体举办了一次网络研讨会,介绍与性别平等主流化有关的现有财政和技术支持,研讨会为与会者提供了一个机会来分享在项目中采用促进性别平等的方法方面的经验教训、最佳做法和挑战(2023年5月);
- (d) 在为国家执行实体举行的强化直接获取资金研讨会上(见上文第34段)举行了一次会议,讨论如何将性别平等考虑纳入强化直接获取资金提案的设计,如何编制和实施促进性别平等的预算编制,以及如何使用项目业绩报告模板报告项目中的性别平等进展情况(2023年6月)。
- 46. 在本报告所述期间,适用适应基金性别均衡记分卡的试点阶段开启。制定记分卡的目的是,通过便利数据和信息的收集和分析,加强基金对整个项目和方案组合中性别政策执行情况的监测。各项目将分两个阶段应用性别均衡记分卡: (1) 在开始阶段和(2) 在执行和结束阶段,性别均衡记分卡的结果将列入适应基金
- (1) 在开始阶段和(2) 在执行和结束阶段。性别均衡记分卡的结果将列入适应基金的年度业绩报告。
- 47. 继续努力改进适应基金促进性别平等的业务框架,包括政策和业务准则。在 这方面,更新的适应基金性别政策<sup>32</sup> 和执行实体关于遵守适应基金性别政策的更 新指导文件<sup>33</sup> 已翻译成法文和西班牙文。

- 48. 适应基金 2022 财政年度的年度业绩报告<sup>34</sup>提供了关于 2022 财政年度中批准的一些项目中关于性别问题意识和响应的干预措施的信息(报告所述期间批准的适应基金项目中的此类干预措施的例子见附件五)。
- 49. 继续与其他气候基金等伙伴组织和《气候公约》秘书处在性别考虑问题上开展合作。董事会副主席参加了在附属机构第五十八届会议期间举行的《气候公约》各组成机构主席之间关于将性别视角纳入组成机构进程进展情况的任务规定会期对话,就将性别考虑纳入适应基金工作交流了经验、成就、关键的促进因素以及与其他组织的合作。

#### 6. 与民间社会的对话

- 50. 民间社会组织积极参与适应基金的工作,在董事会会议期间与董事会定期对话,就项目提案和其他董事会文件进行磋商,并就项目设计和执行进行磋商。中期战略申明,民间社会以各种方式为适应基金做出贡献,包括资源调动、就基金支持的项目提供实时更新和评估、收集目标受益者的意见。
- 51. 自董事会第 12 次会议以来,董事会和民间社会组织之间一直开展定期对话,作为常设议程的一项内容,为董事会就议程上的议题听取建议和接收反馈以及交流意见提供了一个机会。
- 52. 董事会根据适应基金民间社会网络提出的建议考虑了加强民间社会参与和介入适应基金工作的各种方案。董事会讨论了适应基金关于加强民间社会参与的愿景和准则草案,并决定根据讨论情况更新该文件。此外,董事会还决定参照其他气候基金的做法,编写关于确立"当选的积极民间社会观察员"地位的准则草案。35

#### L. 应对 2019 冠状病毒病大流行

- 53. 作为确保适应基金运营连续性和资金获取努力的一部分,董事会继续执行 2020 年通过的疫情对策,作为支持各国和执行实体减轻疫情影响并最大限度地减少适应基金项目组合遭受相关干扰的一套措施。36事实证明,这些措施有效地 为各执行实体和国家提供了额外的灵活性,以继续实施项目和方案,包括:
- (a) 为因疫情而被推迟但计划在未来 24 个月内完成的项目和方案一律免费延长完成日期,最多延长 12 个月;
- (b) 允许灵活适用"重大变更",允许项目预算重新分配,最高可达项目总预算的20%,以支付疫情相关费用;
- (c) 鼓励各国将与疫情有关的事项纳入未来适应基金方案规划,以实现更 广泛的复原力目标;
- (d) 尽可能为执行实体虚拟实施某些项目活动提供灵活性,包括启动会议、监督活动和利害关系方磋商。

- 54. 自疫情开始以来,董事会秘书处已收到并滚动批准了 31 项不增加费用而延 长项目完成日期的请求。
- 55. 考虑到疫情状况及多个区域均取消 COVID-19 限制的趋势,适应基金及其执行实体在报告期间恢复了面对面和实地活动,包括举行董事会及委员会的实体会议,以及进行项目监督及利益相关者咨询。
- 56. 此外,董事会重新审视了整体疫情应对措施,并决定对一系列临时措施和灵活性作出以下调整: <sup>37</sup>
- (a) 规定每个项目最多只能提出两项不增加费用而延长因疫情而推迟项目 完成日期的请求,条件是此类请求符合规定的标准; 38
  - (b) 停止灵活适用与疫情有关的"重大变更"; 39
- (c) 再次鼓励各国在今后制定适应基金供资方案时,在适应基金的任务范围内考虑与疫情有关的事项,以便在今后的方案制定中酌情反映政府恢复计划的目标,从而实现更广泛的复原力:
- (d) 恢复面对面进行的项目组合监测任务。在本报告所述期间,对西非(贝宁、科特迪瓦和加纳)(2022年11月21日至12月2日)、亚美尼亚(2023年4月3日至7日)和印度尼西亚(2023年6月5日至16日)的受资助项目进行了三次访问。

#### M. 对适应基金的评价

57. 报告所述期间是评价咨商小组开展工作的第四个年头。

#### 1. 执行适应基金技术评价咨商小组的战略和工作方案

- 58. 评价咨商小组在四项工作要点上取得了进展:
- (a) 新的评价政策将于 2023 年 10 月生效,取代 2011 年批准并于 2012 年修订的评价框架。为支持适应基金利益相关方实施新政策,评价咨商小组制定了评估指导文件草案, EFC 第 31 次会议对文件草案进行了审议,随后适应基金理事会第 40 次会议注意到了该草案。40 正在让利益相关方熟悉该政策和指导文件。
- (b) 评价咨商小组的多年期战略和工作方案规定对适应基金进行全面评价。董事会审查了评价咨商小组提出的拟议方法,并决定采取分阶段的方法,<sup>41</sup>紧急进行快速评估,并在稍晚的阶段进行全面评估,以期为预期的第三个中期战略(2028-2032)的制定作出贡献。
- (c) 评价咨商小组启动了对阿根廷新增的两个项目的适应基金项目事后评价的第三阶段: "在布宜诺斯艾利斯省西南部提高气候复原力和加强可持续土地管理"(国际复兴开发银行,2015-2019年)和"在阿根廷东北部增强小型农业生产

者的适应能力和复原力"(阿根廷农村改革部,2013-2018年)。评价工作预期在2023年10月前完成。

- (d) 关于三个专题评价,在董事会第 39 次会议上介绍了关于创新的最终评价报告。在本报告所述期间,继续开展关于项目可扩展性以及核证和准备情况的工作。
- 59. 为了为制定新的评价咨商小组多年期工作方案提供信息,小组与利益相关方开展了一系列磋商。

#### 2. 适应基金技术评价咨商小组的预算

60. 董事会批准了 1,615,642 美元的拟议预算,用于支付评价咨商小组及其秘书 处 2024 财政年度的业务费用。<sup>42</sup>

#### N. 参加会议和活动情况

61. 除董事会会议、认证小组会议以及董事会及其秘书处组织的准备工作相关活动外,还举办了其他虚拟活动,展示适应基金的故事,并履行适应基金的任务,如对塞舌尔的项目现场开展了一次虚拟实地访问。此外,董事会及其秘书处和评价咨商小组参加了附件四所列的会议和活动。

#### O. 传播

62. 董事会继续有效实施其传播战略,就适应基金工作和不断增长的供资机会制作和在各种传播平台上传播有趣易懂的内容和信息。与适应基金利益相关方,包括秘书处、执行实体、实施实体和民间社会组织合作发布的有针对性的宣传材料和项目故事,展示了受益者的声音、创新实例、成功故事和与适应基金项目组合有关的经验教训。关于执行传播战略和开展外联活动的详细情况载于附件六。

# 四. 为适应基金董事会执行任务提供的支持

63. CMP 5 鼓励附件一缔约方和国际组织在清洁发展机制项目活动收益分成以外向适应基金提供额外资金。<sup>43</sup> CMP 7 继续鼓励附件一缔约方和国际组织提供资金。<sup>44</sup> CMA 3 确认适应资金必须充足和可预测,包括确认适应基金在为适应行动提供专门支持方面的价值,并请发达国家缔约方考虑多年期认捐;<sup>45</sup> CMA 4 认识到适应基金在气候资金架构中的核心作用,欢迎在当届会议上作出的新认捐,促请所有捐助方及时兑现认捐,并邀请捐助方确保基金资源的可持续性。<sup>46</sup>

- 64. 董事会在第 39 次会议上批准了 2022-2025 年适应基金总体资源调动战略和行动计划。<sup>47</sup>在报告所述期间,董事会根据资源调动战略调动资源并获得支持以执行任务。
- 65. 适应基金年度高级别捐助方对话在 COP 27 期间举行,由 COP 27 主席主持。 支持适应基金的 22 个捐助方和受援方国家和次国家政府代表参加了这次成功的 对话。18 个捐助者集体认捐了 2.43 亿美元,其中 5 个是首次认捐,6 个是多年认捐的分期付款。48
- 66. 董事会在政府资金来源以外的捐款方面采取了进一步行动,这些来源包括基金会、慈善组织、非营利组织、私人和私营部门企业。这些来源还包括通过2012年建立的联合国基金会在线捐赠链接渠道提供的捐款。49董事会定期推动为私营部门和个人向适应基金信托基金捐款提供机会。
- 67. 为了满足日益增长的资源需求,适应基金理事会在第 40 次会议上批准了 2023 年 3 亿美元的新资源筹集目标,该目标将来自比前一年更多的捐助者。50
- 68. 董事会正在采取步骤,积极向已有和潜在的捐助方宣传为执行董事会任务提供支持的机会,包括将与 COP 28 同期举行的 2023 年捐助方对话。董事会通过其秘书处和受托人,一直积极与《气候公约》秘书处和其他相关利益相关方合作,及时制定第六条第四款减排单位货币化战略。

# 五. 适应基金和《巴黎协定》

- 69. 自 2019 年 1 月 1 日起,适应基金就与《巴黎协定》有关的所有事项,开始为《巴黎协定》服务,接受 CMA 的指导并对 CMA 负责,<sup>51</sup> 在《巴黎协定》第六条第四款下的收益分成到位后,将只为《巴黎协定》服务。<sup>52</sup> CMP 14 和 CMA 1 决定,适应基金将继续从《京都议定书》第六、第十二和第十七条下的活动中收取收益分成(如有的话),并由《巴黎协定》第六条第四款所设机制的收益分成以及各种自愿的公共和私人来源提供资金。<sup>53</sup>
- 70. 董事会履行了第 3/CMP.16 号和第 13/CMA.3 号决定规定的任务,在第 39 次会议上批准了对适应基金业务政策和准则以及对战略优先事项、政策和准则的修正,并建议 CMP 17 审议对战略优先事项、政策和准则的修正并采取其认为适当的行动。54 CMP 17 赞赏地注意到董事会在通过经修正的业务政策和准则方面所

做的工作,并通过了经修正的战略优先事项、政策和准则,<sup>55</sup> CMA 4 赞赏地注意 到董事会在通过经修正的业务政策和准则方面所做的工作,并欢迎经修正的战略 优先事项、政策和准则。<sup>56</sup>

- 71. 关于董事会成员资格,CMA 4 要求 SBI 58 根据需要继续审议与董事会成员组成有关的事项,因为适应基金将过渡到专门为《巴黎协定》服务。<sup>57</sup> CMA 4 鼓励董事会继续审议围绕为《巴黎协定》服务方面的议事规则,包括在履行机构完成对董事会成员资格相关事项的审议之后。<sup>58</sup> 按照主席的提议,履行机构第五十八届会议将这一事项推迟到履行机构第五十九届会议审议。<sup>59</sup>
- 72. CMP 17 请董事会通过一项防止性剥削、性虐待和性骚扰的政策, CMA 4 也请董事会这么做。<sup>60</sup> 作为回应,董事会请其秘书处编写一份文件,列出防止性剥削、性虐待和性骚扰政策的备选方案,并提交董事会第 41 次会议审议。<sup>61</sup>
- 73. CMP 17 请董事会视需要审查和更新适应基金的环境和社会政策。62 作为回应,董事会请其秘书处委托对环境和社会政策进行一次独立审查,以更新该政策;必要时,与适应基金相关利益相关方协商,准备更新政策的提案;并将产出提交理事会第 41 次会议审议。63
- 74. CMA 4 决定,董事会及其支助架构应制定并实施一项将适应基金在"第六条第四款机制"登记册内持有的用于适应的收益分成账户中的"第六条第四款减排单位"货币化的战略,并每年向 CMA 通报货币化情况。64 对此,董事会请秘书处和受托人继续与《气候公约》秘书处和任何其他相关利益相关方磋商,以期及时制定一项关于第六条第四款减排单位货币化的战略,并向董事会第 41 次会议报告这项工作的情况。65
- 75. 关于适应基金从《京都议定书》转向为《巴黎协定》服务的安排, <sup>66</sup>董事会请其秘书处继续与《气候公约》秘书处、受托人和任何其他相关利益相关方磋商,以便及时准备这些安排,并向董事会第41次会议报告这项工作的情况。<sup>67</sup>

- 76. CMP 17 请理事会在提交 CMP 18 的年度报告中纳入列入关于适应基金资助的项目和方案的实际结果汇总信息,特别是适应基金的五个核心指标,同时对成功、挑战和经验教训进行质化分析。<sup>68</sup>
- 77. CMP 17 和 CMA 4 就若干事项向董事会提供了指导意见。本报告附件九载有董事会对这一指导意见的答复。

## 六. 适应基金与《公约》之下其他机构之间的业务联系和关系

- 78. 董事会采取行动,促进与《公约》下其他机构的联系,如适应委员会、气候技术中心和网络、绿色气候基金、全球环境基金、巴黎能力建设委员会、资金问题常设委员会和技术执行委员会。<sup>69</sup>
- 79. 适应基金和其他多边气候基金(绿色气候基金、全球环境基金和气候投资基金)的代表参加了 2022 年 11 月 15 日在 COP 27 会议间隙举行的第六次气候交付渠道年度对话。各气候基金负责人评估了联合基金路线图及其工作计划(2022-2023年)的执行进展情况,找出了其中的差距和加强合作的方式,以进一步促进各基金之间的互补性和一致性。
- 80. 在对话中,各气候基金负责人同意深化以下合作领域和时间表:
- (a) 研究衡量受资助活动影响的指标,包括经济影响,并侧重于由气候投资基金牵头的基金实地工作的影响(在2023年12月前委托进行一项研究);
- (b) 探讨由适应基金牵头的联合融资方案的备选方案(在 2023 年 12 月前委托进行一项研究);
- (c) 推进落实已确定的各基金在知识管理和能力建设方面开展合作的备选办法(在 COP 28 之前更新);
- (d) 继续开展联合传播和外联工作,包括探讨为 COP 28 开展联合宣传的备选办法。
- 81. 根据基金联合路线图,与适应基金-绿色气候基金互补性和一致性有关的若干倡议取得了进展,包括扩大项目和方案规模的联合框架;向实践社区联合提供支助;适应基金和绿色气候基金在执行实体认证和再认证方面的互补性。
- 82. 根据适应基金-绿色气候基金扩大项目和方案框架试点阶段的经验教训,两个基金同意将这一办法扩大到其整个项目组合。适应基金确定了符合框架所列标准、因而可能有资格扩大规模的项目,并与绿色气候基金分享了这些项目。绿色气候基金就利用绿色气候基金资源扩大适应基金项目或方案的问题与其指定国家主管部门进行了联系,三分之二的国家表示有兴趣这样做。通过这一框架,四个国家(伯利兹、柬埔寨、厄瓜多尔和南非)关于实施扩大项目规模的讨论已进入高级阶段。
- 83. 在整个报告所述期间,适应基金和绿色气候基金继续共同支持实践社区。在 2023 年 1 月绿色气候基金批准面向实践社区的资金后,后者开始实施其行动计

- 划,德国国际合作机构为请其交付伙伴。正在制定的主要交付成果是一个项目优先排序工具、一份专家名册和六份文件,重点是分享实践社区成员在各种专题上的经验教训。
- 84. 董事会秘书处作为观察员参加了绿色气候基金董事会分别于 2023 年 3 月 13 日至 16 日、2023 年 7 月 10 日至 13 日在大韩民国仁川松岛举行的第 35 和 36 次会议。
- 85. 董事会秘书处设在全球环境基金秘书处,全球环境基金秘书处促进信息和知识交流,并在需要时提供组织间支持。董事会秘书处于 2023 年 3 月参加了全球环境基金介绍研讨会,并在会上与全球环境基金利益相关方分享了关于获得适应基金资金和新的中期战略的信息,其中许多利益相关方也是其他气候基金的利益相关方。
- 86. 应《气候公约》秘书处关于支持过渡委员会的请求,董事会借调了两名工作人员到《气候公约》秘书处领导的过渡支助股兼职工作。董事会秘书处的代表参加了过渡委员会第一次和第二次会议(分别为 2023 年 3 月 27 日至 29 日和 2023 年 5 月 25 日至 27 日)以及关于结合第 2/CP.27 和 2/CMA.4 号决定处理损失和损害问题的第一次研讨会(2023 年 4 月 29 日至 30 日),他们介绍了适应基金在避免和尽量减少气候变化影响相关损失和损害方面工作的经验,适应基金关于减少灾害风险和预警系统的项目,适应基金之下有可能作为应对损失和损害的新供资安排及第 2/CP.27 号决定和第 2/CMA.4 号决定第 3 段所设基金备选办法的体制安排。
- 87. 董事会是国家适应计划联合国行动的一个伙伴组织,这是一项由《气候公约》秘书处协调的倡议,目的是响应任何正在制定或执行国家适应计划的国家提出的技术援助请求。董事会通过秘书处对各国提出的若干请求作出了回应,并在国家适应计划联合国行动会议上介绍了适应基金对国家适应计划执行工作的支持。
- 88. 董事会通过其秘书处,与技术执行委员会和气候技术中心和网络合作,根据技术执行委员会 2023-2026 年滚动工作计划,进一步开展创新合作。董事会秘书处首次参加了气候技术中心和网络咨询委员会会议(2023年3月27日至29日举行的第21次会议)。

#### Annex V

# Examples of gender-sensitive and -responsive interventions in Adaptation Fund projects approved during the reporting period

[English only]

- 1. Efforts to proactively address gender equality and women's empowerment in adaptation action have continued by ensuring that AF-funded projects and programmes include gender-responsive measures for effective, sustainable and equitable outcomes of adaptation action.
- 2. Gender-sensitive and -responsive interventions in four AF projects or programmes approved during the reporting period, extracted from their gender assessments and project-specific gender action plans, include:
- (a) To acknowledge and respond to gender-differentiated climate risks, the projects have identified women's specific concerns and experiences and focused on sectors with a significant impact for women such as access to water and sanitation (appropriate sanitation facilities),<sup>2</sup> disaster management (through early-warning systems),<sup>3</sup> income generation (through women's entrepreneurship), and access to land (through awareness raising)<sup>4</sup>;
- (b) To increase women's participation and agency, the projects have set specific targets to ensure distribution of benefits among vulnerable groups, such as women, indigenous people and youth, in relation to promoting skills development and trainings to enhance their technical capacities and resilience to adapt to climate change (ranging from sustainable land management<sup>5</sup> and agroecology<sup>6</sup> to business development),<sup>7</sup> as well as accessing financial services to diversify their livelihoods<sup>8</sup>;
- (c) To promote innovation and sustainability, the projects have implemented interventions aimed at ensuring learning and knowledge for younger generations of women and challenging social norms. For example, in addition to peer-learning and focused trainings, an initiative called "Youth Learning Routes" will be implemented in order to provide young female farmers with skills and peer exchange networks for sustainable agroecology, as will a participatory tool for training communities and challenge social norms called "Gender Learning and Promotion Framework for Sustainable Development" 10;
- (d) To ensure gender mainstreaming throughout the project cycle, the projects have ensured institutional support from gender teams, as well as grievance mechanisms, appointments of gender focal points and operational guidance and awareness trainings for project staff.<sup>11</sup>

#### **Annex VI**

#### **Communications**

- 1. The AFB, with support of its secretariat, continued its effective strategy of producing and disseminating engaging content in targeted news streams to highlight AF work and project voices on the ground, growing demand for projects and adaptation finance needs, and expanding AF funding windows and opportunities for countries, among other timely topics.
- 2. The AFB, supported by its secretariat, continued to be highly productive in its communication endeavours and to innovate by producing new avenues of communication, including showcasing projects on the ground, incorporating drone footage, producing an AF podcast series and emerging social media platforms and working closely with implementing partners and other stakeholders to showcase AF projects and programmes in action via videos and stories, including highlighting beneficiary voices on the ground and growing AF funding windows.
- 3. Key AF events and other outreach activities were showcased via social media, stories, photo albums, flyers and other platforms. These efforts helped to significantly grow the AF website audience as well as partnerships with key communications colleagues from other funds, IEs and executing entities, civil society organizations, the UNFCCC and other stakeholders operating in the climate space.
- 4. The AFB, through its secretariat, organized and coordinated AF representation at COP 27 through its full-scale AF pavilion, building on the success of the first-time pavilion from the previous year. Its branding and location were highly visible and served as a key point for meeting AF stakeholders and raising awareness of AF work, including the promotion of 15<sup>th</sup> anniversary of the AF and other events. It featured videos and information materials highlighting its projects in Egypt and linked to a catch-all COP 27 website of AF activities, which received a 57 per cent increase in views over its COP 26 website. It also received growing media attention, with 872 media mentions in the key period from October to March alone. This included increasingly prominent media interviews, including by CNBC-Africa, Radio France International, Devex and others.
- 5. The AFB, with support of its secretariat, produced nine press releases, eight project stories, including five in collaboration with media partner Climate Home News to extend their reach, and several videos, photo essays, e-newsletters, podcasts, flyers, brochures and blogs. Themes such as enhancing access to climate finance, exchanging project knowledge, locally led adaptation, enhanced direct access, project scale-up/replication, learning, disaster risk reduction/early warning systems, sustainable fishing practices, adaptation to floods/drought/food security, nature-based solutions, gender and youth, technology and innovation in adaptation were highlighted.
- 6. Project stories covered a wide range of countries, including direct access projects and projects in SIDS and the LDCs. Multimedia products included nine videos showcasing AF projects in action and thought leadership in adaptation across key trends and novel programs. Key messaging was developed and shared to maximize leadership interventions in outreach events. Several new brochures and social media cards were developed on timely themes and global days, and additional stories and videos shared from IE partners.
- 7. Through extensive media campaigns supported by the AFB secretariat, the AF was in the media spotlight consistently. Significant growth was seen across the diverse communication platforms of the AF and in mentions of the AF in the media.
- 8. The number of AF web page views rose by more than 33 per cent over the previous reporting period, reaching a record 1,018,964 for the fiscal year. With regard to social media channels, the AF reached 22,100 followers on X (formerly known as Twitter) thanks to an increase of 1,875 followers. Facebook reached 18,095 followers after adding 1,846 followers, and LinkedIn increased by 2,891 followers. The continued growth of and activities on its communication channels has in turn fed the growth of the AF by continuing to build its brand

and reaching a growing key audience with quality and diverse communication products highlighting its evolving work. Timely, steady news and visible communications contributed to a record 20 contributors, including five first-time donors and six multi-year pledges.






Project and programme pre-concepts and concepts endorsed by the Adaptation Fund

- "In assessing project and programme proposals, the Adaptation Fund Board shall give particular attention to: (a) Consistency with national sustainable development strategies and adaptation planning processes, including, where appropriate, national adaptation plans (NAPs), nationally determined contributions (NDCs), adaptation communications, national development plans, poverty reduction strategies, national communications and national adaptation programmes of action (NAPAs) and other voluntary adaptation reports and relevant instruments, where they exist" (strategic priorities, policies and guidelines, para. 17(a));

In line with the strategic priorities, policies and guidelines, all project and programme proposals approved by the AFB in the reporting period support country-driven adaptation projects and programmes in developing countries and have been screened for consistency with NAPs and other voluntary adaptation planning processes to support their implementation.

In line with its mandate, the AFB is a partner organization in the UN4NAPs initiative, coordinated by the UNFCCC secretariat for responding to requests for technical assistance from any country that is in the process of formulating or implementing its NAP. #### Paragraph 12

The AFB at its 40<sup>th</sup> meeting decided to request the secretariat to prepare a document with options for a policy on safeguarding against sexual exploitation and abuse and sexual harassment and present it to the Board for consideration at its 41<sup>st</sup> meeting (AFB decision B.40/80). The AFB will provide an update on this matter in its addendum to this document, which will be issued after its 41<sup>st</sup> meeting (October 2023).

# **Decision 5/CMP.17: Fourth review of the Adaptation Fund**

The AFB at its 39<sup>th</sup> meeting (October 2022) approved the overall resource mobilization strategy and action plan for the Fund for 2022 to 2025, which includes focus on leveraging a variety of potential contributors, including subnational, private sector and foundations. The AF was the first to mobilize resources from subnational governments and is the only multilateral climate fund that has procedures in place for receiving contributions from non-governmental sources. The strategy recognizes the opportunity to further build on this and to undertake outreach to a variety of potential additional contributors.

Also encourages the AFB to continue to enhance access to the Fund, including by:

- (a) Strengthening engagement with and support for building the institutional capacity of national implementing entities;

- (c) Further strengthening coherence and complementarity between the Adaptation Fund and other institutions funding adaptation projects and programmes, including the Green Climate Fund, in order to facilitate streamlining access modalities, as appropriate, including for accreditation, and scaling up Adaptation Fund projects;
- (d) Further improving geographical and thematic coverage in the accreditation of national and regional implementing entities;

The mission of the AF is to serve the Paris Agreement by accelerating adaptation action and enhancing access to finance. Under the new MTS, one of the cross-cutting strategic themes is "Enhancing access to climate finance and long-term institutional capacity", which guides all activities of the Fund.

As at 30 June 2023, the Trustee has disbursed USD 664.96 million to IEs in relation to projects and programmes funded by the Fund at a disbursement rate of over 62 per cent, which is significantly higher than most peers' rates. While the COVID-19 pandemic has slowed down the implementation of some projects owing to restrictions imposed by countries, the Fund has continued efforts to expedite project execution on the ground, including through AFB decisions B.35.b/16 and B.40/69, which provided for more flexibility in adaptive management. In the context of the new MTS and its implementation plan, the Fund will continue its dedicated support to countries and IEs so as to expedite project implementation, including through close monitoring of projects facing challenges, with ad hoc supervision missions if needed, further guidance through the readiness program as well as additional adaptive management in line with the Fund's operational policies and guidelines.

In terms of geographic coverage, the AFB secretariat has, as at March 2023, received nominations from the designated authorities of nine developing country Parties, of which five are from Africa, two from Asia-Pacific, two from Latin America and the Caribbean, six are LDCs and one a SIDS.

Requests the AFB to include in its annual report to CMP 18 and CMA 5 (November 2023) information on aggregated actual results of projects and programmes funded by the Adaptation Fund, in particular across the Fund's five core indicators, accompanied by qualitative analysis of successes, challenges and lessons learned;

A full report will be annexed to the addendum to this document, to be issued following the 41st meeting of the AFB.

The decision states that: "The Trustee shall prepare and furnish the Adaptation Fund Board with financial reports of the Trust Fund annually (or at any other such frequency agreed between the Trustee and the Adaptation Fund Board), and provide records and accounts of the Trust Fund for audit by its external auditors annually (or at any other such frequency agreed between the Trustee and the Adaptation Fund Board), in accordance with the policies and procedures of the Trustee. Furthermore, the Trustee shall prepare and furnish the Adaptation Fund Board with reports on the sale of the CERs for the Adaptation Fund and on the status of commitments and transfers of Trust Fund funds annually (or at any other such frequency agreed between the Trustee and the Adaptation Fund Board)."
- 3. The information contained in this Financial Report is based on financial information as of June 30, 2023.

# II. Adaptation Fund Trust Fund Summary as of June 30, 2022

#### Certified Emission Reduction (CER) Sales and Donations

- 4. Cumulative resources pledged to AF Trust Fund including CER sales proceeds amounted to USD 1,680.36 million as of June 30, 2023. USD 214.92 million was received through CER sales proceeds and USD 1,232.96 million in donations, totalling cumulative receipts of USD 1,447.88 million as of June 30, 2023. Resources not yet received from Donors amounted to USDeq. 232.47 million, comprising USDeq. 213.96 million in pledges and USDeq. 18.51 million in donations receivable under the signed agreements
- 5. An amount of USD 3.12 million was received from CER sales during fiscal year 2023.

### Investment Income

6. As of June 30, 2023, the AF Trust Fund earned investment income of USD 69.31 million on the liquid balances in the AF Trust Fund. The AF Trust Fund liquid portfolio has returned 3.86% for fiscal year 2023.

#### Funding Approvals

7. Cumulative net funding decisions made by the AF Board through June 30, 2023 totalled USD 1,155.48 million, of which USD 1,060.75 million represents approvals for projects and programs.

#### Cash Transfers

8. The Trustee has transferred a total of USD 746.70 million up to June 30, 2023, including USD 664.96 million related to programs, projects and fees.

#### Funds Held in Trust

9. Funds Held in Trust<sup>2</sup> reflect proceeds from CER monetization, donations received and investment income, less cash transfers made to date. Funds Held in Trust as of June 30, 2023 amounted to USD 767.49 million, excluding USD 3 million set aside for operational reserve.

## Funds available for AF Board funding decisions

10. Funds available to support AF funding decisions amounted to USD 358.72 million as of June 30, 2023, which is an increase of <u>USD 139.47 million</u> during fiscal year 2023.




## A. ASSET MIX

14. The undisbursed cash balance of the AF Trust Fund is maintained in a commingled investment portfolio ("Pool") for all trust funds managed by IBRD. Funds are managed such that the expected maximum loss, as measured by the CVaR, in the worst 1% of cases will not exceed 0.25% at the portfolio's investment horizon.






