

#### I. Opening of the session

(Agenda item 1)

1. CMP 15, convened pursuant to Article 13, paragraph 6, of the Kyoto Protocol, was held at IFEMA – Feria de Madrid in Madrid, Spain, from 2 to 15 December 2019. Carolina Schmidt (Chile), President of CMP 15, opened the session on Monday, 2 December.<sup>1</sup>

#### II. Organizational matters

(Agenda item 2)

#### A. Adoption of the agenda

(Agenda sub-item 2(a))

- 2. At its 1<sup>st</sup> meeting,<sup>2</sup> the CMP considered a note by the Executive Secretary containing the provisional agenda and annotations.<sup>3</sup> The provisional agenda was prepared in agreement with the President of CMP 14 after consultation with the Bureau of the CMP and taking into consideration the views expressed by members of the Bureau and by Parties at SBI 50.
- 3. On a proposal by the President of CMP 15, the CMP adopted the agenda as follows:

#### B. Election of additional officers

(Agenda sub-item 2(b))

4. The CMP considered this agenda sub-item at its 1<sup>st</sup> meeting and at its 8<sup>th</sup> meeting, on 15 December. No election of additional officers was required.<sup>5</sup>

## C. Organization of work, including for the sessions of the subsidiary bodies

(Agenda sub-item 2(c))

- 5. At the 1<sup>st</sup> meeting, the President proposed that the CMP follow the organization of work agreed by the COP.<sup>6</sup>
- 6. The President informed Parties that the CMP would take appropriate action on the basis of recommendations of the SBSTA and the SBI on the following items on its agenda:

- 7. Ukraine proposed deferring consideration of agenda item 4 until the secretariat has amended document FCCC/KP/CMP/2019/6 and Add.1. The Party requested that its statement, which was noted by the President, be noted in the report on the session.<sup>7</sup>
- 8. The President noted that the CMP would reconvene during the second week of the session to consider conclusions and decisions for adoption.
- 9. The CMP agreed to proceed on the basis of the proposal by the President.
- 10. During the conference, the President convened five informal stocktaking plenaries, on 10, 12, 13, 14 and 15 December, to review progress and share plans for advancing the work in order to reach successful outcomes on unresolved issues forwarded by the subsidiary bodies to the governing bodies for further guidance and on specific issues on the agendas of the governing bodies.<sup>8</sup>

#### D. Approval of the report on credentials

(Agenda sub-item 2(d))

- 11. At the 7<sup>th</sup> meeting, on 12 December, the President referred to the report on credentials,<sup>9</sup> which the Bureau, in accordance with rule 20 of the draft rules of procedure being applied, had examined and approved.
- 12. On the basis of the report of the Bureau and the additional credentials submitted, the CMP accepted the credentials of Parties attending the session.<sup>10</sup>

### E. Status of ratification of the Doha Amendment to the Kyoto Protocol (Agenda sub-item 2(e))

- 13. At the 1<sup>st</sup> meeting, the President recalled that, on 8 December 2012, CMP 8 adopted the Doha Amendment to the Kyoto Protocol<sup>11</sup> in accordance with Articles 20–21 of the Kyoto Protocol. On the basis of the current number of Parties to the Kyoto Protocol (192), 144 instruments of acceptance are required in order for the Doha Amendment to enter into force. The President informed the CMP that, as at 1 December 2019, the Depositary had received instruments of acceptance of the Doha Amendment from 134 Parties to the Kyoto Protocol.
- 14. The President urged Parties to the Kyoto Protocol intending to ratify the Doha Amendment to expedite their domestic procedures to deposit their instruments of acceptance with the Depositary as soon as possible. On a proposal by the President, the CMP took note of the status of ratification of the Doha Amendment as at 1 December 2019.
- 15. At the 8<sup>th</sup> meeting, the President informed the CMP that the Depositary had received an instrument of acceptance of the Doha Amendment from Niue on 10 December 2019. The President informed the CMP that a further nine instruments of acceptance are required for the Doha Amendment to enter into force.
- 16. On a proposal by the President, the CMP took note of the updated status of ratification of the Doha Amendment.

#### III. Reports of the subsidiary bodies

(Agenda item 3)

### A. Report of the Subsidiary Body for Scientific and Technological Advice (Agenda sub-item 3(a))

- 20. At the 7<sup>th</sup> meeting, the SBSTA Chair, Paul Watkinson (France), introduced the draft report on SBSTA 51<sup>14</sup> and gave an oral report on the results of SBSTA 50 and 51.<sup>15</sup>
- 21. On a proposal by the President, the CMP took note of the report on SBSTA 50,<sup>16</sup> the draft report on SBSTA 51 and the oral report provided by the SBSTA Chair. The President expressed her appreciation to Mr. Watkinson for his hard work and for guiding the work of the SBSTA over the past two years.

#### B. Report of the Subsidiary Body for Implementation

(Agenda sub-item 3(b))

- 22. At the  $7^{th}$  meeting, the SBI Chair, Emmanuel Dumisani Dlamini (Eswatini), introduced the draft report on SBI  $51^{17}$  and gave an oral report on the results of SBI 50 and  $51.^{18}$
- 23. On a proposal by the President, the CMP took note of the report on SBI 50,<sup>19</sup> the draft report on SBI 51 and the oral report provided by the SBI Chair. The President expressed her appreciation to Mr. Dlamini for his hard work and for guiding the work of the SBI over the past two years.

## IV. Reporting from and review of Parties included in Annex I<sup>20</sup> (Agenda item 4)

#### A. National communications

(Agenda sub-item 4(a))

24. At its 1<sup>st</sup> meeting, the CMP noted that this matter was on the agenda of the SBI.<sup>21</sup>

25. At its 7<sup>th</sup> meeting, the CMP took note of the SBI conclusions on the matter.<sup>22</sup>

## B. Annual compilation and accounting report for the second commitment period for Annex B Parties under the Kyoto Protocol

(Agenda sub-item 4(b))

26. At the 1<sup>st</sup> meeting, the President referred to the annual compilation and accounting report for Parties included in Annex I with commitments inscribed in the third column of Annex B in the Doha Amendment to the Kyoto Protocol for 2019.<sup>23</sup> The CMP did not complete its consideration of the report at this session.

#### V. Matters relating to the clean development mechanism

(Agenda item 5)

- 27. At the 1<sup>st</sup> meeting, the President referred to the annual report to the CMP of the CDM Executive Board,<sup>24</sup> which covers its activities from 1 September 2018 to 12 September 2019.
- 28. The President thanked the Chair of the CDM Executive Board, Piotr Dombrowicki (Poland), for his leadership and the members and alternate members of the Board for their hard work.
- 29. On a proposal by the President, the CMP established a contact group on this matter, co-chaired by Dimitar Nikov (France) and Yaw Osafo (Ghana).
- 30. At its 7<sup>th</sup> meeting, on a proposal by the President, the CMP adopted decision 2/CMP.15, entitled "Guidance relating to the clean development mechanism". The President thanked Mr. Nikov and Mr. Osafo for their hard work.
- 31. At the 8<sup>th</sup> meeting, the President noted that a nomination to the CDM Executive Board was outstanding and urged the constituencies to continue their consultations and to submit the outstanding nomination to the Executive Secretary as soon as possible and by 28 February 2020 at the latest. Once the nomination has been received by the Executive Secretary, the member will be deemed to have been elected at CMP 15, in accordance with established practice.
- 32. On a proposal by the President, the CMP elected the following members and alternate members to the CDM Executive Board:<sup>25</sup>

## X. Report of the forum on the impact of the implementation of response measures

(Agenda item 10)

- 51. At its 1<sup>st</sup> meeting, the CMP noted that this matter was on the agendas of the SBSTA and the SBI.<sup>35</sup>
- 52. At its resumed 8<sup>th</sup> meeting, the President recalled that the SBSTA and the SBI had been unable to conclude their consideration and that this matter had been forwarded to the CMP for further guidance. The President thanked Hussein Rasheed Hassan (Maldives) and Marc Vanheukelen (European Union) for undertaking consultations on the matter on her behalf.<sup>36</sup>
- 53. On a proposal by the President, the CMP adopted decision 4/CMP.15, entitled "Workplan of the forum on the impact of the implementation of response measures and its Katowice Committee of Experts on the Impacts of the Implementation of Response Measures".

## XI. Report on the high-level ministerial round table on increased ambition of Kyoto Protocol commitments

(Agenda item 11)

54. At the 1<sup>st</sup> meeting, the President recalled that consultations on this matter at CMP 14 had not achieved consensus on whether further work was needed under this agenda item. The

President proposed that a senior member of her delegation hold consultations on the matter on her behalf and report back to the CMP on the outcome.

55. At the 7<sup>th</sup> meeting, the President thanked Gonzalo Guaiquil (Chile) for undertaking those consultations and noted that the CMP had not completed its consideration of this matter at this session.

- 56. At its 1<sup>st</sup> meeting, the CMP noted that the matters under sub-items 12(a–b) were on the agenda of the SBI.<sup>37</sup>
- 57. At its 7<sup>th</sup> meeting, on a recommendation of the SBI,<sup>38</sup> the CMP adopted decision 7/CMP.15, entitled "Administrative, financial and institutional matters".

#### C. Programme budget for the biennium 2020–2021

(Agenda item 12(c))

- 58. At its 7<sup>th</sup> meeting, the CMP took note of the draft decisions on the programme budget for the biennium 2020–2021, and the budget for the international transaction log and a methodology for the collection of its fees for the biennium 2020–2021 recommended at SBI 50<sup>39</sup> for consideration and adoption at CMP 15.
- 59. On a proposal by the President, the CMP adopted:
- (a) Decision 5/CMP.15, entitled "Budget for the international transaction log and a methodology for the collection of its fees for the biennium 2020–2021";
- (b) Decision 6/CMP.15, entitled "Programme budget for the biennium 2020–2021".

#### XIII. High-level segment

(Agenda item 13)40

- 60. At the first informal stocktaking plenary, on 10 December, the President appointed Teresa Ribera (Spain) and Masagos Zulkifi (Singapore) to facilitate discussions on decision 1/CMP.15.
- 61. At its 8<sup>th</sup> meeting, on a proposal by the President, the CMP adopted decision 1/CMP.15, entitled "Chile Madrid Time for Action". The President thanked Ms. Ribera and Mr. Zulkifi for their hard work.

#### XIV. Other matters

(Agenda item 14)

62. At its  $8^{th}$  meeting, the CMP noted that no other matters had been raised under this agenda item.

#### XV. Conclusion of the session

(Agenda item 15)

63. At the joint 9<sup>th</sup> meetings of the CMP, COP 25 and CMA 2, on 15 December, the President and representatives of groups of Parties and observer organizations made closing statements.<sup>41</sup>

## A. Adoption of the draft report of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol on its fifteenth session (Agenda sub-item 15(a))

- 64. At its 10<sup>th</sup> meeting, on 15 December, the CMP considered the draft report on this session<sup>42</sup> and, on a proposal by the President, authorized the Rapporteur to complete the report under the guidance of the President and with the assistance of the secretariat.
- 65. The Deputy Executive Secretary informed the CMP that one decision adopted by the CMP at this session had financial and human resource implications beyond the provisions included in the budget for the biennium 2020–2021. Under agenda item 10, "Report of the forum on the impact of the implementation of response measures", EUR 860,000 will be required in the biennium 2020–2021 to operationalize the workplan of the forum on the impact of the implementation of response measures and its Katowice Committee of Experts on the Impacts of the Implementation of Response Measures. This falls into the category of temporary or short-term activities. 43, 44
- 66. The Deputy Executive Secretary informed the CMP that funding for these activities in the biennium 2020–2021 will be sought from voluntary contributions, and that resource requirements for 2022 and beyond resulting from decisions adopted at this session will be treated in line with the established budgetary process.
- 67. The Deputy Executive Secretary stated that the secretariat is relying on Parties' continued generosity in providing funding for these activities in a timely and predictable manner, as without such contributions the secretariat will not be able to undertake the requested activities. He noted that these amounts are preliminary and based on the information available at the time.

#### B. Closure of the session

(Agenda sub-item 15(b))

68. At its 10<sup>th</sup> meeting, on a proposal by a Party, the CMP adopted resolution 1/CMP.15, entitled "Expression of gratitude to the Government of the Republic of Chile, the Government of the Kingdom of Spain and the people of the city of Madrid".

69. The President then declared CMP 15 closed.
