## I. Opening of the session

1. The fifteenth session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP), convened pursuant to Article 13, paragraph 6, of the Kyoto Protocol, was held at IFEMA – Feria de Madrid in Madrid, Spain, from 2 to 13 December 2019. Carolina Schmidt (Chile), President of CMP 15, convened the 1<sup>st</sup> meeting of the session¹ on Monday, 2 December.²

- 2. At its 1<sup>st</sup> meeting, the CMP considered a note by the Executive Secretary containing the provisional agenda and annotations.<sup>3</sup> The provisional agenda was prepared in agreement with the President of CMP 14 after consultation with the Bureau of the CMP, taking into consideration the views expressed by members of the Bureau and by Parties at the fiftieth session of the Subsidiary Body for Implementation.
