I. Opening of the session

(Agenda item 1)

1. CMP 16, convened pursuant to Article 13, paragraph 6, of the Kyoto Protocol, was held at the Scottish Event Campus in Glasgow, United Kingdom of Great Britain and Northern Ireland, from 31 October to 13 November 2021. Alok Sharma (United Kingdom), President of CMP 16, opened the session on Sunday, 31 October.¹

II. Organizational matters

(Agenda item 2)

A. Adoption of the agenda

(Agenda sub-item 2(a))

2. At its 1st meeting, ² on 31 October, the CMP considered document FCCC/KP/CMP/2021/1/Add.1, containing the provisional agenda.³ The President noted that the document reflected the understanding outlined at the 1st plenary meeting of COP 26.⁴

3. Following a request by a representative of Ukraine,⁵ the President proposed and the CMP agreed to defer consideration of agenda sub-item 4(b), "Annual compilation and accounting report for the second commitment period for Annex B Parties under the Kyoto Protocol (for 2019, 2020 and 2021)", to CMP 17 (November 2022). Ukraine also requested that its statement be noted in the report on the session.

- 4. On the proposal by the President, the CMP adopted the agenda as follows:
 - 1. Opening of the session.
 - 2. Organizational matters:
 - (a) Adoption of the agenda;
 - (b) Election of additional officers;

B. Election of additional officers

(Agenda sub-item 2(b))

5. The CMP considered this matter at its 1st meeting and at its resumed 10th meeting, on 13 November. No election of additional officers was required.⁷

6. The President informed Parties that nominations for elections to bodies under the Kyoto Protocol were outstanding and he urged constituencies to continue consultations and submit the outstanding nominations to the secretariat as soon as possible and by 28 February 2022 at the latest. Once the nominations have been received by the secretariat, the nominees will be deemed elected at CMP 16 in accordance with established practice.

C. Organization of work, including for the sessions of the subsidiary bodies

(Agenda sub-item 2(c))

1. Referral of work to the subsidiary bodies and organization of the Conference

7. At the 1st meeting, the President proposed that the CMP follow the organization of work agreed by the COP.⁸

8. The President informed Parties that the CMP would take appropriate action on the basis of recommendations of the SBSTA and the SBI on the following items on its agenda:

9. In addition, the President proposed to refer agenda sub-item 4(c), "Date of completion of the expert review process under Article 8 of the Kyoto Protocol for the second commitment period", to SBI 56 (June 2022) for consideration. The President requested the SBI to conclude its work with a view to recommending a draft decision for consideration and adoption at CMP 17 at the latest.

10. The President informed Parties that on Thursday, 11 November, and Friday, 12 November, the CMP would reconvene to consider draft decisions and conclusions for adoption.

11. The CMP agreed to proceed on the basis of the proposals by the President.

2. Opening statements

12. On 31 October, a joint plenary of the CMP, COP 26, CMA 3, SBSTA 52–55 and SBI 52–55 was held to hear opening statements.⁹

3. Informal stocktaking

13. During the Conference, the President convened five informal stocktaking plenaries.¹⁰

4. Conclusion of work

14. At its 10th meeting, on 13 November, on a proposal by the President, the CMP adopted decision 1/CMP.16, entitled "Glasgow Climate Pact".

D. Approval of the report on credentials

(Agenda sub-item 2(d))

15. At the 9th meeting, on 11 November, the President referred to the report on credentials,¹¹ which the Bureau, in accordance with rule 20 of the draft rules of procedure being applied, had examined and approved.

16. On the basis of the report of the Bureau and additional credentials presented, the CMP accepted the credentials of Parties attending the session.¹² In addition, the secretariat received credentials from Antigua and Barbuda on 15 November 2021, Tonga on 30 November 2021, Costa Rica on 1 December 2021 and Dominica on 14 January 2022.

E. Status of ratification of the Doha Amendment to the Kyoto Protocol

(Agenda sub-item 2(e))

17. At the 1st meeting, the President recalled that, on 8 December 2012, CMP 8 adopted the Doha Amendment to the Kyoto Protocol in accordance with Articles 20–21 of the Kyoto Protocol. He noted that the Doha Amendment entered into force on 31 December 2020 and, as at 30 October 2021, 147 Parties to the Kyoto Protocol had accepted the Doha Amendment.

18. On a proposal by the President, the CMP took note of the status of ratification of the Doha Amendment.

F. Attendance

19. Information on participation in the sessions in Glasgow is available in document FCCC/CP/2021/INF.3.

20. According to decision 36/CMP.1, the admission of organizations as observers as decided by the COP also applies to the CMP. Observer organizations newly admitted to the sessions of the COP, the CMP and the CMA are listed in document FCCC/CP/2021/7.¹³

G. Documentation

21. The documents that were before CMP 16 are available on the UNFCCC website.¹⁴

III. Reports of the subsidiary bodies

(Agenda item 3)

A. Report of the Subsidiary Body for Scientific and Technological Advice

(Agenda sub-item 3(a))

22. At the 9th meeting, the SBSTA Vice-Chair, Kakhaberi Mdivani (Georgia), introduced the draft report on SBSTA 52–55¹⁵ and gave an oral report on the results of the session.¹⁶

23. On a proposal by the President, the CMP took note of the draft report and the oral report. The President expressed his appreciation to the SBSTA Chair, Tosi Mpanu-Mpanu (Democratic Republic of the Congo), for guiding the work of the SBSTA over the past two years and for his collaboration and support during the Presidency consultations in the lead-up to and during the Conference.

24. At the 9th meeting, the SBI Chair, Marianne Karlsen (Norway), introduced the draft report on SBI 52–55¹⁷ and gave an oral report on the results of the session.¹⁸

25. On a proposal by the President, the CMP took note of the draft report and the oral report. The President expressed his appreciation to Ms. Karlsen for guiding the work of the SBI over the past two years and for her collaboration and support during the Presidency consultations in the lead-up to and during the Conference.

V.Matters relating to the clean development mechanism

(Agenda item 5)

27. At the 1st meeting, the President referred to the annual reports to the CMP of the CDM Executive Board for 2020 and 2021,²² which cover its activities from 13 September 2019 to 9 September 2021.

28. The President thanked the Chair of the CDM Executive Board for 2021, Olivier Kassi (Belgium), the Chair for 2020, El Hadji Mbaye Diagne (Senegal), and the members and alternate members of the Board for their hard work over the past two years.

29. On a proposal by the President, the CMP established a contact group on this matter, co-chaired by Kazuhisa Koakutsu (Japan) and Yaw Osafo (Ghana).

30. The President informed the CMP that some issues discussed in the contact group were linked to matters relating to Article 6 of the Paris Agreement, being addressed under the SBSTA. As such, the President stated that he would maintain close contact with the co-chairs to ensure coordinated progress across the SBSTA, the CMA and the CMP. He also informed

58. At its 12th meeting, on 13 November, the CMP noted that no other matters had been raised under this agenda item.

XV. Conclusion of the session

59. At the joint 11th meeting of the CMP and 13th meetings of COP 26 and CMA 3, on 13 November, the President, the Executive Secretary and representatives of groups of Parties and observer organizations made closing statements.³⁸

A. Adoption of the draft report of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol on its sixteenth session

(Agenda sub-item 15(a))

60. At its 12th meeting, the CMP considered the draft report on the session³⁹ and, on a proposal by the President, authorized the Rapporteur to complete the report under the guidance of the President and with the assistance of the secretariat.

61. A representative of the secretariat informed the CMP that one decision it adopted has financial and human resource implications beyond the provisions included in the budget for the biennium 2022–2023, and that funding estimates and categorization of activities are preliminary and based on the information available at the time: under agenda item 9, "Report of the forum on the impact of the implementation of response measures", EUR 26,000 will be required in 2022 to organize a two-day workshop to further advance work on implementation of the forum workplan. Additional staff costs of EUR 19,000 will be covered from existing resources. The same estimate was reported under the equally titled COP 26 agenda item 12 and CMA 3 agenda item 11. This is a temporary or short-term activity,⁴⁰ to be funded from voluntary contributions under the Trust Fund for Supplementary Activities.

B. Closure of the session

62. At its 12th meeting, on a proposal by a Party, the CMP adopted resolution 1/CMP.16, entitled "Expression of gratitude to the Government of the United Kingdom of Great Britain and Northern Ireland and the people of the city of Glasgow".

63. The President then declared CMP 16 closed.
