## I. Opening of the session

(Agenda item 1)

1. CMP 17, convened pursuant to Article 13, paragraph 6, of the Kyoto Protocol, was held at the Sharm el-Sheikh International Convention Center in Sharm el-Sheikh, Egypt, from 6 to 20 November 2022.<sup>1</sup> Sameh Shoukry (Egypt), President of CMP 17, opened the session on Sunday, 6 November.

## **II.** Organizational matters

(Agenda item 2)

#### A. Adoption of the agenda

(Agenda sub-item 2(a))

2. At its 1<sup>st</sup> meeting,<sup>2</sup> on 6 November, the CMP considered document FCCC/KP/CMP/2022/1 containing the provisional agenda and annotations.<sup>3</sup>

- 3. On a proposal by the President, the CMP adopted the agenda as follows:

#### **B.** Election of additional officers

(Agenda sub-item 2(b))

4. The CMP considered this matter at its resumed 10<sup>th</sup> meeting, on 20 November. No election of additional officers was required.<sup>5</sup>

5. The President informed Parties that nominations for election to bodies under the Kyoto Protocol were outstanding and urged constituencies to continue consultations and submit the outstanding nominations to the secretariat as soon as possible and by 28 February 2023 at the latest. On a proposal by the President, the CMP agreed that, once the outstanding nominations have been received by the secretariat, the nominees will be deemed elected at CMP 17 in accordance with established practice.

## C. Organization of work, including for the sessions of the subsidiary bodies

(Agenda sub-item 2(c))

#### Referral of work to the subsidiary bodies and organization of the Conference

6. At the 1<sup>st</sup> meeting, the President proposed that the CMP follow the organization of work agreed by the COP.<sup>6</sup>

7. At the same meeting, on a proposal by the President, the CMP agreed to defer consideration of agenda sub-items 4(a), "National communications", and 4(b), "Annual compilation and accounting report for the second commitment period for Annex B Parties under the Kyoto Protocol (for 2019, 2020, 2021 and 2022)", to CMP 18 (November–December 2023).

8. The President informed Parties that the CMP would take appropriate action on the basis of recommendations of the SBSTA and the SBI on the following items on its agenda:

9. Regarding agenda sub-item 4(c), "Date of completion of the expert review process under Article 8 of the Kyoto Protocol for the second commitment period", the President recalled that CMP 16 had referred this matter to the SBI and that SBI 56 had concluded its consideration on the matter and recommended a draft decision thereon for consideration at CMP 17.<sup>7</sup>

10. The President informed Parties that on Thursday, 17 November, and Friday, 18 November, the CMP would reconvene to consider draft decisions and conclusions for adoption.

11. The CMP agreed to proceed on the basis of the information presented by the President.

12. Also on 6 November, a joint meeting of CMP 17, COP 27, CMA 4, SBSTA 57 and SBI 57 was held to hear opening statements.<sup>8</sup>

13. During the Conference, the President convened four informal stocktaking plenaries, on 14, 15, 17 and 18 November,<sup>9</sup> with the aim of enhancing the openness, inclusiveness and transparency of the negotiations. During the informal stocktaking plenaries, the President provided an assessment of progress and shared his plans for advancing work in order to reach successful outcomes.<sup>10</sup>

14. At the 10<sup>th</sup> meeting, on 20 November, the President recalled that world leaders had gathered at the session under the theme "Together for Implementation" to deliberate on how to advance the global climate agenda and translate climate commitments into implementation. The President noted that the outcomes of the session provided a gateway to scaled-up implementation and transformation towards a future of climate neutrality and climate-resilient development. The President expressed his deep appreciation to Parties for their willingness to work constructively to deliver the achieved results.

#### D. Approval of the report on credentials

(Agenda sub-item 2(d))

15. At the 9<sup>th</sup> meeting, on 17 November, the President referred to the report on credentials,<sup>11</sup> which the Bureau, in accordance with rule 20 of the draft rules of procedure being applied, had examined and approved.

16. On the basis of the report of the Bureau, the CMP accepted the credentials of Parties attending the session. In addition, the secretariat received credentials from Senegal on

18 November 2022, the Marshall Islands on 19 November 2022, Côte d'Ivoire on 16 December 2022, Namibia on 22 December 2022 and Kenya on 3 January 2023.

#### E. Attendance

17. Information on participation in the sessions in Sharm el-Sheikh is available in document FCCC/CP/2022/INF.3.

18. According to decision 36/CMP.1, the admission of organizations as observers as decided by the COP also applies to the CMP. Observer organizations newly admitted to the sessions of the COP, the CMP and the CMA are listed in document FCCC/CP/2022/7.<sup>12</sup>

19. The documents that were before CMP 17 are available on the UNFCCC website.<sup>13</sup>

### **III.** Reports of the subsidiary bodies

(Agenda item 3)

A. Report of the Subsidiary Body for Scientific and Technological Advice (Agenda sub-item 3(a))

20. At the 9<sup>th</sup> meeting, the SBSTA Chair, Tosi Mpanu Mpanu (Democratic Republic of the Congo), introduced the draft report on SBSTA  $57^{14}$  and gave an oral report on the results of SBSTA 56 and  $57.^{15}$ 

21. On a proposal by the President, the CMP took note of the report on SBSTA 56,<sup>16</sup> the draft report on SBSTA 57 and the oral report provided by the SBSTA Chair.

#### B. Report of the Subsidiary Body for Implementation

(Agenda sub-item 3(b))

22. At the 9<sup>th</sup> meeting, the SBI Chair, Marianne Karlsen (Norway), introduced the draft report on SBI 57<sup>17</sup> and gave an oral report on the results of SBI 56 and 57.<sup>18</sup>

23. On a proposal by the President, the CMP took note of the report on SBI 56,<sup>19</sup> the draft report on SBI 57 and the oral report provided by the SBI Chair.

24. On a further proposal by the President, the CMP took note of the report of the administrator of the international transaction log under the Kyoto Protocol.<sup>20</sup>

25. The President noted that recommendations of the SBI would be adopted under the relevant agenda items.

## C. Date of completion of the expert review process under Article 8 of the Kyoto Protocol for the second commitment period

(Agenda sub-item 4(c))

26. At its 1<sup>st</sup> meeting, the CMP noted that this matter was considered at SBI 56.<sup>22</sup>

27. At its 9<sup>th</sup> meeting, on a recommendation of the SBI,<sup>23</sup> the CMP adopted decision 1/CMP.17, entitled "Date of completion of the expert review process under Article 8 of the Kyoto Protocol for the second commitment period".

## V. Matters relating to the clean development mechanism

(Agenda item 5)

28. At the 1<sup>st</sup> meeting, the President referred to the 2022 report of the CDM Executive Board to the CMP,<sup>24</sup> which covers the work of the Executive Board from 10 September 2021 to 8 September 2022 and informed the CMP that, since the publication of the 2022 report, the Board had held its 116<sup>th</sup> meeting in Sharm el-Sheikh, from 31 October to 3 November 2022.<sup>25</sup> The President thanked the 2022 Chair, Omar Yuvual Alcock (Jamaica), and members and alternate members of the CDM Executive Board for their hard work over the past year.

29. At the same meeting, on a proposal by the President, the CMP established a contact group on this matter co-chaired by Kazuhiza Koakutsu (Japan) and Alick Muvundika (Zambia).

30. At the 10<sup>th</sup> meeting, the President informed the CMP that the contact group referred to in paragraph 29 above also considered SBI 57 agenda item 5, "Matters relating to the clean development mechanism registry referred to in paragraph 75(b) of the annex to decision 3/CMA.3", as recommended by the SBI.<sup>26</sup>

31. On a proposal by the President, the CMP adopted decision 2/CMP.17, entitled "Guidance relating to the clean development mechanism".

32. At its resumed 10<sup>th</sup> meeting, on a proposal by the President, the CMP elected the following members and alternate members to the CDM Executive Board:

## VI. Matters relating to joint implementation

(Agenda item 6)

33. At the 1<sup>st</sup> meeting, the President referred to the 2022 report of the JISC to the CMP,<sup>27</sup> which covers the work of the JISC from 15 September 2021 to 14 September 2022 and thanked the Chair, Jakob Wiesbauer-Lenz (Austria), and members and alternate members of the JISC for their hard work over the past year. At the same meeting, on a proposal by the President, the CMP took note of the 2022 report of the JISC and expressed its appreciation to the Committee for its prudent management of resources over the past year.

34. Also at the same meeting, the President proposed that Presidency consultations be held on the recommendation of the JISC to the CMP on the discontinuation of its activities and functions<sup>28</sup> and that the outcomes of those consultations be reported back to the CMP. The consultations were undertaken by Wael Keshk (Egypt).

35. At the 10<sup>th</sup> meeting, the President informed the CMP that the consultations had been completed.

36. On a proposal by the President, the CMP adopted decision 3/CMP.17, entitled "Guidance on the implementation of Article 6 of the Kyoto Protocol".

## VII. Matters relating to the Adaptation Fund

(Agenda item 7)

#### A. Report of the Adaptation Fund Board

(Agenda sub-item 7(a))

37. At the 1<sup>st</sup> meeting, the President referred to the 2022 report of the Adaptation Fund Board to the CMP,<sup>29</sup> which covers the work of the Board from 1 July 2021 to 30 June 2022, and thanked the Chair, Albara Tawfiq (Saudi Arabia), and members and alternate members of the Board for their hard work over the past year. At the same meeting, on a proposal by the President, the CMP established a contact group on this matter co-chaired by Diann Black-Layne (Antigua and Barbuda) and Eva Schreuder (Netherlands).

38. At its 10<sup>th</sup> meeting, on a proposal by the President, the CMP adopted decision 4/CMP.17, entitled "Report of the Adaptation Fund Board for 2022".

41. At its 10<sup>th</sup> meeting, on a recommendation of the SBI,<sup>31</sup> the CMP adopted decision 5/CMP.17, entitled "Fourth Review of the Adaptation Fund".

42. At its 1<sup>st</sup> meeting, the CMP noted that this matter was on the agenda of the SBI.<sup>32</sup>

43. At its  $9^{th}$  meeting, on a proposal by the President, the CMP took note of the conclusions of SBI 56 on this matter.<sup>33</sup>

# IX. Report of the forum on the impact of the implementation of response measures

(Agenda item 9)

44. At its  $1^{st}$  meeting, the CMP noted that this matter was on the agendas of the SBSTA and the SBI.<sup>34</sup>

45. At the 10<sup>th</sup> meeting, the President thanked the Chairs of the SBSTA and the SBI for forwarding the outcomes of the work of the SBSTA and the SBI<sup>35</sup> and stated that he had undertaken further consultations on this matter.<sup>36</sup>

46. On a proposal by the President, the CMP adopted decision 7/CMP.17, entitled "Report of the forum on the impact of the implementation of response measures".

## X. Report of the Compliance Committee

(Agenda item 10)

47. At the 1<sup>st</sup> meeting, the President referred to the annual report of the Compliance Committee to the CMP,<sup>37</sup> which covers the activities of the Committee from 10 September 2021 to 7 July 2022.

48. The President thanked the Chairpersons of the Compliance Committee, Karoliina Anttonnen (Finland), Lisa Benjamin (Bahamas), Paulette Bynoe (Guyana) and Kunihiko

49. At the same meeting, the President proposed that Kunzang (Bhutan) conduct informal consultations on this matter on his behalf.

50. At its 9<sup>th</sup> meeting, on a proposal by the President, the CMP adopted decision 6/CMP.17, entitled "Compliance Committee".

## XI. Report on the high-level ministerial round table on increased ambition of Kyoto Protocol commitments

(Agenda item 11)

51. At the 1<sup>st</sup> meeting, the President recalled that consultations on this matter at CMP 16 had not achieved consensus on whether further work was needed under this agenda item. The President proposed that Amr Osama Abdel-Aziz (Egypt) hold consultations on this matter on his behalf and report back to the CMP on the outcomes thereof.

52. At the 9<sup>th</sup> meeting, the President noted that the CMP had not completed its consideration of this matter at this session.

## **XV.** Conclusion of the session

(Agenda item 15)

56. At the joint 11<sup>th</sup> meeting of CMP 17, COP 27 and CMA 4, on 20 November, the President, the Executive Secretary and representatives of groups of Parties and observer organizations made closing statements.<sup>42</sup>

### A. Adoption of the draft report of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol on its seventeenth session

(Agenda sub-item 15(a))

57. At its resumed 10<sup>th</sup> meeting, the CMP considered the draft report on the session<sup>43</sup> and, on a proposal by the President, authorized the Rapporteur to complete the report under the guidance of the President and with the assistance of the secretariat.

58. The Deputy Executive Secretary informed the CMP that one of the decisions it adopted has financial and human resource implications beyond the provisions included in the budget for the biennium 2022–2023, and that funding estimates and categorization of activities are preliminary and based on the information available at the time: under agenda item 9, "Report of the forum on the impact of the implementation of response measures", EUR 459,000 will be required in 2023 to compile submissions from Parties as input to the global stocktake and to organize a regional workshop on activity 2 of the forum workplan. The same estimate is provided under the equally titled COP 27 agenda item 12 and CMA 4 agenda item 12. These activities are temporary or short-term<sup>44</sup> and would therefore be funded from supplementary funds.

59. The Deputy Executive Secretary informed the CMP that resource requirements for 2024 and beyond resulting from decisions taken at this session will be treated in line with the established budgetary process.

#### **B.** Closure of the session

(Agenda sub-item 15(b))

60. At its resumed 10<sup>th</sup> meeting, on a proposal by a Party, the CMP adopted resolution 1/CMP.17, entitled "Expression of gratitude to the Government of the Arab Republic of Egypt and the people of the city of Sharm el-Sheikh".

61. The President then declared CMP 17 closed.
