#### I. Opening of the session

(Agenda item 1)

1. COP 25, convened pursuant to Article 7, paragraph 4, of the Convention, was held at IFEMA – Feria de Madrid in Madrid, Spain, from 2 to 15 December 2019.<sup>1</sup> Michał Kurtyka (Poland), President of COP 24, opened the session on Monday, 2 December, and delivered an opening statement.<sup>2</sup>

2. The ceremonial opening was held on 2 December in the presence of Heads of State and Government. Statements were made by Hoesung Lee, Chair of the Intergovernmental Panel on Climate Change; Sebastián Piñera, President of Chile, via video message; António Guterres, Secretary-General of the United Nations; and Pedro Sánchez, President of the Government of Spain.<sup>3</sup>

#### **II.** Organizational matters

(Agenda item 2)

### A. Election of the President of the Conference of the Parties at its twenty-fifth session

(Agenda sub-item 2(a))

3. At the 1<sup>st</sup> meeting of the COP,<sup>4</sup> the President of COP 24 recalled that, in accordance with rule 22, paragraph 1, of the draft rules of procedure being applied, the office of President of the COP is subject to rotation among the five regional groups. He informed Parties that the next President would come from the Latin American and Caribbean States. Following the proposal of the President of COP 24, the COP elected by acclamation Carolina Schmidt, Minister of the Environment of Chile, as President of COP 25, who made a statement.<sup>5</sup>

#### **B.** Adoption of the rules of procedure

(Agenda sub-item 2(b))

4. At the 1<sup>st</sup> meeting, the President recalled that the President of COP 24 had proposed, and Parties had agreed, to continue to conduct consultations on the draft rules of procedure at COP 25. On a proposal by the President, the COP agreed that, as at previous sessions, the draft rules of procedure contained in document FCCC/CP/1996/2 should continue to be applied, with the exception of draft rule 42. The President also proposed that a senior member of her delegation hold informal consultations on this matter on her behalf and report back to the COP on the outcome.

5. At the 8<sup>th</sup> meeting, on 15 December, the President thanked Claudio Garrido (Chile) for undertaking those informal consultations and informed the COP that Parties had agreed to continue consultations on the matter at COP 26 (November 2020). On a proposal by the President, the COP agreed to continue consideration of the matter at COP 26.

#### C. Adoption of the agenda

(Agenda sub-item 2(c))

6. At its 1<sup>st</sup> meeting, the COP considered document FCCC/CP/2019/11 containing the provisional agenda.<sup>6</sup> The President noted that the document reflected the outcome of intensive consultations and thanked all Parties for their constructive engagement. She recalled the understanding reached among Parties with regard to specific items:

(a) The item proposed for inclusion in the agenda by Egypt on behalf of the African Group entitled "Clarification of the status of the provision of privileges and immunities to the Green Climate Fund", was not included in the provisional agenda contained in document FCCC/CP/2019/11. However, the President requested the co-facilitators for sub-item 8(c), "Report of the Green Climate Fund to the Conference of the Parties and guidance to the Green Climate Fund", to provide space to consider the matter under this sub-item, in the hope of reaching a successful outcome. She informed Parties that she would personally engage with the Secretary-General on the matter;

(b) Sub-item 14(c), "Proposal from Turkey to delete the name of Turkey from the list in Annex I to the Convention", had been included in the provisional agenda contained in document FCCC/CP/2019/11. However, the President informed Parties that just before the opening of the session Turkey had withdrawn its request for inclusion of the item in the agenda.

7. The President proposed that the following agenda items be held in abeyance:

(a) Sub-item 14(a), "Proposal from the Russian Federation to amend Article 4, paragraph 2(f), of the Convention";

(b) Item 15, "Second review of the adequacy of Article 4, paragraph 2(a) and (b), of the Convention".

8. The President then proposed that the agenda be adopted as contained in document FCCC/CP/2019/11, amended as referred to in paragraph 6(b) above and with items 14(a) and 15 held in abeyance.

10. A representative of one Party made a statement.

#### **D.** Election of officers other than the President

(Agenda sub-item 2(d))

11. At the 1<sup>st</sup> meeting, the President informed the COP that Una May Gordon (Jamaica), a Vice-President of the COP, had begun consultations on behalf of the President of COP 24 on the election of officers other than the President and would continue the consultations until the nominations were finalized.

12. The President also informed the COP that only 8 of the 157 nominations due had been received and that the gender composition of the bodies established under the Convention, the Kyoto Protocol and the Paris Agreement in 2019 was 30 per cent female and 70 per cent male.

13. The President requested Parties to give active consideration to the nomination of men and women equally for elective posts in all established bodies in order to achieve gender balance. She invited groups and constituencies to submit all outstanding nominations by 7 December. On a proposal by the President, the COP decided to postpone the election of the other officers of its Bureau until all nominations had been finalized.

14. At the 8<sup>th</sup> meeting, the President thanked Ms. Gordon for undertaking the consultations on the election of the other officers of the Bureau and of the officers of other bodies under the Convention, the Kyoto Protocol and the Paris Agreement.

15. On a proposal by the President, the COP elected by acclamation the other members of the Bureau of COP 25.<sup>8</sup> The composition of the Bureau is therefore as follows:<sup>9</sup>

#### E. Admission of organizations as observers

(Agenda sub-item 2(e))

16. At its 1<sup>st</sup> meeting, the COP considered a note by the secretariat on the admission of organizations as observers<sup>10</sup> listing five IGOs and 118 NGOs that had been provisionally admitted as observers. In accordance with the recommendations of the Bureau and on a proposal by the President, the COP admitted the organizations listed in the above-mentioned note by the secretariat.

17. According to decisions 36/CMP.1 and 2/CMA.1, the admission of organizations as observers as decided by the COP also applies to the CMP and the CMA, respectively.

18. In addition, on a proposal by the President based on a recommendation of the Bureau, the COP requested SBI 52 to review the approach to admitting observer organizations and to provide any relevant guidance to the secretariat.

### **F.** Organization of work, including for the sessions of the subsidiary bodies (Agenda sub-item 2(f))

19. At the 1<sup>st</sup> meeting, the President informed Parties that the COP would take appropriate action on the basis of recommendations of the SBSTA and the SBI on the following items on its agenda:

20. On a proposal by the President, the COP agreed to refer consideration of the annual report on gender composition and the synthesis report on progress in integrating a gender perspective in constituted body processes (under its agenda item 13) to the SBI.

21. Ukraine expressed its objection to the consideration of agenda item 4 and requested that consideration of that item and any documents prepared by the secretariat that are not in accordance with United Nations General Assembly resolutions 68/262, paragraph 6, and 73/263, paragraph 11, be deferred. The Party also requested that its statement be noted in the report on the session.<sup>12</sup> The President noted Ukraine's requests.

22. The President informed the COP that the sessions of the subsidiary bodies would conclude on Monday, 9 December, and that she looked forward to receiving the outcomes of their work.

23. With regard to agenda item 17, "High-level segment", the President informed the COP that national statements by Parties would be delivered in the joint high-level segment of the

COP, the CMP and the CMA on 10 and 11 December, while statements by senior representatives of IGOs and NGOs would be delivered on 11 December.<sup>13</sup>

24. The President further informed Parties that the COP would reconvene later that day in a joint plenary with the other governing and subsidiary bodies to hear opening statements from Parties and observers.

25. The COP agreed to proceed on the basis of the proposals by the President.

26. At the joint 2<sup>nd</sup> meetings of the COP, CMP 15, CMA 2, SBSTA 51 and SBI 51, on 2 December, statements were made by representatives of Parties on behalf of the Group of 77 and China; the European Union and its member States; the Environmental Integrity Group; the Umbrella Group; the Arab Group; the African Group; the least developed countries; the Coalition for Rainforest Nations; the Alliance of Small Island States; Argentina, Brazil and Uruguay; the Bolivarian Alliance for the Peoples of Our America – Peoples' Trade Treaty; Brazil, South Africa, India and China; and AILAC. One statement was made on behalf of a Party.<sup>14</sup>

27. At the same meeting, statements were further made by representatives of business and industry, environmental, farmers and agricultural, research and independent, trade union, and youth NGOs, indigenous peoples organizations, local government and municipal authorities, and the women and gender constituency.

28. During the conference, the President convened five informal stocktaking plenaries, on 10, 12, 13, 14 and 15 December, to review progress and share plans for advancing the work in order to reach successful outcomes on unresolved issues forwarded by the subsidiary bodies to the governing bodies for further guidance and on specific issues on the agendas of the governing bodies.<sup>15</sup>

#### G. Dates and venues of future sessions

(Agenda sub-item 2(g))

29. At the 1<sup>st</sup> meeting, the President noted that, in keeping with the principle of rotation among the regional groups, the President of COP 26, CMP 16 and CMA 3 (November 2020) would come from the Western European and other States, and the President of COP 27, CMP 17 and CMA 4 (November 2021) would come from the African States.

30. The President informed the COP that the Western European and other States had nominated the United Kingdom of Great Britain and Northern Ireland to host COP 26, and she invited the African States to come forward with offers to host COP 27.

31. The President indicated that SBI 50 had recommended dates for the sessional periods in 2024.

32. The President proposed that a senior member of her delegation conduct informal consultations on her behalf with a view to proposing a draft decision on the dates and venues of future sessions for consideration and adoption by the COP.

33. At the 8<sup>th</sup> meeting, the President thanked Mr. Garrido for conducting those informal consultations.

34. On a proposal by the President, the COP adopted decision 16/CP.25, entitled "Dates and venues of future sessions".

35. A representative of the United Kingdom made a statement as the incoming Presidency of COP 26.<sup>16</sup>

#### H. Adoption of the report on credentials

(Agenda sub-item 2(h))

36. At the 7<sup>th</sup> meeting, on 12 December, the President referred to the report on credentials,<sup>17</sup> which the Bureau, in accordance with rule 20 of the draft rules of procedure being applied, had examined and approved.

37. On the basis of the report of the Bureau, and the additional credentials submitted by two Parties,<sup>18</sup> the COP approved the credentials of Parties attending the session.<sup>19</sup>

#### III. Reports of the subsidiary bodies

(Agenda item 3)

A. Report of the Subsidiary Body for Scientific and Technological Advice (Agenda sub-item 3(a))

40. At the 7<sup>th</sup> meeting, the SBSTA Chair, Paul Watkinson (France), introduced the draft report on SBSTA 51<sup>21</sup> and gave an oral report on the results of SBSTA 50 and 51.<sup>22</sup>

41. On a proposal by the President, the COP took note of the report on SBSTA 50,<sup>23</sup> the draft report on SBSTA 51 and the oral report provided by the SBSTA Chair. The President expressed her appreciation to Mr. Watkinson for his hard work and for guiding the work of the SBSTA over the past two years.

42. At its 8<sup>th</sup> meeting, the COP noted the nominations of members to the Local Communities and Indigenous Peoples Platform Facilitative Working Group.<sup>24</sup>

#### B. Report of the Subsidiary Body for Implementation

(Agenda sub-item 3(b))

43. At the 7<sup>th</sup> meeting, the SBI Chair, Emmanuel Dumisani Dlamini (Eswatini), introduced the draft report on SBI  $51^{25}$  and gave an oral report on the results of SBI 50 and  $51.^{26}$

44. On a proposal by the President, the COP took note of the report on SBI 50,<sup>27</sup> the draft report on SBI 51 and the oral report provided by the SBI Chair. The President expressed her appreciation to Mr. Dlamini for his hard work and for guiding the work of the SBI over the past two years.

45. The COP, on the recommendations of the SBI, adopted:<sup>28</sup>

(a) Decision 7/CP.25, entitled "National adaptation plans";<sup>29</sup>

(b) Decision 15/CP.25, entitled "Terms of reference for the review of the Doha work programme on Article 6 of the Convention".<sup>30</sup>

### C. Issues forwarded to the Conference of the Parties by the subsidiary bodies

46. At the first informal stocktaking plenary, on 10 December, the President thanked the Chairs of the subsidiary bodies for their hard work and noted that some issues under consideration by the subsidiary bodies that remained unresolved had been forwarded to the relevant governing body for further guidance. She informed Parties that she would appoint ministers and senior members of her delegation to assist her in facilitating discussions on those unresolved issues as well as on some issues on the agendas of the governing bodies. She stated that she would be convening regular stocktaking meetings in order to maintain a transparent and inclusive process.

47. The following ministers and senior members of the President's delegation were appointed:

(a) Review of the WIM: Ola Elvestuen (Norway) and Simon Stiell (Grenada);

(b) Response measures: Hussein Rasheed Hassan (Maldives) and Marc Vanheukelen (European Union);

(c) Scope of the next periodic review of the long-term global goal under the Convention and of overall progress towards achieving it: Ivan Vejar (Chile);

- (d) Report and terms of reference of the CGE: Eduardo Silva (Chile);
- (e) Gender and climate change: Mr. Garrido.

48. At the 8<sup>th</sup> meeting, the President recalled that the SBSTA and the SBI had been unable to conclude their consideration of the scope of the next periodic review of the long-term global goal and that the matter had been forwarded to the COP for further consideration.

49. On a proposal by the President, the COP adopted decision 5/CP.25, entitled "Scope of the second periodic review of the long-term global goal under the Convention and of overall progress towards achieving it". The President thanked Mr. Vejar for his hard work.<sup>31</sup>

### IV. Reporting from and review of Parties included in Annex I to the Convention

(Agenda item 4)

50. At its 1<sup>st</sup> meeting, the COP noted that this matter was on the agenda of the SBI.<sup>32</sup>

51. At its 7<sup>th</sup> meeting, on a recommendation of the SBI,<sup>33</sup> the COP adopted decision 6/CP.25, entitled "Revision of the UNFCCC reporting guidelines on national communications for Parties included in Annex I to the Convention".

52. On a proposal by the President, the COP took note of the SBI conclusions on this matter.<sup>34</sup>

# V. Reporting from Parties not included in Annex I to the Convention

(Agenda item 5)

53. At its 1<sup>st</sup> meeting, the COP noted that this matter was on the agenda of the SBI.<sup>35</sup>

54. At its 8<sup>th</sup> meeting, the President recalled that the SBI had been unable to conclude its consideration of the terms of reference of the CGE and that the matter had been forwarded to the COP for further guidance. The President thanked Mr. Silva for undertaking consultations on the matter on her behalf.

55. On a proposal by the President, the COP considered and adopted the conclusions in paragraph 56 below.

56. The COP requested that SBI 52 continue to review and revise the terms of reference of the CGE,<sup>36</sup> taking into account the informal note on the report and terms of reference of the CGE,<sup>37</sup> with a view to finalizing and recommending a draft decision on the matter for consideration and adoption at COP 26.

57. A representative of a Party speaking on behalf of the African Group, expressed concern, which was noted by the President, that agreement could not be reached on this matter and requested that its statement be reflected in the report on the session.<sup>38</sup>

58. The COP noted the nominations of members to the CGE.<sup>39</sup>

#### VI. Report of the Adaptation Committee

(Agenda item 6)

59. At its  $1^{st}$  meeting, the COP noted that this matter was on the agendas of the SBSTA and the SBI.<sup>40</sup>

60. At its 7<sup>th</sup> meeting, the President recalled that the SBSTA and the SBI had not completed their consideration of this matter at these sessions.

61. At the 8<sup>th</sup> meeting, the President noted that a nomination to the Adaptation Committee was outstanding and urged the constituencies to continue their consultations and to submit the outstanding nomination to the Executive Secretary as soon as possible and by 28 February 2020 at the latest. Once the nomination has been received by the Executive Secretary, the member will be deemed to have been elected at COP 25, in accordance with established practice.

## VII. Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts

(Agenda item 7)

63. At the 1<sup>st</sup> meeting, the COP noted that this matter was on the agendas of the SBSTA and the SBI.<sup>42</sup>

64. The President recalled that COP 24 had been invited to consider the matter of its authority over and guidance to the WIM, including its Executive Committee.<sup>43</sup>

65. The President proposed that Parties maintain the provisional approach adopted at COP 24, whereby the COP would continue to consider the outcomes of the consideration of the report of the Executive Committee and the output of the review of the WIM. She stated that this would be undertaken without prejudging the outcome of the consultations on the governance of the WIM. The President also proposed that a senior member of her delegation hold informal consultations on the matter of the authority of the COP over, and its guidance to, the WIM. The COP agreed to the approach outlined by the President.

66. A representative of one Party made a statement.<sup>44</sup>

67. At the resumed 8<sup>th</sup> meeting, on 15 December, the President informed the COP that consideration of the governance of the WIM had not concluded at this session and that COP 26 would continue the consideration of matters related to the governance of the WIM.

68. On a proposal by the President, the COP adopted decision 2/CP.25, entitled "Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts and its 2019 review", in which the COP notes the equally titled decision 2/CMA.2. The President thanked Mr. Elvestuen and Mr. Stiell for facilitating the discussions on the review of the WIM on her behalf.

69. A representative of a Party speaking on behalf of the Group of 77 and China, and Tuvalu stated that decision 2/CP.25 does not prejudge the outcomes of the discussions on the governance of the WIM. The President noted their concerns. The Parties requested that their statements be reflected in the report on the session.<sup>45</sup> A representative of another Party also made a statement.

73. On a proposal by the President, the COP established a contact group on this matter, co-chaired by Robert Moore (United Kingdom) and Richard Muyungi (United Republic of Tanzania).

74. At the resumed 8<sup>th</sup> meeting, the President thanked Mr. Moore and Mr. Muyungi for their hard work and noted that the COP had not completed its consideration of this matter at this session.

75. Statements were made by representatives of Parties on behalf of the African Group; the Arab Group; Argentina, Brazil and Uruguay; the European Union and its member States; and the LMDCs, and by representatives of a further 10 Parties. The African Group; Argentina, Brazil and Uruguay; and the LMDCs expressed their disappointment at the lack of an outcome on this matter and requested that their statements be reflected in the report on the session.<sup>50</sup>

Once the nominations have been received by the Executive Secretary, the members will be deemed to have been elected at COP 25, in accordance with established practice.

83. At its resumed 8<sup>th</sup> meeting, on a proposal by the President, the COP adopted decision 12/CP.25, entitled "Report of the Green Climate Fund to the Conference of the Parties and guidance to the Green Climate Fund". The President thanked Mr. Sugio and Mr. Yauvoli for their hard work.

# **D.** Report of the Global Environment Facility to the Conference of the Parties and guidance to the Global Environment Facility (Agenda sub-item 8(d))

84. At the 1<sup>st</sup> meeting, the President invited the COP to provide guidance to the GEF on policies, programme priorities and eligibility criteria taking into account the annual report of

(Agenda sub-item 14(b))

106. At the 1<sup>st</sup> meeting, the President recalled that this sub-item was held in abeyance at COP 24 and that, in accordance with rule 16 of the draft rules of procedure being applied, the matter was included in the provisional agenda for COP 25. The President proposed that a senior member of her delegation conduct informal consultations on the matter on her behalf.

107. At the 7<sup>th</sup> meeting, the President thanked Mr. Garrido for undertaking those consultations and noted that the COP had not completed its consideration of this matter at this session.

(Agenda item 15 *held in abeyance*)

### **XVI.** Administrative, financial and institutional matters (Agenda item 16)

- A. Audit report and financial statements for 2018 (Agenda sub-item 16(a))
- **B.** Budget performance for the biennium 2018–2019 (Agenda sub-item 16(b))

108. At its  $1^{st}$  meeting, the COP noted that the matters under sub-items 16(a-b) were on the agenda of the SBI.<sup>72</sup>

109. At its 7<sup>th</sup> meeting, on a recommendation of the SBI,<sup>73</sup> the COP adopted decision 18/CP.25, entitled "Administrative, financial and institutional matters".

#### C. Programme budget for the biennium 2020–2021

(Agenda sub-item 16(c))

110. At its 7<sup>th</sup> meeting, the COP took note of the draft decisions on the programme budget for the biennium 2020–2021 recommended at SBI 50<sup>74</sup> for adoption at COP 25.

111. On a proposal by the President, the COP adopted decision 17/CP.25, entitled "Programme budget for the biennium 2020–2021".

#### D. Decision-making in the UNFCCC process

(Agenda sub-item 16(d))

112. At the 1<sup>st</sup> meeting, the President recalled that the COP had not completed its consideration of this matter at COP 24 and therefore, in accordance with rule 10(c) of the draft rules of procedure being applied, the matter was included in the provisional agenda for COP 25.

113. The President proposed that a senior member of her delegation conduct informal consultations on the matter on her behalf.

114. At the 7<sup>th</sup> meeting, the President thanked Mr. Garrido for undertaking those consultations and noted that the COP had not completed its consideration of the matter at this session.

#### XVII. High-level segment

(Agenda item 17)

115. At the joint 3<sup>rd</sup> meetings of the COP, CMP 15 and CMA 2, on 10 December, the joint high-level segment of the three bodies was opened by the President, who made a statement. Statements were also made by Alejandro Sanz, a Spanish musician; Petteri Taalas, Secretary-

General of the World Meteorological Organization; Teresa Ribera, Spanish Minister for Ecological Transition; Patricia Espinosa, UNFCCC Executive Secretary; and Tijjani Muhammad-Bande, President of the United Nations General Assembly at its seventy-fourth session.<sup>75</sup>

116. At the first informal stocktaking plenary, the President appointed Ms. Ribera and Masagos Zulkifi (Singapore) to facilitate discussions on decision 1/CP.25.

117. At its 8<sup>th</sup> meeting, on a proposal by the President, the COP adopted decision 1/CP.25, entitled "Chile Madrid Time for Action". The President thanked Ms. Ribera and Mr. Zulkifi for their hard work.

118. Statements were made by representatives of Parties on behalf of the African Group, AILAC, the Environmental Integrity Group, the European Union and its member States, the least developed countries, and by representatives of a further 15 Parties.<sup>76</sup>

#### A. Statements by Parties

(Agenda sub-item 17(a))

119. During the high-level segment, 163 statements were delivered: 4 by Heads of State or Government, 2 by Deputy Prime Ministers, 3 on behalf of groups of Parties and 154 by ministers or representatives of Parties.<sup>77</sup>

120. Antigua and Barbuda, Brunei Darussalam, Jamaica and Liberia requested to have their statements posted on the UNFCCC website in lieu of oral delivery.<sup>78</sup>

#### **B.** Statements by observer organizations

(Agenda sub-item 17(b))

121. At the joint 4<sup>th</sup> meetings of the COP, CMP 15 and CMA 2, on 10 December, 28 statements were made by representatives of IGOs and NGOs.<sup>79</sup>

#### **XVIII.** Other matters

(Agenda item 18)

122. At its 8<sup>th</sup> meeting, the COP noted that no other matters had been raised under this agenda item.

#### XIX. Conclusion of the session

(Agenda item 19)

123. At the joint 9<sup>th</sup> meetings of the COP, CMP 15 and CMA 2, on 15 December, the President and representatives of groups of Parties and observer organizations made closing statements.

124. Statements were made by representatives of Parties on behalf of Argentina, Brazil and Uruguay; the African Group; the European Union and its member States; the Group of 77 and China; the Umbrella Group; Brazil, South Africa, India and China; the least developed countries; the LMDCs; AILAC; the Alliance of Small Island States; the Environmental Integrity Group and the Arab Group, and by representatives of a further three Parties. Some Parties provided written statements.<sup>80</sup>

125. Statements were also made by representatives of business and industry, environmental, research and independent, trade union, and youth NGOs, indigenous peoples organizations, and the women and gender constituency.

### A. Adoption of the draft report of the Conference of the Parties on its twenty-fifth session

(Agenda sub-item 19(a))

126. At its 10<sup>th</sup> meeting, on 15 December, the COP considered the draft report on this session<sup>81</sup> and, on a proposal by the President, authorized the Rapporteur to complete the report under the guidance of the President and with the assistance of the secretariat.

127. The Deputy Executive Secretary provided a preliminary estimate of the administrative and budgetary implications of some of the decisions adopted at this session, in accordance with rule 15 of the draft rules of procedure being applied.

128. The Deputy Executive Secretary informed Parties that several provisions contained in the decisions adopted by the COP, the CMP and the CMA at these sessions have resource implications beyond the requirements included in the budget for the biennium 2020–2021. EUR 2 million will be required to undertake activities, as follows:

(a) Under agenda sub-item 3(b), "Report of the Subsidiary Body for Implementation", EUR 60,000 will be required for preparing in 2020 a synthesis report on progress in implementing the Doha work programme on Article 6 of the Convention and Action for Climate Empowerment. (An information note presenting options for future work to enhance implementation of Article 6 of the Convention and Article 12 of the Paris Agreement will be covered by resources budgeted for the biennium 2020–2021.) This falls into the category of temporary or short-term activities,<sup>82</sup> which would be funded from voluntary contributions to the Trust Fund for Supplementary Activities;<sup>83</sup>

(b) Under agenda item 7, "Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts", EUR 550,000 will be required in the biennium 2020–2021 to organize meetings in conjunction with regional forums and support to the work of the WIM Executive Committee. These fall into the category of temporary or short-term activities;<sup>84</sup>

(c) Under agenda sub-item 8(a), "Long-term climate finance", EUR 50,000 will be required for preparing an update report for COP 26. This falls into the category of temporary or short-term activities;

(d) Under agenda item 9, "Development and transfer of technologies: joint annual report of the Technology Executive Committee and the Climate Technology Centre and Network", EUR 77,000 will be required in 2020 for an in-session technology day. This falls into the category of temporary or short-term activities;<sup>85</sup>

(e) Under agenda item 12, "Report of the forum on the impact of the implementation of response measures", EUR 860,000 will be required in the biennium 2020–2021 to operationalize the workplan of the forum on the impact of the implementation of response measures and its Katowice Committee of Experts on the Impacts of the Implementation of Response Measures. This falls into the category of temporary or short-term activities;<sup>86</sup>

(f) Under agenda item 13, "Gender and climate change", EUR 450,000 will be required in the biennium 2020–2021 for implementing the enhanced Lima work programme on gender and its gender action plan, which is in addition to requirements for gender-related work already included in the budget for the biennium 2020–2021 to be funded from supplementary resources. This falls mostly into the category of recurring or long-term activities, but partly into the category of temporary or short-term activities. Requirements for the long-term activities amount to EUR 350,000, for overseeing and supporting implementation of the intergovernmental process and engagement related to the work programme. Requirements for the short-term activities amount to EUR 100,000, for facilitating participation by delegates and experts in specific activities and supporting the preparation of communication products related to the work programme.

129. The Deputy Executive Secretary informed the COP that funding for these activities in the biennium 2020–2021 will be sought from voluntary contributions, and that resource requirements for 2022 and beyond resulting from decisions adopted at these sessions will be treated in line with the established budgetary process.

130. The Deputy Executive Secretary stated that the secretariat is relying on Parties' continued generosity in providing funding for these activities in a timely and predictable manner, as without such contributions the secretariat will not be able to undertake the requested activities. He noted that these amounts are preliminary and based on the information available at the time.

#### **B.** Closure of the session

(Agenda sub-item 19(b))

131. At its 10<sup>th</sup> meeting, on a proposal by a Party, the COP adopted resolution 1/CP.25, entitled "Expression of gratitude to the Government of the Republic of Chile, the Government of the Kingdom of Spain and the people of the city of Madrid".

132. The President then declared COP 25 closed.
