# الاتفاقية الإطارية بشأن تغير المناخ



## مؤتمر الأطراف

## قبول المراقبين: المنظمات المقدّمة لطلب الحصول على صفة مراقب

### مذكرة من الأمانة

- 1- يخضع قبول المنظمات الحكومية الدولية والمنظمات غير الحكومية بصفة مراقب في دورات مؤتمر الأطراف لأحكام الفقرة 6 من المادة 7 من الاتفاقية، التي تنص، في جملة أمور أخرى، على ما يلي:  
"ويجوز الموافقة على حضور أية هيئة أو وكالة، سواء كانت وطنية أو دولية، حكومية أو غير حكومية، ذات اختصاص في المسائل المشمولة بالاتفاقية، وتكون قد أبلغت الأمانة برغبتها في أن تكون ممثلة بصفة مراقب في إحدى دورات مؤتمر الأطراف ما لم يعترض على ذلك ثلث عدد الأطراف الحاضرين على الأقل".
- 2- وقد وافق مؤتمر الأطراف في دورته الأولى<sup>(1)</sup> على أن تدعو الأمانة لحضور الدورات المقبلة للمؤتمر ولهيئاته الفرعية جميع المنظمات الحكومية الدولية والمنظمات غير الحكومية التي تُقبل في الدورة الأولى لمؤتمر الأطراف وفي الدورات التالية، ما لم يُعترض على أي منظمة بعينها وفقاً للاتفاقية ولمشروع النظام الداخلي المعمول به<sup>(2)</sup>. وبناءً على ذلك، أُخطرت الأمانة، وفقاً للمادة 8 من مشروع النظام الداخلي المعمول به، جميع المنظمات التي أُقبلت في الدورات السابقة لمؤتمر الأطراف (باستثناء المنظمات التي أُقبلت لدورة واحدة فقط) بموعد ومكان انعقاد الدورة 28 لمؤتمر الأطراف، دون الحكم مسبقاً على المقررات التي قد يتخذها مؤتمر الأطراف. ولا ينطبق شرط تقديم طلب للقبول إلا على المنظمات المتقدمة بطلبات جديدة.
- 3- وأعدت الأمانة قائمة بالمنظمات الحكومية الدولية والمنظمات غير الحكومية التي قدمت طلبات جديدة (انظر المرفق الأول) تعرب فيها عن رغبتها في أن تمثل في دورات مؤتمر الأطراف وهيئاته الفرعية بصفة مراقب وتستوفي الشروط المبينة في (1) الاتفاقية و(2) مشروع النظام الداخلي المعمول به و(3) الممارسة المتبعة، كي ينظر فيها مؤتمر الأطراف.

4- ولدى إعداد القائمة، وضعت الأمانة في اعتبارها على النحو الواجب أحكام الفقرة 6 من المادة 7 من الاتفاقية والمادتين 7 و8 من مشروع النظام الداخلي المعمول به، وكذلك الممارسة المتبعة التي أحاطت الهيئة الفرعية للتنفيذ علماً بها<sup>(3)</sup>، والتي يُطلب بمقتضاها من المنظمات الحكومية الدولية والمنظمات غير الحكومية أن تقدم دليلاً على اختصاصها في المسائل المتصلة بالاتفاقية، وأن تؤكد شخصيتها القانونية المستقلة، وكونها منظمات لا تستهدف الربح و/أو معفاة من الضرائب في إحدى الدول الأعضاء في الأمم المتحدة، أو في إحدى وكالاتها المتخصصة، أو في الوكالة الدولية للطاقة الذرية، أو في إحدى الدول الأطراف في النظام الأساسي لمحكمة العدل الدولية.

5- ويقدم المرفق الثاني تفاصيل عن منطمتين مقبولتين بصفة مراقب غيرتا اسميهما بصورة قانونية منذ قبولهما بصفة مراقب في دورات مؤتمر الأطراف، نتيجة للاندماج مع منظمة أخرى أو للضم إلى المنظمة الأم التي تقدمت بطلب القبول. وفي كلتا الحالتين، طُلب من المنظمة الناتجة عن الاندماج أو الضم تقديم المعلومات المشار إليها في الفقرة 4 أعلاه تمشياً مع الممارسة المتبعة الأنفة الذكر، واعتُبرت مؤهلة للحصول على مركز المراقب باسمها الجديد.

6- وتلقى أعضاء المكتب قائمة بالمنظمات التي قدمت طلبات جديدة لاستعراضها، واتفقوا على توصية مؤتمر الأطراف بقبول المنظمات المدرجة في القائمة. وقد أُبلغت هذه المنظمات بأنها قُبلت مؤقتاً على أساس أن السلطة النهائية لقبولها بصفة مراقب تقع على عاتق مؤتمر الأطراف. ويُدعى مؤتمر الأطراف إلى أن يمنح، في الجلسة الأولى من دورته 28، مركز المراقب للمنظمات الحكومية الدولية والمنظمات غير الحكومية الواردة في المرفقين الأول والثاني.

7- وفيما يتعلق بالمادتين 6 و7 من مشروع النظام الداخلي المعمول به، سيُتبع مسار إجرائي واحد في قبول المنظمات بصفة مراقب لحضور دورات مؤتمر الأطراف ودورات مؤتمر الأطراف العامل بوصفه اجتماع الأطراف في بروتوكول كيوتو<sup>(4)</sup> ودورات مؤتمر الأطراف العامل بوصفه اجتماع الأطراف في اتفاق باريس<sup>(5)</sup>، على أن يكون مؤتمر الأطراف هو من يتخذ قرار قبول المنظمات بصفة مراقب أو عدم قبولها.
