The list of participants attending the twenty-eighth session of the Conference of the Parties, the eighteenth session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol, the fifth session of the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement and the fifty-ninth sessions of the subsidiary bodies has been prepared on the basis of information received by the secretariat as at Tuesday, 12 December 2023.

4. The Excel file on the UNFCCC website contains 12 worksheets; the corresponding statistics are reflected in table 1. For participants with multiple nominations by different nominators, the Excel file includes only the information from the last used badge, namely the last active badge. If a participant had no active badge, the information from the last printed badge was used.
