**Proposal by the President** 

**Draft decision -/CP.30** 

Joint annual report of the Executive Committee of the Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts and the Santiago network for averting, minimizing and addressing loss and damage associated with the adverse effects of climate change for 2024

The Conference of the Parties<sup>1</sup>

- 1. Endorses decision -/CMA.7,² on the joint annual report of the Executive Committee of the Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts and the Santiago network for averting, minimizing and addressing loss and damage associated with the adverse effects of climate change for 2024,³ which provides as follows:
  - "1. Reiterates its welcoming<sup>4</sup> of the progress of the Executive Committee of the Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts in implementing its rolling workplan for 2023–2027;<sup>5</sup>

- "2. Also reiterates its welcoming<sup>6</sup> of the progress of the Advisory Board and the interim secretariat of the Santiago network for averting, minimizing and addressing loss and damage associated with the adverse effects of climate change in operationalizing the Santiago network;
- "3. *Takes note* of the joint annual report of the Executive Committee of the Warsaw International Mechanism and the Santiago network for 2024,7 which also contains:
- (a) The report of the Executive Committee of the Warsaw International Mechanism, which includes recommendations from the Executive Committee;
- (b) The report of the Santiago network, which includes recommendations from the Advisory Board of the Santiago network.
- "4. *Notes* that considerations related to the governance of the Warsaw International Mechanism will continue at its eighth session (November 2026). 10"
- 2. *Notes* that considerations related to the governance of the Warsaw International Mechanism will continue at its thirty-first session (November 2026).<sup>11</sup>
