STATUS REPORT ON THE IN-DEPTH REVIEWS OF THIRD NATIONAL COMMUNICATIONS

Note by the secretariat

1. This note provides information on the status of submission of third national communications from Parties included in Annex I to the Convention (Annex I Parties) and on the reviews coordinated by the secretariat. In accordance with decision 11/CP.4 of the Conference of the Parties (COP),¹ third national communications should have been submitted to the secretariat by 30 November 2001. The COP, by its decision 33/CP.7,² requested the secretariat to apply the procedures for the review of third national communications, including in-depth reviews, as defined in decisions 2/CP.1³ and 6/CP.3.⁴

2. At the time of the preparation of this note the secretariat had received national communications from 34 Annex I Parties. Thirteen of these communications were submitted on or before the due date. All the national communications received have been posted on the secretariat web site.⁵

3. The secretariat started the in-depth reviews of third national communications in the first half of 2002. To date, 21 Parties have been visited by international teams of experts and more review visits are planned for the second half of 2003 and the first half of 2004.

4. The table below contains summary information on the status of submission of third national communications and on the dates of their review, and also notes tentative dates for forthcoming in-depth reviews.
