I. Opening of the session

(Agenda item 1)

1. The twenty-third session of the Subsidiary Body for Implementation (SBI) was held at the Palais des congrès de Montréal, Montreal, Canada, from 28 November to 6 December 2005.
2. The Chair of the SBI, Mr. Thomas Becker (Denmark), opened the session and welcomed all Parties and observers. He welcomed Mr. Heorhiy Veremiychuk (Ukraine), Vice-Chair of the SBI, and Mr. Emilio Sempis (Panama), Rapporteur of the SBI.

II. Organizational matters

(Agenda item 2)

A. Adoption of the agenda

(Agenda item 2 (a))

3. At its 1st meeting, on 28 November, the SBI considered a note by the Executive Secretary containing the provisional agenda and annotations (FCCC/SBI/2005/11). Statements were made by representatives of three Parties, including one speaking on behalf of the European Community and its member States.¹
4. At the same meeting, the SBI adopted the agenda as follows:

B. Organization of the work of the session

(Agenda item 2 (b))

5. The SBI considered this sub-item at its 1st meeting, on 28 November, at which the Chair drew attention to the proposed programme of work posted on the UNFCCC web site. On a proposal by the Chair, the SBI agreed to proceed on the basis of that programme of work.

C. Election of officers other than the Chair

(Agenda item 2 (c))

6. The SBI considered this sub-item at its 1st and 4th meetings, on 28 November and 6 December, respectively. At the 1st meeting, the Chair recalled rule 27 of the draft rules of procedure being applied, whereby the SBI is expected to elect its Vice-Chair and Rapporteur. Such an election was last held at the twenty-first session. The Chair informed the SBI that consultations on nominations were being undertaken and that he would keep delegates informed of progress. In the conduct of these consultations,

Parties were invited to recall decision 36/CP.7 and to give active consideration to the nomination of women for elective posts in the SBI.

7. At the 4th meeting, the Chair informed the SBI that agreement had been reached among the regional groups, and proposed the nominees for election. The SBI re-elected Mr. Heorhiy Veremiychyk² (Ukraine) as Vice-Chair and elected Ms. Gladys K. Ramothwa (Botswana) as Rapporteur. The Chair informed the meeting that the Vice-Chair will serve for a second and final term of one year, and the Rapporteur will serve for an initial term of one year which may be renewed for another year. The Chair noted that they will serve for the twenty-fourth and twenty-fifth sessions, and until their successors are elected. He thanked the current SBI Bureau for its work.

D. Election of replacement officers

(Agenda item 2 (d))

8. The elected Vice-Chair and Rapporteur represent Parties to both the Convention and the Kyoto Protocol. Therefore, no election of replacement officers was necessary.

III. National communications from Parties included in Annex I to the Convention

(Agenda item 3)

A. Options for the review process

(Agenda item 3 (a))

9. The SBI considered this sub-item at its 1st and 4th meetings, on 28 November and 6 December, respectively. It had before it document FCCC/SBI/2005/16. Statements were made by representatives of four Parties, including one speaking on behalf of the European Community and its member States.³

10. At its 1st meeting, the SBI agreed to consider this sub-item in a contact group co-chaired by Ms. Emily Ojoo-Massawa (Kenya) and Mr. Dimitrios Lalas (Greece). At the 4th meeting, the co-chairs reported on the contact group's consultations.

11. At its 4th meeting, the SBI considered and adopted conclusions,⁴ proposed by the Chair, containing a draft decision⁵ on this subject for adoption by the Conference of the Parties (COP) at its eleventh session.

12. At the same meeting, the SBI considered and adopted conclusions,⁶ proposed by the Chair, containing a draft decision⁷ on this subject for adoption by the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (COP/MOP) at its first session.

B. Report on national greenhouse gas inventory data from Parties included in Annex I to the Convention for the period 1990–2003

(Agenda item 3 (b))

13. The SBI considered this sub-item at its 1st meeting, on 28 November. It had before it document FCCC/SBI/2005/17 of which it took note. Statements were made by representatives of four Parties.

C. Status report on the review of third national communications

(Agenda item 3 (c))

14. The SBI considered this sub-item at its 1st meeting, on 28 November. It had before it document FCCC/SBI/2005/INF.9 of which it took note.

IV. National communications from Parties not included in Annex I to the Convention

(Agenda item 4)

A. Work of the Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention

(Agenda item 4 (a))

1. Proceedings

15. The SBI considered this sub-item at its 1st and 4th meetings, on 28 November and 6 December, respectively. It had before it document FCCC/SBI/2005/22 and Corr.1. Statements were made by representatives of 11 Parties, including one speaking on behalf of the least developed countries.

16. At the 1st meeting, the Chair invited Ms. Emily Ojoo-Massawa (Kenya), Chair of the Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention (CGE), to report on the activities of the group.

17. At the same meeting, the Chair acknowledged the nomination of Mr. M. Asaduzzaman (Bangladesh) as the in-coming Chair of the CGE and Ms. Lilian Portillo (Paraguay) as the new Rapporteur of the group.

18. At the same meeting, the SBI agreed to consider this sub-item together with sub-items 4 (b) and (c) in informal consultations convened by Mr. La'avasa Malua (Samoa). At the 4th meeting, Mr. Malua reported on these consultations.

19. At the same meeting, the Chair informed the SBI that the membership of the CGE for 2006 was now complete (see annex II).

20. At the same meeting, the Chair expressed his appreciation to the Government of South Africa for its offer to host the CGE hands-on training workshop on greenhouse gas inventories for the Africa region.

21. At its 4th meeting, the SBI considered and adopted conclusions⁸ proposed by the Chair.

2. Conclusions

22. The SBI took note of the oral report presented by the Chair of the CGE on the outcomes of the fifth meeting of the group, held in Montreal, Canada, on 24 and 25 November 2005, and welcomed the progress report on the activities of the CGE prepared by the secretariat (FCCC/SBI/2005/22 and Corr.1).

23. The SBI noted the outcomes of the global hands-on training workshop on mitigation assessments, held in Seoul, Republic of Korea, from 26 to 30 September 2005, and expressed its appreciation to the Government of the Republic of Korea for the financial and logistical support that it provided to the workshop through the Korea Energy Economics Institute.

24. The SBI expressed its gratitude to the Governments of Australia, Canada, Finland, Norway, Sweden, Switzerland and the United States of America for their financial contributions to the development of training materials and for supporting the participation of developing country experts at the global hands-on training workshop on mitigation assessments.
25. The SBI noted the recommendation of the participants to the workshop for further technical support in the use of various tools and methodologies in the conduct of mitigation assessments, and requested the CGE to provide advice so that related follow-up actions on training be country-driven.
26. The SBI endorsed the planned activities of the CGE for 2006 relating to the hands-on training workshops and further technical assistance to Parties not included in Annex I to the Convention (non-Annex I Parties) to continue improving the process of preparation of their national communications. It requested the CGE, in collaboration with the Least Developed Countries Expert Group (LEG), to advise Parties on how to integrate information contained in national adaptation programmes of action into second and subsequent national communications.
27. Based on the lessons learned in conducting the hands-on training workshops to date, the SBI encouraged the CGE to develop a cost-effective and comprehensive training strategy and other technical support, such as local training and networking of experts, to assist non-Annex I Parties in preparing their national communications in cooperation with the Global Environment Facility (GEF)-funded National Communications Support Programme (NCSP) of the United Nations Development Programme/United Nations Environment Programme (UNEP), and with other relevant organizations.
28. The SBI encouraged the CGE to continue its collaboration with the Expert Group on Technology Transfer and the LEG in the implementation of its work programme. It requested the secretariat to continue to facilitate the collaboration between the CGE and the NCSP, and other multilateral and bilateral organizations, in the provision of technical support to non-Annex I Parties in the preparation of their national communications.
29. The SBI requested the CGE to make recommendations on ways to improve the reporting of projects identified in national communications from non-Annex I Parties in accordance with Article 12, paragraph 4, of the Convention, and to report to, and advise, the SBI, at its twenty-sixth session (May 2007), on ways to improve access to financial and technical support for such projects.
30. The SBI invited Parties to provide information to the secretariat on existing activities and programmes, including those of bilateral and multilateral funding sources, to enable the CGE to report to the SBI at its twenty-fifth session (November 2006) on ways to improve access to financial and technical support provided for the preparation of national communications. The SBI concluded that it will consider this report under the agenda item on provision of financial and technical support at the same session.
31. The SBI looked forward to receiving the report on the examination of 41 initial national communications of non-Annex I Parties, including recommendations on how to improve the preparation of second and, where appropriate, subsequent national communications, that the CGE will present at SBI 24 (May 2006). It requested the CGE, in preparing this report, to consider the sixth compilation and synthesis of initial national communications of non-Annex I Parties, contained in document FCCC/SBI/2005/18 and Add.1-6 and Add.3/Corr.1.
32. The SBI took note of the plans by the CGE to organize hands-on training workshops on vulnerability and adaptation assessments for the Asia and the Pacific and the Latin America and the Caribbean regions, and a hands-on training workshop on national greenhouse gas inventories for the Africa region, in 2006. It thanked the Governments of Indonesia and Paraguay for their offers to host the regional workshops on vulnerability and adaptation assessments.

33. The SBI noted that only part of the resources required for the above-mentioned workshops has been raised so far and urged Parties to provide additional resources in order to organize these events. The SBI invited Parties included in Annex II to the Convention (Annex II Parties) and other Parties included in Annex I to the Convention (Annex I Parties) in a position to do so, to provide financial resources for these workshops and for the implementation of the work programme of the CGE.

B. Compilation and synthesis of initial national communications

(Agenda item 4 (b))

1. Proceedings

34. The SBI considered this sub-item at its 1st and 4th meetings, on 28 November and 6 December, respectively (see paragraph 18 above). It had before it document FCCC/SBI/2005/18 and Add.1-6 and Add.3/Corr.1. Statements were made by representatives of three Parties, including one speaking on behalf of the European Community and its member States,⁹ and one on behalf of the least developed countries.

35. At its 4th meeting, the SBI considered and adopted conclusions¹⁰ proposed by the Chair.

2. Conclusions

36. The SBI took note of the sixth compilation and synthesis of initial national communications from non-Annex I Parties contained in document FCCC/SBI/2005/18 and Add.1-6 and Add.3/Corr.1.

37. The SBI noted that, based on the information contained in the above-mentioned document, non-Annex I Parties are continuing to fulfil their commitments under Article 4, paragraph 1, and Article 12, paragraph 1, of the Convention.

38. The SBI invited Parties to submit to the secretariat, by 13 February 2006, their views on the above-mentioned document for compilation in a miscellaneous document.

39. The SBI concluded it will consider the sixth compilation and synthesis of initial national communications from non-Annex I Parties and the above-mentioned miscellaneous document at its twenty-fourth session (May 2006) with a possibility of preparing a draft decision on this matter for adoption by the Conference of the Parties at its twelfth session (November 2006).

40. The SBI noted its request under agenda item 4 (a) to the CGE, relating to the CGE's examination of initial national communications, to consider the information contained in document FCCC/SBI/2005/18 and Add.1-6 and Add.3/Corr.1 and in the miscellaneous document referred to in paragraph 38.

41. The SBI welcomed the progress made by non-Annex I Parties in the preparation of their national communications, as reflected in document FCCC/SBI/2005/18 and Add.1-6 and Add.3/Corr.1, and noted with satisfaction that 129 non-Annex I Parties had so far submitted their initial national communications. The SBI encouraged those Parties that have yet to submit their initial national communications to do so as soon as possible.

C. Provision of financial and technical support

(Agenda item 4 (c))

1. Proceedings

42. The SBI considered this sub-item at its 1st and 4th meetings, on 28 November and 6 December, respectively (see paragraph 18 above). It had before it document FCCC/SBI/2005/INF.8. Statements were made by representatives of two Parties, including one speaking on behalf of the Group of 77 and China.

43. At its 4th meeting, the SBI considered and adopted conclusions¹¹ proposed by the Chair.

2. Conclusions

44. The SBI considered document FCCC/SBI/2005/INF.8 containing a list of projects identified in national communications by non-Annex I Parties in accordance with Article 12, paragraph 4, of the Convention.

45. The SBI noted its request under agenda item 4 (a) to the CGE to make recommendations on ways to improve the reporting of projects identified in national communications in accordance with Article 12, paragraph 4, of the Convention; to report on ways to improve access to financial and technical support for such projects; and to advise the SBI on this matter at its twenty-sixth session (May 2007).

46. The SBI invited bilateral and multilateral assistance programmes to provide support to non-Annex I Parties in formulating and developing project proposals identified in their national communications in accordance with Article 12, paragraph 4, of the Convention, and in their subsequent implementation.

47. The SBI encouraged non-Annex I Parties to submit their project proposals to the GEF through its implementing agencies, and to bilateral and multilateral assistance programmes, for timely funding.

V. Financial mechanism (Convention)

(Agenda item 5)

A. Special Climate Change Fund

(Agenda item 5 (a))

48. The SBI considered this sub-item at its 2nd and 4th meetings, on 29 November and 6 December, respectively. It had before it the draft text contained in document FCCC/SBI/2005/10, annex I. Statements were made by representatives of six Parties, including one speaking on behalf of the European Community and its member States,¹² and one on behalf of the Group of 77 and China.

49. At its 2nd meeting, the SBI agreed to consider this sub-item together with sub-items 5 (b), (c) and (d) in a contact group co-chaired by Mr. Rawleston Moore (Barbados) and Mr. Karsten Sach (Germany). At the 4th meeting, Mr. Sach reported on the contact group's consultations.

50. At its 4th meeting, the SBI considered draft conclusions^{13,14} proposed by the Chair. The SBI did not adopt these proposals and decided to continue its consideration of the Special Climate Change Fund at

its twenty-fourth session (May 2006) on the basis of the draft text contained in document FCCC/SBI/2005/10, annex I.

B. Report of the Global Environment Facility to the Conference of the Parties
(Agenda item 5 (b))

51. The SBI considered this sub-item at its 2nd and 4th meetings, on 29 November and 6 December, respectively (see paragraph 49 above). It had before it document FCCC/CP/2005/3 and Corr.1. Statements were made by representatives of 18 Parties, including one speaking on behalf of the Group of 77 and China, one on behalf of the least developed countries, one on behalf of the Alliance of Small Island States (AOSIS), and one on behalf of the European Community and its member States.¹⁵

52. At the 2nd meeting, the Chair invited the representative of the GEF secretariat to make a statement.

53. At its 4th meeting, the SBI considered and adopted conclusions¹⁶ proposed by the Chair for adoption by the COP at its eleventh session.¹⁷

C. Matters relating to the implementation of decision 5/CP.8
(Agenda item 5 (c))

1. Proceedings

54. The SBI considered this sub-item at its 2nd and 4th meetings, on 29 November and 6 December, respectively (see paragraph 49 above). It had before it document FCCC/SBI/2005/INF.7. A statement was made by the representative of one Party speaking on behalf of the Group of 77 and China.

55. At its 4th meeting, the SBI considered and adopted conclusions¹⁸ proposed by the Chair.

2. Conclusions

56. The SBI noted with appreciation the report on the experience of international funds and multilateral financial institutions relevant to the investment needs of developing countries for the purposes of fulfilling their commitments under the Convention (FCCC/SBI/2005/INF.7), prepared by the secretariat according to decision 9/CP.10.

57. The SBI agreed to use this report at its twenty-fourth session (May 2006), together with the report on the assessment of funding necessary to assist developing countries in fulfilling their commitments under the Convention (FCCC/SBI/2004/18), prepared in the context of the Memorandum of Understanding between the COP and the Council of the GEF by the secretariat in collaboration with the secretariat of the GEF, as an input to the consideration by the SBI of the third review of the financial mechanism, and to report on the outcome of that consideration to the COP at its twelfth session (November 2006).

D. Additional guidance to the Global Environment Facility

(Agenda item 5 (d))

58. The SBI considered this sub-item at its 2nd and 4th meetings, on 29 November and 6 December, respectively (see paragraph 49 above). No document was prepared for this sub-item. A submission was received from the Group of 77 and China; this can be found in document FCCC/SBI/2005/CRP.3. A statement was made by the representative of one Party speaking on behalf of the Group of 77 and China.

59. At its 4th meeting, the SBI considered and adopted conclusions,¹⁹ proposed by the Chair, containing a draft decision²⁰ on this subject for adoption by the COP at its eleventh session.

VI. Financial mechanism (Kyoto Protocol)

(Agenda item 6)

A. Adaptation Fund

(Agenda item 6 (a))

60. The SBI considered this sub-item at its 3rd and 4th meetings, on 29 November and 6 December, respectively. It had before it document FCCC/SBI/2005/19. Statements were made by representatives of eight Parties, including one speaking on behalf of the Group of 77 and China, one on behalf of AOSIS, one on behalf of the least developed countries and one on behalf of the European Community and its member States.²¹

61. At its 3rd meeting, the SBI agreed to consider this sub-item together with sub-item 6 (b) in a contact group co-chaired by Mr. Rawlestone Moore (Barbados) and Mr. Karsten Sach (Germany). At the 4th meeting, Mr. Moore reported on the contact group's consultations.

62. Submissions were received from the Group of 77 and China, and from the European Community and its member States; these can be found in documents FCCC/SBI/2005/CRP.1, and FCCC/SBI/2005/CRP.2.

63. At its 4th meeting, the SBI considered and adopted conclusions,²² proposed by the Chair, containing a draft decision²³ on this subject for adoption by the COP/MOP at its first session.

64. At the same meeting, the Chair expressed his appreciation to the Government of Canada for its offer to host the Adaptation Fund workshop in 2006.

B. Guidance to the Global Environment Facility

(Agenda item 6 (b))

65. The SBI considered this sub-item at its 3rd and 4th meetings, on 29 November and 6 December, respectively (see paragraph 61 above). No document was prepared for this sub-item. However, it was decided to consider document FCCC/SBI/2005/19 under this sub-item rather than under sub-item 6 (a). Statements were made by representatives of two Parties, including one speaking on behalf of the Group of 77 and China.

66. At its 4th meeting, the SBI considered draft conclusions,²⁴ proposed by the Chair, containing a draft decision for adoption by the COP/MOP at its first session. The SBI decided to continue its consideration of the application of the memorandum of understanding between the COP and the Council of the GEF at its twenty-fourth session (May 2006), on the basis of the draft text contained in annex I to this report.

VII. Article 6 of the Convention

(Agenda item 7)

1. Proceedings

67. The SBI considered this item at its 1st and 4th meetings, on 28 November and 6 December, respectively. It had before it documents FCCC/SBI/2005/14 and FCCC/SBI/2005/21. Statements were made by representatives of two Parties, including one speaking on behalf of the European Community and its member States.²⁵

68. At the 1st meeting, the Chair invited the Director General of the Malaysian Meteorological Service Department to report on the Asia and the Pacific regional workshop held in Yokohama, Japan, from 13 to 15 September 2005.

69. At the same meeting, the Chair also invited the representative of UNEP to inform Parties of UNEP's work in support of Article 6 of the Convention.

70. At the same meeting, the SBI agreed to consider this item in a contact group chaired by Mr. Crispin D'Auvergne (Saint Lucia).

71. At its 4th meeting, the SBI considered and adopted conclusions²⁶ proposed by the Chair.

2. Conclusions

72. The SBI took note of the reports on the regional workshops for the Asia and the Pacific (FCCC/SBI/2005/21) and the Latin America and the Caribbean (FCCC/SBI/2005/14) regions. It expressed its gratitude to the Governments of Japan and Uruguay for hosting the workshops and to the Governments of Australia, Japan, New Zealand, Switzerland and the United States of America, and to UNEP, for providing financial and technical support.

73. The SBI welcomed the progress made by Parties, in the four regions in which workshops have been held to date, in implementing activities relating to Article 6 of the Convention and the New Delhi work programme on Article 6 of the Convention. It noted their desire to develop regional strategies for the six pillars of Article 6 of the Convention (education, training, public awareness, public participation, access to information and international cooperation).

74. The SBI also noted that the financial resources made available through various means, such as for national communications and other enabling activities, and for implementing the New Delhi work programme, were not commensurate with the needs and concerns identified by Parties. The SBI urged Annex II Parties, other Annex I Parties in a position to do so, and the GEF and other bilateral and multilateral agencies, to continue to support financially the implementation of activities relating to Article 6 of the Convention.

75. The SBI welcomed the launch of the prototype information network clearing house (CC:iNet) for Article 6 of the Convention at its twenty-third session and thanked the Governments of France, the United Kingdom of Great Britain and Northern Ireland and the United States of America for their financial support to this project. The SBI noted that funding is currently available for the clearing house and its operation only until mid-2006. The SBI also acknowledged the offers by several entities to serve as possible regional nodes. The SBI noted that the clearing house was one of many tools for promoting the further implementation of Article 6. The SBI urged governments, intergovernmental organizations and non-governmental organizations in a position to do so to contribute to the success of the clearing house by populating it with relevant information and documents. The SBI also called on Parties and organizations to promote, where possible, wider awareness of the clearing house, for example, by creating links to it from their own web sites.

76. The SBI noted that five countries have established Article 6 focal points. The SBI further encouraged those Parties that have not done so to appoint Article 6 focal points and to inform the secretariat accordingly. The SBI further urged Parties and institutions in a position to do so to strengthen focal points in order to promote activities relating to Article 6.

77. The SBI also requested Parties to submit to the secretariat, by 4 August 2006, their views on advancing work on the clearing house and on making it fully functional, multilingual and user-friendly, and requested the secretariat to compile these views into a miscellaneous document for consideration by the SBI at its twenty-fifth session (November 2006).

78. The SBI requested the secretariat to prepare a synthesis report, based on the reports of the workshops, highlighting common themes and issues as a way of providing broader insights into the results of the workshops, for consideration at its twenty-fifth session.

79. The SBI reiterated the need for a workshop on Article 6 to address the particular needs of small island developing States (FCCC/SBI/2004/19, para. 65) and requested the secretariat, subject to the availability of resources, to organize such a workshop before SBI 25. The SBI called on Parties in a position to do so to provide financial support for conducting this workshop.

80. The SBI noted that the information contained in the submissions mentioned in paragraph 77 and the synthesis report mentioned in paragraph 78, together with other continuing submissions on the work of Parties on Article 6, could be used by Parties in the review of the New Delhi work programme, in accordance with decision 11/CP.8, paragraph 3.

VIII. Capacity-building under the Convention

(Agenda item 8)

1. Proceedings

81. The SBI considered this item at its 1st, 2nd and 4th meetings, on 28 and 29 November and 6 December, respectively. No document was prepared for this agenda item. However, Parties decided to also consider document FCCC/CP/2005/3 and Corr.1 under this agenda item. Statements were made by representatives of five Parties, including one speaking on behalf of the European Community and its member States,²⁷ and one on behalf of the Group of 77 and China.

82. At its 2nd meeting, the SBI agreed to consider this item in a contact group co-chaired by Ms. Joyceline Goco (Philippines) and Mr. Anders Turesson (Sweden). At the 4th meeting, the co-chairs reported on the contact group's consultations.

83. At its 4th meeting, the SBI considered and adopted conclusions²⁸ proposed by the Chair.

2. Conclusions

84. The SBI reiterated the importance of capacity-building for developing countries as a critical element in the implementation of the Convention.

85. The SBI welcomed and considered the report of the GEF (FCCC/CP/2005/3 and Corr.1), specifically the sections on capacity-building, and acknowledged the compilation and synthesis of initial national communications from Parties not included in Annex I to the Convention (FCCC/SBI/2005/18 and Add.1–6 and Add.3/Corr.1).

86. The SBI reiterated the following requests to the secretariat:

- (a) To provide reports to the COP, at each of its sessions, on activities to implement the framework for capacity-building as set out in decision 2/CP.7, paragraph 9
- (b) To disseminate, in cooperation with the GEF and its implementing agencies, an information document on best practices and lessons learned in capacity-building projects and programmes, and to facilitate its publication through the UNFCCC web site, consistent with decision 2/CP.10
- (c) To report on the progress of the GEF in developing capacity-building performance indicators, consistent with decision 4/CP.9.

87. The SBI reiterated that capacity-building activities undertaken by the GEF should be guided by decisions 2/CP.7 and 2/CP.10 and emphasized that the response of the GEF to the framework for capacity-building as set out in decision 2/CP.7 should be provided in a timely manner. The SBI noted with appreciation that 153 countries were engaged in the national capacity self-assessments (NCSAs) as at September 2005, but noted that some countries were not yet engaged in this process and encouraged the GEF to continue to provide the required financial resources to ensure that the remaining eligible developing countries are engaged in the NCSAs by SBI 24 (May 2006).

88. The SBI welcomed the GEF country programme for the least developed countries (LDCs) and small island developing States (SIDS) and agreed that it should be guided by decision 2/CP.7, annex, paragraph 15. The SBI noted that each country programme will be a medium-sized project at the national level following small grants procedures to expedite the implementation of capacity-building activities in LDCs and SIDS.

89. The SBI concluded that these conclusions and the submissions by the Parties in accordance with decision 2/CP.10, which may include views on relevant approaches and strategic issues, will be considered in the future monitoring and review of the framework for capacity-building.

IX. Capacity-building under the Kyoto Protocol

(Agenda item 9)

90. The SBI considered this item at its 3rd and 4th meetings, on 29 November and 6 December, respectively. It had before it documents FCCC/SBI/2005/MISC.3 and Add.1. Statements were made by representatives of two Parties, including one speaking on behalf of the Group of 77 and China.

91. At its 3rd meeting, the SBI agreed to consider this item in a contact group co-chaired by Ms. Joyceline Goco (Philippines) and Mr. Anders Turesson (Sweden). At the 4th meeting, Mr. Turesson reported on the contact group's consultations.

92. At the same meeting, the SBI considered and adopted conclusions,^{29,30} proposed by the Chair, containing draft decisions^{31,32} on this subject for adoption by the COP/MOP at its first session.

X. Implementation of Article 4, paragraphs 8 and 9, of the Convention (Agenda item 10)

A. Buenos Aires programme of work on adaptation and response measures (decision 1/CP.10) (Agenda item 10 (a))

93. The SBI considered this sub-item at its 2nd meeting, on 29 November. No document was prepared for this sub-item. The views of the Government of Saudi Arabia on the pre-sessional expert meeting on response measures, held prior to SBI 23, and on the upcoming pre-sessional expert meeting on economic diversification, to be held prior to SBI 24, incorporating their statement by reference, can be found in document FCCC/SBI/2005/MISC.4. Statements were made by representatives of nine Parties, including one speaking on behalf of the European Community and its member States,³³ one on behalf of the least developed countries and one on behalf of AOSIS. The SBI took note of these statements.

B. Matters relating to the least developed countries (Agenda item 10 (b))

94. The SBI considered this sub-item at its 2nd and 4th meetings, on 29 November and 6 December, respectively. It had before it documents FCCC/SBI/2005/12, FCCC/SBI/2005/20, FCCC/TP/2005/2, FCCC/TP/2005/3, FCCC/TP/2005/4 and FCCC/TP/2005/5. Statements were made by representatives of three Parties, including one speaking on behalf of the least developed countries and one on behalf of the European Community and its member States.³⁴

95. At the 2nd meeting, the Chair invited Mr. Paul Desanker (Malawi), Chair of the LEG, to report on progress in the implementation of the LEG programme of work.

96. At the same meeting, the SBI agreed to consider this sub-item in a contact group co-chaired by Ms. Dechen Tsering (Bhutan) and Ms. Aloisia Wörgetter (Austria). At the 4th meeting, Ms. Tsering reported on the contact group's consultations.

97. At its 4th meeting, the SBI considered and adopted conclusions,³⁵ proposed by the Chair, containing a draft decision³⁶ on this subject for adoption by the COP at its eleventh session.

(Agenda item 11)

1. Proceedings

98. The SBI considered this sub-item at its 3rd and 4th meetings, on 29 November and 6 December, respectively. It had before it documents FCCC/SBI/2005/13 and FCCC/SBI/2005/INF.10 and the draft text contained in document FCCC/SBI/2005/10, annex II.

99. At its 4th meeting, the SBI considered and adopted conclusions^{37,38} proposed by the Chair.

2. Conclusions

Convention

100. The SBI took note of the report on budget performance under the Convention for the biennium 2004–2005 as at 30 June 2005 (FCCC/SBI/2005/13).

101. The SBI also took note of the status of contributions, as at 31 October 2005, reported in document FCCC/SBI/2005/INF.10, and expressed its appreciation to the Parties that had paid their contributions to the core budget of the Convention in a timely manner, and particularly to those Parties that had made voluntary contributions to the Trust Fund for Participation in the UNFCCC Process and the Trust Fund for Supplementary Activities. It also urged Parties that had not yet made their contributions to do so as soon as possible.

102. The SBI agreed to recommend a draft decision on administrative and financial matters (FCCC/SBI/2005/L.21/Add.1)³⁹ for adoption by the COP at its eleventh session.

Kyoto Protocol

103. The SBI took note of the report on budget performance for the biennium 2004–2005 as at 30 June 2005 (FCCC/SBI/2005/13).

104. The SBI also took note of the status of contributions as at 31 October 2005, reported in document FCCC/SBI/2005/INF.10, and expressed its appreciation to the Parties that had paid their contributions to the Kyoto Protocol Interim Allocation (KPIA) in a timely manner, and particularly to those Parties that had made voluntary contributions to the Trust Fund for Participation in the UNFCCC Process and the Trust Fund for Supplementary Activities. It also urged Parties that had not yet made their contributions to the KPIA to do so as soon as possible.

105. The SBI agreed to recommend a draft decision on administrative and financial matters (FCCC/SBI/2005/L.22/Add.1)⁴⁰ for adoption by the COP/MOP at its first session.

109. At its 4th meeting, the SBI considered and adopted conclusions,⁴² proposed by the Chair, containing a draft decision⁴³ on this subject for adoption by the COP at its eleventh session.

D. Privileges and immunities for individuals serving on constituted bodies established under the Kyoto Protocol

(Agenda item 11 (d))

110. The SBI considered this sub-item at its 3rd and 4th meetings, on 29 November and 6 December, respectively. It had before it document FCCC/KP/CMP/2005/6. Statements were made by representatives of two Parties, including one speaking on behalf of the European Community and its member States.

111. At its 3rd meeting, the SBI agreed to consider this sub-item in a contact group chaired by Mr. Masao Nakayama (Micronesia). At the 4th meeting, Mr. Nakayama reported on the contact group's consultations.

112. At its 4th meeting, the SBI considered and adopted conclusions,⁴⁴ proposed by the Chair, containing a draft decision⁴⁵ on this subject for adoption by the COP/MOP at its first session.

XII. Continuing review of the functions and operations of the secretariat

(Agenda item 12)

1. Proceedings

113. The SBI considered this item at its 3rd and 4th meetings, on 29 November and 6 December, respectively.

114. At its 4th meeting, the SBI considered and adopted conclusions⁴⁶ proposed by the Chair.

XV. Closure of the session

121. At the 4th meeting, on 6 December, the Chair thanked delegates, the chairs of contact groups and convenors of informal consultations for their contributions. He also thanked the secretariat for its support.
