**Public holiday**

<PlugNplay> and <Wireless> network services Internet (PlugNplay and wireless) network services are available to participants throughout the conference. Services are available in two categories. There is no need to make any changes to your system in either case.

Category #1: loose network (nodes) cables placed at specific locations in the media and computer centres. To use this service, simply plug the cable into your PC or laptop. Category #2: WiFi (Wireless fidelity) network services throughout the conference facility. To use this service, you need a computer equipped with a wireless network component. The wireless network is identified by the name PlugNplay. Choose the PlugNplay point with the highest percentage availability for better service. No changes need to be made to your system to take advantage of this service.

The PlugNplay network is open with no restrictions or protection. In order to remain safe, please follow these best practice tips:

- Install and/or update your ANTIVIRUS software.
- Activate your PERSONAL FIREWALL if your computer has the software installed. WindowsXP users should activate the WINDOWS FIREWALL feature.
- Assign your computer a suitable name e.g. your organization, company or delegation.
