**ROUND TABLE ON ANALYSIS OF THE MEANS AVAILABLE TO ANNEX I PARTIES TO REACH THEIR EMISSION REDUCTION OBJECTIVES (KP AWG 5.2)**

Although it is difficult at this time to assess what should be addressed by the roundtable at KP AWG 5.2, Canada believes that it should at minimum cover aspects of sources/sectors not covered by the workshop at KP AWG 5.1, and it should focus on possible approaches to reducing sectoral emissions. Parties as well as expert organizations including the OECD/IEA Annex I Experts Group, the Centre for Clean Air Policy, the World Business Council for Sustainable Development, Resources for the Future, the Pew Center on Global Climate Change and the World Resources Institute should be invited to participate in the roundtable. As noted above, Canada would be pleased to consider making a presentation at this roundtable.

Outcomes of the in-session workshop at KP AWG 5.1 should be taken into consideration in determining the organization of the roundtable as well as the topics to be covered. The outcomes of the roundtable should feed into and inform the ongoing work of the sub-group on LULUCF at KP AWG 5.2.

In conclusion, Canada looks forward to participating actively in the processes of the Bali Road Map and to working constructively with other Parties as we develop a more effective international framework to address climate change and determine our respective contributions to that framework by 2009.

**Table ronde sur l'analyse des moyens offerts aux Parties visées à l'annexe I pour atteindre leurs objectifs de réduction des émissions (GTS – PK 5.2)**

Bien qu'il soit difficile à ce stade-ci d'évaluer ce dont la table ronde devrait traiter au GTS – PK 5.2, le Canada estime qu'elle devrait à tout le moins parler des aspects des sources/secteurs qui n'ont pas été abordés par l'atelier au GTS – PK 5.1, et qu'elle devrait se concentrer sur les approches possibles à la réduction des émissions sectorielles. Les Parties, de même que des experts et des organismes, dont le groupe d'experts de l'OECD/IEA Annexe I, le Center for Clean Air Policy, le World Business Council for Sustainable Development, le Resources for the Future, le Pew Center on Global Climate Change et le World Resources Institute devraient être invités à participer cette table ronde. Comme nous le mentionnions plus tôt, le Canada serait heureux de faire une présentation à cette table ronde.

Les conclusions de l'atelier de session au GTS – PK 5.1 devraient servir à déterminer l'organisation de la table ronde ainsi que les thèmes qui devront y être traités. Les conclusions de la table ronde devraient être transmises au sous-groupe sur l'UTCATF au GTS – PK 5.2.

En terminant, le Canada se réjouit de prendre une part active dans les processus de la feuille de route de Bali et de collaborer de façon constructive avec les autres Parties au développement d'un cadre international plus efficace afin de s'attaquer aux changements climatiques et de définir nos contributions respectives à cet égard d'ici 2009.
