接纳观察员：申请接纳为观察员的组织

## 秘书处的说明

1. 接纳政府间组织和非政府组织为缔约方会议届会的观察员，须依照《公约》第七条第6款的规定，该条除其他外规定，“任何在本公约所涉事项上具备资格的团体或机构，不管其为国家或国际的、政府或非政府的，经通知秘书处其愿意作为观察员出席缔约方会议的某届会议，均可予以接纳，除非出席的缔约方至少三分之二反对”。

2. 缔约方会议第一届会议商定，秘书处应邀请本届和今后各届会议所接纳的各政府间组织和非政府组织参加缔约方会议及其附属机构今后的各届会议，但根据《公约》和议事规则草案受到反对的任何特定组织除外<sup>1</sup>。因此，缔约方会议前几

届会议所接纳的所有组织(仅准许参加缔约方会议某一届会议的组织除外)，均已被邀请参加第十四届会议，但这不影响缔约方会议可能做出的决定。只是新申请参加届会的组织需经过接纳程序。

3. 秘书处编写了一份新的申请希望参加缔约方会议第十四届会议的政府间组织和非政府组织名单，供缔约方会议审议(见本文件附件)。

4. 在拟定这一名单时，秘书处充分考虑了《公约》第七条第 6 款的规定以及既定的做法，即观察员组织须提交证明，证明其在联合国会员国或联合国一专门机构成员国、国际原子能机构成员国或国际法院缔约国中具有非营利和(或)免税地位。

5. 缔约方会议主席团成员已收到这份新的申请组织名单，对该名单所列组织没有提出反对意见。已通知这些组织它们获得了“被临时接纳地位”，但接纳观察员的最后批准权在缔约方会议。主席团还建议，邀请波兰可再生能源经济商会参加缔约方会议第十四届会议，但如果该组织想继续参加，必须在第十四届会议之后重新提出申请。

6. 请缔约方会议在第一次会议上给予附件中所列政府间组织和非政府组织观察员地位。

7. 同时是《京都议定书》缔约方的《公约》缔约方可能记得，第 36/CMP.1 号决定第 2 段(c)项规定，关于所适用的议事规则草案第 6 条和第 7 条：

- (a) 《公约》缔约方会议前几届会议获接纳为观察员的组织，也将获接纳参加《议定书》/《公约》缔约方会议第一届会议；
- (b) 接纳观察员组织参加缔约方会议的届会和《议定书》/《公约》缔约方会议的届会，将采用单一程序，由缔约方会议就接纳观察员组织问题作出决定。
