No **formal** meetings related to the process will be scheduled on that day. All **formal** meetings currently scheduled for Monday will be rescheduled to Tuesday, 9 December, at the same times.

All other meetings not directly related to the process, planned side events and press briefings at the COP 14 conference venue and in the City of Poznan, scheduled to take place on Monday, 8 December, will proceed as scheduled.
