Update on negotiations

As announced at the ADP informal stocktaking plenary on Saturday, 16 November, the Co-Chairs of the **ADP** will make available a draft COP decision on Monday morning and present it to the ADP at a **meeting at 10 a.m.** (Plenary 2).

In the afternoon of Sunday, 17 November, the **SBI** and **SBSTA** Chairs reported to the COP President on the status of work in their respective bodies, following the closure of SBSTA and the suspension of SBI on Sunday early morning.

The **SBI is expected to resume on Monday, 18 November, at 11.30 a.m.** (Plenary 1) to consider the outstanding items 4 (a) and 5 (a).

The SBI closing plenary will be followed by an **informal stocktaking plenary by the President at 12.15 p.m.** (Plenary 2).

Work on unresolved items under the SBI and SBSTA will continue under the authority of the President, who asked the two Chairs to undertake consultations on his behalf on a number of items. The Chairs will conduct consultations on these items and will report back to the President by Tuesday.

On one item the President has decided to request support from ministers, the names of which will be announced shortly.

SBSTA, 12 (a)	Methodological issues under the Kyoto Protocol: Implications of the implementation of decisions 2/CMP.7 to 4/CMP.7 and 1/CMP.8 on the previous decisions on methodological issues related to the Kyoto Protocol, including those relating to Articles 5, 7 and 8 of the Kyoto Protocol
