## Status report of the annual inventory of Kazakhstan

1. This status report was prepared by the secretariat pursuant to decision 13/CP.20, as part of the initial assessment of Kazakhstan's 2016 annual inventory, submitted in accordance with decision 24/CP.19. It reflects the content of the inventory submission of 2016 as originally submitted by the Party on 15 April, and of the resubmission received on 04 May 2016.

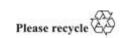
