
## Status of submission and review of second biennial reports

## Note by the secretariat

- 1. This note provides information on the status of submission and review of second biennial reports (BR2s) from Parties included in Annex I to the Convention (Annex I Parties) as at 28 February 2017.
- 2. The Conference of the Parties (COP), by decision 2/CP.17, paragraph 13, requested Annex I Parties to submit their BR2s by 1 January 2016.
- 3. In addition, the COP, by decision 2/CP.17, paragraph 12, adopted the "UNFCCC biennial reporting guidelines for developed country Parties", noting that developed country Parties shall use those guidelines for the preparation of their biennial reports (BRs). By decision 19/CP.18, paragraph 1, the COP adopted the common tabular format (CTF) for those guidelines and decided that developed country Parties shall use the format when preparing and submitting their BRs in accordance with decision 2/CP.17.
- 4. At the time of the preparation of this note, the secretariat had received 43 BR2s and 43 sets of corresponding CTF tables. A total of 28 Annex I Parties submitted their BR2s and 29 Annex I Parties submitted their CTF tables before the due date determined in decision 2/CP.17, while 15 Annex I Parties submitted their BR2s and 14 Annex I Parties submitted their CTF tables after that date, of which 7 submitted their BR2s and 6 their CTF tables within six weeks of that date. The textual part of the BR2 of Luxembourg was submitted on 6 June 2016. The textual part of the BR2 and the CTF tables of Ukraine have not been submitted. All BR2s and CTF tables received have been posted on the UNFCCC website.<sup>2</sup>

- 5. The secretariat received the sixth national communication (NC6) of Turkey on 5 April 2016.<sup>3</sup>
- 6. The COP, by decision 13/CP.20, adopted the "Guidelines for the technical review of information reported under the Convention related to greenhouse gas inventories, biennial reports and national communications by Parties included in Annex I to the Convention" (hereinafter referred to as the UNFCCC review guidelines) (annex to decision 13/CP.20) and decided that they shall be used for the review of BRs and national communications until any revisions to the guidelines are decided upon by the COP.
- 7. The secretariat coordinated 11 centralized reviews between 7 March and 11 June 2016, covering all BR2s submitted by Annex I Parties. The review of the NC6 of Turkey took place in conjunction with the review of its first and second BRs. Technical review reports of all reviewed BR2s were published on the UNFCCC website by 6 December 2016, well before the 15-month completion deadline for reviews as stipulated in the UNFCCC review guidelines. The dates of submission of the BR2s and the status of review reports are presented in the table below.
- 8. The delay in the submission of BR2s and corresponding CTF tables (see para. 4 above) hampered the effectiveness of the preparation and conduct of their review.
- 9. Multilateral assessment (MA) for 24 reviewed Parties<sup>7</sup> took place at a working session during the forty-fifth session of the Subsidiary Body for Implementation in Marrakech, Morocco, on 12 and 14 November 2016. The summary reports on the MA for those Parties have been published on the UNFCCC website.<sup>8</sup> MA for the remaining 18 Parties<sup>9</sup> is planned for the forty-sixth session of the Subsidiary Body for Implementation (May 2017).
