Reporting Obligations (who reports)

- Participating Parties are *subject to the reporting requirements of Article 6.2*, if the participating Party:
 - Host Party **authorizes** internationally transferred mitigation outcomes (ITMOs) and entities.
 - Host Party that **approves entities** in activities for which ITMOs are **authorized**.

Article 6.2 Reporting. Initial Report

A country participating in a cooperative approach does not have to report anything relating to Art. 6.2 ex ante, i.e. before it is engaged in the transfer of ITMOs. However, when a country is on the verge of transferring ITMOs, it **does have to submit an initial report** showing that it fulfils the participation requirements.

The initial report consists of four sections:

The initial report contains 4 main sections:

"no later than the authorization of ITMO"

The **first section** requires that the participating country confirms it fulfils the participation requirements).

The **second section** contains information about the NDC (target, types of targets, reference levels, scope, and coverage, implementation periods, intention to use cooperative approaches, etc).

The **third section** concerns the accounting of ITMOs and accounting of the NDC, and contains information on ITMO metrics, the method for applying **corresponding adjustments**, and the **method for quantification** of the NDC.

The **fourth section** includes information specific to the cooperative approach: Authorization by the participating country. Description and duration of the cooperative approach. Expected mitigation per year of the cooperative approach. Countries involved in the cooperative approach. Authorized entities. Description of how the cooperative approach ensures environmental integrity.

Article 6.2 Reporting. Initial Report (trigger and timeline)

(i) Trigger:

- the point in time when a Party becomes a participating Party by **authorizing the cooperative approach** as per paragraph 18 in Decision 2/CMA.3

(ii) Timeline (when the IR is submitted):

- After **authorizing the cooperative approach -> trigger**
- Not later than the **authorization of ITMO**

III. ITMO metrics, method for applying corresponding adjustments and method for quantification of the NDC

A. ITMO metrics.

- B. Method for applying corresponding adjustments** as per decision 2/CMA.3, annex, chapter III.B (Application of corresponding adjustments) for multi- or single-year NDCs that will be applied consistently throughout the period of NDC implementation and where the method is a multi-year emissions trajectory, trajectories or budget, description of the method
- C. Switzerland has ratified the Paris Agreement on October 6th 2017 and is a Party to the Paris Agreement.

B. Information on how the Party ensures that it has prepared, communicated and is maintaining an NDC in accordance with Article 4, paragraph 2 (para. 18(a), para. 4(b), to be updated by para. 21(a))

Switzerland has submitted the latest version of its updated NDC on December 17th 2021.¹ Switzerland's national CO₂ Acts (2022-24 in force; 2025-2030² under Parliamentary debate) anchor Switzerland's emission reduction targets and define domestic measures.

C. Information on how the Party ensures it has arrangements in place for authorizing the use of ITMOs towards achievement of NDCs pursuant to Article 6, paragraph 3 (para. 18(a), para. 4(c), to be updated by para. 21(a))

Switzerland's competent authority for authorizing the use of ITMOs is the Federal Department of Environment, Transport, Energy and Communications acting through the Federal Office for the Environment (FOEN). The competence is delegated to the FOEN through the bilateral agreements as well as Switzerland's national CO₂ Act. The bilateral agreements and the national CO₂ legislation include eligibility requirements for the authorizations.

D. Information on how the Party ensures it has arrangements in place that are consistent with the Article 6, paragraph 2, guidance and relevant decisions of the CMA for tracking ITMOs (para. 18(a), para. 4(d), to be updated by para. 21(a))

Switzerland uses the Swiss Emissions Trading Registry³ for the tracking of ITMOs which are recognized by Switzerland under Article 6.2. The ITMOs, which have been first transferred from Switzerland's partner countries will be issued in the Swiss Emissions Trading Registry as
