

Meeting of the Specialized Technical Committee of Ministers in charge of the Environment for the endorsement of the ECOWAS Regional Climate Strategy and the ECOWAS Climate Funding Access and Mobilization Strategy

Final Report

Accra, Ghana, April 29, 2022

I. INTRODUCTION

- 1. Following the meeting of Environment and Climate Change Experts from ECOWAS Member States held on 26-27 April 2022 in Accra, Ghana, the ECOWAS Commission organized a virtual ministerial meeting on 29 April 2022. This meeting brought together the Ministers responsible for the environment.
- 2. The main objective of the meeting was to endorse the strategic documents developed by the ECOWAS Commission, namely (1) ECOWAS Regional Climate Strategy and (2) ECOWAS Climate Finance Access and Mobilization Strategy.
- 3. The meeting was attended by the Ministers in charge of the Environment or their representatives from the following ECOWAS Member States:

II. OPENING CEREMONY

- 6. The ceremony was marked by speeches by the Executive Secretary of CILSS, the Commissioner in charge of Water Resources and the Environment of the WAEMU Commission, the Director General of Expertise France, the Commissioner in charge of Agriculture, Environment and Water Resources of ECOWAS, the representative of the Minister of Environment, Science, Technology and Innovation of Ghana.
- 7. In his speech, Dr. Abdoulaye Mohamadou, Executive Secretary of CILSS thanked the ECOWAS Commission and its partners for the development of these strategic documents on climate change. He recalled that climate change poses a serious threat to our planet and risks compromising the chances of meeting the challenges of poverty reduction in our West African region. Consequently, it is becoming urgent to systematically integrate the risks and impacts of climate change into development policies and programs, which still represents a challenge for the countries of our region.
- 8. The Executive Secretary of CILSS indicated that this version of the Regional Climate Strategy submitted to the Ministers for endorsement is the result of extensive consultation with the institutions and CILSS has largely contributed to it. He was also pleased that through the SRC, the regional institutions are combining their efforts to better manage the consequences of climate change, and find adequate and sustainable solutions to manage food insecurity, demographic question, the preservation of natural resources.
- 9. Finally, Dr. Abdoulaye Mohamadou reassured that CILSS it will spare no effort to play its part in this Regional Climate Strategy which is perfectly in line with its mandate to deliver local climate services. to the Sahelian and West African populations.
- 10. In his address, Prof. Kako Nubukpo, Commissioner in charge of Water Resources and Environment of the UEMOA Commission thanked the Minister of Environment, Science, Technology and Innovation of Ghana, the government and people of Ghana for hosting this meeting. He said he was happy to be part of the meeting on behalf of UEMOA. He congratulated everyone for their contributions at the national and regional levels. He reminded everyone that the complexity of climate change requires coordinated efforts at regional and national levels. Therefore, the development of Regional Climate Strategy is very vital for the West Africa region. He ended by reaffirming WAEMU's commitment to continue coordination with sister regional organizations including ECOWAS to fight against climate change.

- 11. The Director General of Expertise France, Jérémie PELLET, said he was happy to be part of the process ensuring the continued commitment of France and the EU. He indicated that the support for the development of this strategy was done in collaboration with the French Development Agency. He noted everyone that Expertise France has been working with ECOWAS and other organizations for over 10 years and that this collaboration should continue. Mr. PELLET said they were happy to have welcomed the support provided by Expertise France through the Global Climate Alliance for the development of the Regional Climate Strategy. He congratulated the ECOWAS Commission and other stakeholders while noting that no regional organization in the world has gone so far in the fight against climate change. He also said that the regional approach is essential because it goes beyond borders.
- 12. The Director General of Expertise France, recalled that this document is aligned with long-term vision for Africa. He ended by thanking all the stakeholders for their involvement in the development and validation process of the Regional Climate Strategy document and indicated that his organization will continue to monitor the implementation of the strategy.
- 13. In his speech, Mr. Sékou SANGARE, Commissioner for Agriculture, Environment and Water Resources, congratulated all the ministers, experts and regional bodies for their availability and their presence at this ministerial meeting. He thanked the Government of the Republic of Ghana for agreeing to host this meeting and providing the necessary facilities for the organization of the meeting.
- 14. Mr. Sangare, mentioned that the Declaration of the Heads of State and Government of ECOWAS on climate change adopted on December 12, 2021 instructed the ECOWAS Commission, among others, to acceleration the finalization and the implementation of the Regional Climate Strategy in collaboration with specialized regional institutions and Member States. Taking stock of this instruction, the ECOWAS Commission, with the support of the GCCA+ West Africa Project funded by the European Union, has finalized the draft RCS.
- 15. The Commissioner recalled that a strategy has no chance of achieving its objectives unless it incorporates the means necessary for its implementation. This is why, and with the technical support and facilitation of the Secretariat of the United Nations Framework Convention on Climate Change (UNFCCC), a Strategy for accessing and mobilizing climate finance for the region and the ECOWAS countries has been developed and pre-validated by Member State representatives in 2021.
- 16. The Commissioner called on the meeting of Ministers to adopt the Regional Climate Strategy and the Strategy for accessing and mobilizing climate finance which will be submitted to their attention for their endorsement before submitting them to the statutory Council of Ministers of ECOWAS for adoption.
- 17. In his speech, Mr. Peter DERY, Director of Environment representing Dr. Kweku Afriyie, Minister of Environment, Science, Technology and Innovation of Ghana, indicated that his Minister would have liked to take part to this important ministerial meeting but that its schedule was changed at the last minute.. He then welcomed, on behalf of the Government

of Ghana, the participants who are present in Accra. He also welcomed the opportunity given to him to deliver the opening speech of this important ministerial meeting aimed at validating two important documents on climate change for the ECOWAS region, another opportunity to act. , in a concerted manner, and to strengthen joint action in the fight against climate change.

- 18. Mr. Peter Dery went on to say that institutions need the capacity and knowledge to assess the climate vulnerability of new and existing infrastructure in order to plan and manage the potential impacts of extreme weather events. He also added that the implementation of the strategic documents will require additional financial resources from the government and development partner institutions.
- 19. The representative of the Honorable Minister ended by inviting all partners, in particular those present at the meeting, to support the implementation of the strategy. He concluded by calling on the meeting of Ministers to endorse these strategic documents which will be submitted to them.

III. ESTABLISHMENT OF THE MEETING BUREAU

20. The bureau of the meeting was established as follows:

IV. REVIEW AND ADOPTION OF THE AGENDA

- 21. Following the establishment of the bureau of the meeting, the Chair welcomed the participants and thanked them for their presence at the meeting. He submitted the agenda for adoption.
- 22. The agenda, appended to this report (Annex 2), was adopted unanimously.

V. ORGANIZATION OF WORK

23. During the working session, the two strategy documents were presented to the Ministers., The presentation of the strategies was followed by that of the report of the meeting of experts.

1) ECOWAS Regional Climate Strategy

24. Mr. Sékou Sangaré, Commissioner in Charge of Agriculture, Environment and Water Resources, presented the different parts of the Regional Climate Strategy (RCS). This presentation focused on the vision of the RCS which is that of "a community resilient to the effects and impacts of climate change and which has been able to seize the related economic opportunities in favor of sustainable development with low carbon emissions". This vision

- contributes to the achievement of the ECOWAS Vision 2050 and is fully in line with the Paris Agreement.
- 25. The Commissioner focused on the general objective of the ECOWAS Regional Climate Strategy which is to support Member States to take up the challenge of the fight against climate change, for the respect of their respective commitments under the Paris Agreement.
- 26. The six (6) specific strategic objectives of the RCS are as follows: (i) ensure the compatibility and coherence of the regional political framework with the global objectives of the Paris Agreement, (ii) develop the capacity for anticipation and decision-making to manage current and future climate risks, (iii) promote a change in the institutional and organizational paradigm on climate, (iv) build the capacities of ECOWAS and its Member States for the implementation of policies and actions to combat against climate change, (v) strengthen cooperation and solidarity between Member States in the face of climate change and (vi) promote approaches for mobilizing endogenous and exogenous financial resources.
- 27. The strategy covers adaptation and mitigation components, including approach, general context, sectors, sectoral context and expected results. Institutional arrangements and means of implementation with related actions were also presented and discussed.
- 28. The climate strategy also covers strategic sectors such as Agriculture, Livestock, Fisheries and Aquaculture, Energy, Transport and Mobility, Natural Ecosystems and Biodiversity, Water Resources, Coastal Zones, Health, Climate Services, Hydrometeorological and Climatological Systems, Early Warning Systems and Hydrometeorological and Climatological Disaster Risk Management, and Industry. Finally, the Regional Climate Strategy includes an action plan (2022-2030) which details the actions to be taken for its implementation.

2) ECOWAS Climate Finance Access and Mobilization Strategy

- 29. Mr. Sékou Sangaré, Commissioner in charge of Agriculture, Environment and Water Resources also presented the ECOWAS Climate Finance Access and Mobilization Strategy which aims to facilitate improved access and mobilization of climate finance for the implementation of priority climate mitigation and adaptation projects identified by the fifteen (15) ECOWAS Member States. This strategy sets out key actions to address identified challenges, barriers and opportunities to promote mobilization and access to climate finance for ECOWAS Member States. Implementing these strategic actions will help Member States bridge the current climate finance gap of approximately USD 294 billion for 2015-2030. The strategy and project pipeline were reviewed by experts and validated in July 2021.
- 30. This strategy identifies thirty (30) strategic actions in five strategic intervention areas which are (1) Improving the enabling environment to mobilize funds and catalyze private investment; (2) Improve capacity building to develop and implement mitigation and adaptation projects; (3) Improve capacities and mechanisms at national and regional levels for the coordination of climate finance; (4) Identify and mobilize effective, innovative and appropriate financing for priority climate actions; (5) Strengthen and develop systems for measuring, reporting and verifying the means of implementation.

- 31. The strategy implementation plan identifies key principles that will guide the implementation plan, stakeholders and institutional arrangements, mechanism for monitoring, evaluation, reporting and review, resources for implementation as well as the implementation pan (2022-2031).
- 32. At the end of his presentation, the Commissioner in charge of Agriculture, Environment and Water Resources also expressed the wish that the ministers give their approval to the ECOWAS regional climate strategy document which will be submitted to the ECOWAS Council of Ministers for adoption.
- 33. For his part, Chairman of the Bureau of the meeting requested that the report of the meeting of experts be presented.

3) Report of the meeting of Experts

34. The Chairman of the Experts' meeting, Mr Peter DERY, Director of Environment of Ghana, presented to the Ministers the report of the Experts which was held on April 26 and 27, 2022, emphasizing the contributions and recommendations of the participants as follows:

i) Regarding the ECOWAS regional climate strategy, highlights include:

- ✓ The document must be translated efficiently in order to harmonize the arrangements made;
- ✓ Waste should be considered as a sector under the mitigation section based on the deliverables proposed and validated during the meeting;
- ✓ The blue economy should be taken into account in the strategy;
- ✓ Further develop the role of CSOs and the private sector in the implementation of the strategy;
- ✓ Revise the coastal zone sector map to include Cabo Verde and mention the high vulnerability of small island states;
- ✓ A sub-committee set up by the president to review the trade component of the means of implementation recommended that most of the components under trade should be removed, with the exception of "Engaging in negotiations of regional or bilateral agreements the promotion access to new technologies that support low-carbon and/or resilient development". The team explained that there are already adequate trade-related protocols and conventions. The committee also recommended that a section on technology transfer be added to the document;
- ✓ Necessity to nclude the strengthening of the establishment and operationalization of operational units in terms of Corporate Social Responsibility (CSR) and climate (not specificities of recruitment) within the Commission.

ii) Regarding the ECOWAS climate finance access and mobilization strategy, highlights include:

- ✓ The ECOWAS Commission and Member States should take the necessary measures for the effective implementation of this strategy and its related documents such as the project pipeline and its action plan;
- ✓ Ministers of finance should consider the mobilization of the financial resources necessary for its implementation in the next budget of 2023-2031.

4) Discussions

35. After the presentations, the Ministerial Meeting commended the quality of these strategic documents which aim to strengthen the actions of the ECOWAS Commission in its support to Member States to deal with the effects of climate change while contributing to the implementation of the Paris Agreement. They also made some recommendations. In particular, Côte d'Ivoire has asked to remove "fishing" part from the agriculture, livestock and aquaculture sector because for Cote d'Ivoire fishing is a separate sector.

VI. DECISIONS AND RECOMMENDATIONS OF THE MEETING

- 36. At the end of the ministerial meeting, the Ministers approved the ECOWAS Regional Climate Strategy and the Climate Finance Access and Mobilization Strategy. They recommended the submission of the Strategy for adoption by the ECOWAS Council of Ministers. The Ministers made the following recommendations:
 - ✓ Use instruments such as green bonds to mobilize resources for financing climate actions;
 - ✓ Need for a harmonized legal and regulatory framework to benefit climate investments to transform the economies of the countries in West African Region;
 - ✓ Increase the mobilization of our internal resources, in particular through the establishment of a carbon market to enable greater involvement of the private sector
 - ✓ Strengthen access to the Green Climate Fund through the number of accredited regional entities to allow more direct access;
 - ✓ Include the waste sector in the mitigation component;
 - ✓ Set up a RCS measurement system (MRV) to have reliable information for monitoring execution.
- 37. Furthermore, the meeting of Ministers commended the ECOWAS Commission for the preparation of documents on key environmental issues in the region. The meeting also thanks all the stakeholders who contributed through their support, availability and advice to the drafting of these documents, namely the GCCA+ West Africa project implemented by Expertise France and funded by the European Union.

VII. CLOSING OF THE SESSION

38. Closing the meeting, the Chairman of the meeting Barr. Mohammed Hassan Abdullahi, Honourable Minister of Environment of the Federal Republic of Nigeria expressed his heartfelt thanks to his peers for the quality of the work and urged them to take ownership of this document prepared by ECOWAS in order to facilitate its implementation.
