## INFORMATION NOTE TO PARTIES AND OBSERVER STATES

### *Registration for the UNFCCC Climate Change Dialogues*

With reference to the [information note](#) of 9 September 2020 on the UNFCCC Climate Change Dialogues (Climate Dialogues), which will take place online from 23 November to 4 December, the UNFCCC secretariat wishes to inform Parties and observer States to the Convention, the Kyoto Protocol and the Paris Agreement that the online registration system (ORS) is now open for nomination of delegates for the Climate Dialogues events.

The list of events for which delegations should be nominated can be found in the annex. Owing to the technical limitations of virtual meeting platforms and the limits on how many participants can actively and effectively participate in a virtual meeting,<sup>1</sup> active participation in meetings open for registration that will be broadcast has to be limited to one delegate per Party and observer State. Additional delegates will be able to follow the event via broadcast.

For events that are open only to Parties and observer States and will not be broadcast, registration will be limited to two delegates per Party and observer State. If the number of participants registered for a certain event exceeds the active participation limit of the virtual meeting platform,<sup>2</sup> it may be necessary to limit participation in that event to one delegate per Party and observer State. In such a case, a broadcast would be made available exclusively to delegates registered for that meeting.

Focal points should nominate members of their delegation in the ORS, which is available at <https://onlinereg.unfccc.int>.

To allow sufficient time for the final preparations, including ensuring secure access to the events, **delegates need to be nominated and confirmed as early as possible and at the latest by Wednesday, 11 November 2020**. Nominated delegates will receive information regarding a simple procedure they need to complete to be able to access the events.

**Distribution:** To Parties and observer States to the United Nations Framework Convention on Climate Change through their national focal points and diplomatic missions accredited to the Federal Republic of Germany.

<sup>1</sup> “Active participation” means the ability to share one’s video with other participants, to request the floor and to speak at the meeting.

<sup>2</sup> The maximum number of active participants in a meeting on the platform that will be used is 250.

As this is the first series of virtual events of this scope organized by the secretariat, we kindly ask all focal points and delegates for their patience and understanding.
