### I. Opening of the session

1. The fourteenth session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP), convened pursuant to Article 13, paragraph 6, of the Kyoto Protocol, was held at the International Conference Centre in Katowice, Poland, from 2 to 14 December 2018. Mr. Michał Kurtyka, President of CMP 14, convened the 1st meeting of CMP 14 on Sunday, 2 December.


### A. Adoption of the agenda
