

## Draft conclusions proposed by the Chair

- 1. At the request of the Conference of the Parties,<sup>1</sup> the Subsidiary Body for Scientific and Technological Advice (SBSTA) considered the experience of conducting desk reviews of greenhouse gas (GHG) inventories taking into consideration the relevant conclusions from the meetings of GHG inventory lead reviewers up to 2017.<sup>2</sup>
- 2. Noting the conclusions from the 15<sup>th</sup> meeting of GHG inventory lead reviewers,<sup>3</sup> the SBSTA welcomed the information on the improvements in conducting desk reviews and recognized that ensuring a sufficient number of experts for desk reviews has been a challenge for the secretariat.
- 3. The SBSTA invited Parties to encourage and facilitate the participation of their nominated experts in desk reviews to enable the secretariat to organize desk reviews with the sufficient number of experts and ensure geographical balance in the expert review teams.
- 4. The SBSTA noted from the conclusions from the meetings of lead reviewers referred to in paragraph 1 above that the organization of desk reviews has benefited from
