Paris Agreement work programme

Draft conclusions proposed by the Co-Chairs

Pursuant to the requests of the Conference of the Parties (COP)² and the Conference of Parties serving as the meeting of the Parties to the Kyoto Protocol,³ the Ad Hoc Working Group on the Paris Agreement (APA) agreed to forward the proposals by its Co-Chairs for the outcomes of its work on the Paris Agreement work programme (PAWP), as presented in the annex. The proposals are being forwarded for consideration at COP 24 without prejudice to the content and form of the final outcome of the PAWP and recognizing that further work by the COP is necessary to finalize the PAWP outcome.

^b Different views have been expressed by Parties on whether some of the possible additional matters should be added to the Paris Agreement work programme for CMA 1. The possible additional matters are: (1) modalities for biennially communicating finance information on the provision of public financial resources to developing countries in accordance with Article 9, paragraph 5, of the Paris Agreement; (2) guidance by the CMA to the operating entities of the Financial Mechanism (the Green Climate Fund and the Global Environment Facility) under Article 9, paragraph 8, of the Paris Agreement and decision 1/CP.21, paragraphs 58 and 61–63; (3) guidance by the CMA to the Least Developed Countries Fund and the Special Climate Change Fund in accordance with decision 1/CP.21, paragraph 58; (4) guidance by the CMA on the adjustment of existing nationally determined contributions under Article 4, paragraph 11, of the Paris Agreement; and (5) setting a new collective quantified goal on finance in accordance with decision 1/CP.21, paragraph 53.
