## **MESSAGE TO PARTIES AND OBSERVER STATES**

### **Sixth High-level Ministerial Dialogue on Climate Finance 14 November 2024**

**and**

### **High-level Ministerial Dialogue on the Urgent Need to Scale Up Adaptation Finance 19 November 2024**

#### **Meeting Room 11, Baku Stadium**

On behalf of the incoming COP 29, CMP 19 and CMA 6 Presidency, I am pleased to inform Parties and observer States to the Convention, the Kyoto Protocol and the Paris Agreement that the high-level ministerial dialogues on climate finance topics, to be held during COP 29 are scheduled as follows:

- **Thursday, 14 November 2024** from 10:00 to 13:00 (GMT +4) - Sixth High-level ministerial dialogue on climate finance.
- **Tuesday, 19 November 2024** from 15:00 to 18:00. (GMT +4) - High-level ministerial dialogue on the urgent need to scale up adaptation finance.

#### **Sixth high-level ministerial dialogue on climate finance**

The COP at its twenty-sixth session, decided to continue discussions on long-term climate finance and to convene biennial high-level ministerial dialogues on climate finance in 2022, 2024 and 2026. The dialogue will focus on the progress and fulfilment of the goal of mobilizing jointly USD 100 billion per year by 2020 through to 2025, to address the needs of developing countries in the context of meaningful mitigation action and transparency on implementation.

The COP 29 President will prepare a summary of the deliberations at the high-level ministerial dialogue, for consideration at COP 30.

**Distribution:** To Parties and observer States to the United Nations Framework Convention on Climate Change through their national focal points and diplomatic missions accredited to the Federal Republic of Germany.



**High-level ministerial dialogue on the urgent need to scale up adaptation finance**

CMA 5 decided to convene a high-level ministerial dialogue at its sixth session on the urgent need to scale up adaptation finance, taking into account the adaptation-related outcomes of the global stocktake, and to ensure the mobilization by developed country Parties of the adaptation support pledged.

Both events will have a webcast. While the ministerial dialogues are open to all Parties and observer States, owing to the limited capacity of the meeting rooms, access to Parties and observer States will be limited to one minister or deputy minister or head of delegation, plus one accompanying member of the delegation. Tickets for in-person participation will be allocated to Party representatives. Further information on ticket distribution will be shared with national focal points in due time.

The aim of the COP 29 Presidency during these events is to facilitate interactive discussions whereby all participants can take the floor more than once and react to other interventions. In this regard, participants will be requested to make succinct and focused interventions. Parties and observer States will be able to share their full statements in writing for publication on the web pages of the dialogues.
