Further to the communications dated 24 March 2025, the secretariat is pleased to announce the publication of the programme for the first Climate Week 2025: Dialogues for Ambition and Implementation, which will take place in Panama City, Panama from 19 to 23 May.

- 23 May: Consultation to present the updated NAP technical guidelines to Parties

Each mandated event taking place during Climate Week will be organized in accordance with its respective mandate under the Conference of Parties serving as the meeting of Parties to the Paris Agreement and Subsidiary Bodies.

## **Implementation Forum Day**

The programme also provides information on the Implementation Forum Day, which will take place on Wednesday, 21 May, with a series of events and will conclude with a plenary session on Thursday, 22 May.

The Implementation Forum Day will feature, among other activities, *COP 30 Incoming Presidency special events* and the *Implementation Labs*. These labs are designed to facilitate multistakeholder engagement aimed at identifying actionable solutions across three key areas: finance, technology, and carbon markets.
