Discussion topic for the third dialogue under the United Arab Emirates Just Transition Work Programme

As the chairs of the SBSTA and the SBI, we have been tasked by decision 3/CMA.5¹ with guiding the secretariat in organizing at least two dialogues this year, with one to be held prior to the first regular sessions of the subsidiary bodies at their sixty-second sessions (June 2025), and one prior to the second regular sessions of the subsidiary bodies, at their sixty-third sessions (November 2025), and that such dialogues should be conducted in hybrid format to allow both in-person and virtual participation. Decision 3/CMA.5² also requires us to decide on the topics to be discussed under the dialogues this year, taking into consideration the submissions from Parties, observers and other non-Party stakeholders.

Following an informal virtual consultation on the topic for the third dialogue under the UAE Just Transition Work Programme held on 20 March 2025, we are pleased to communicate to Parties and observer organizations that the third dialogue will focus on: **“Approaches to enhancing adaptation and climate resilience in the context of just transitions”**.

We would like to encourage Parties, observers and other non-Party stakeholders to submit via the [submission portal](#), views on opportunities, best practices, actionable solutions, challenges and barriers relevant to the topic of the third dialogue as early as possible, and no later than four weeks before the third dialogue³, in order for us to share the agenda well in advance. Our preparation of the agenda and concept note will be informed by the submissions referred to above, as well as by the interventions on sub-topics and guiding questions made by Parties and Groups during the Informal virtual consultation held on 20 March 2025.

Information on further details and participation by Parties, observers and other non-Party stakeholders to the third dialogue will be communicated through the proper channels as it becomes available.
