**Online Registration - Virtual-only Participation**

**United Nations Climate Change Conference, SB 64  
8 – 18 June 2026  
Bonn, Germany**

The secretariat refers to the forthcoming sixty-fourth sessions of the Subsidiary Body for Scientific and Technological Advice and the Subsidiary Body for Implementation (SB 64) to be held from **8 – 18 June 2026** at the [World Conference Center Bonn](#) (WCCB), Platz der Vereinten Nationen 2, 53113 Bonn, Germany and wishes to inform Parties and United Nations systems, specialized agencies and other relevant organizations that the online registration system (ORS) (available at <https://onlinereg.unfccc.int/>) is now open for delegations to register participants for virtual only participation in the sessions.

The Virtual-only tab to register participants to attend sessions will remain available until the confirmation deadline **7 June 2026, 23:59** Central European Summer Time (CEST).

The Virtual-only registration enables access for delegates to the UNFCCC online platform for SB 64, allowing them to attend or follow meetings remotely as applicable. Delegates registered for ‘Virtual-only’ participation are registered for the full period of the session and will be able to access the online platform for the duration of SB 64.

Please note that online access will be limited to official plenary sessions, press conferences and negotiation meetings and mandated events only. Virtual participation in other events, such as side events, will not be available through the platform. In addition, Mandated events, as well plenary meetings and press conferences will be publicly available via the UNFCCC website.

Delegates who have already been registered for onsite participation at SB 64 will be able to participate both physically in-person and virtually via the online platform.
