MESSAGE TO PARTIES AND OBSERVER STATES

Third dialogue under the United Arab Emirates Just Transition Work Programme

22 - 23 May 2025
Panama City, Panama

I refer to the [Message to Parties and Observers](#) dated 2 April 2025 regarding the discussion topic for the third dialogue under the United Arab Emirates Just Transition Work Programme (UAE JTWP) and am pleased to invite Parties and observer States to the Convention, the Kyoto Protocol and the Paris Agreement to the third dialogue under the UAE JTWP, scheduled to take place during [Climate Week-1 2025: Dialogues for Ambition and Implementation](#)¹. The new Climate Weeks will have a global focus.

The third dialogue is being organized pursuant to decision 3/CMA.5, by which the CMA decided that at least two dialogues shall be held each year as part of the UAE JTWP and requested the secretariat to organize those dialogues under the guidance of the Chair of SBSTA and Chair of SBI.

Pursuant to the same decision, the Chair of the Subsidiary Body for Scientific and Technological Advice (SBSTA), Adonia Ayebare, and Chair of the Subsidiary Body for Implementation (SBI), Julia Gardiner have selected the topic: *“Approaches to enhancing adaptation and climate resilience in the context of just transitions”*.

Under the guidance of the Chairs of the SBSTA and SBI, the third dialogue will take place in Panama City, Panama from **22 to 23 May 2025** in a hybrid format. One full-day session is planned on 22 May and a half-day session is planned on 23 May.

Distribution: To Parties and observer States through their national focal points and diplomatic missions accredited to the Federal Republic of Germany.

Nomination and registration

Parties are invited, through their national focal points, to nominate a maximum of **two in-person participants**, and up to **six virtual participants**.

Owing to limited availability of financial resources, the secretariat is not in a position to fully fund participants (travel and daily subsistence allowance) for the third dialogue. However, the secretariat is able to provide funding limited to three days of daily subsistence allowance to Panama City, Panama, for one in-person participant from each eligible Party. This daily subsistence allowance can be provided to a participant who has been nominated by a Party as the first funded in-person participant to attend the fifth global dialogue and investment-focused event under the Sharm el-Sheikh mitigation ambition and implementation work programme from 19 to 20 May, or to a participant who may wish to cover their cost of travel to attend the dialogue using their own funds.

For the former case, travel arrangements will be coordinated by the secretariat and the cost of ticket modification will be borne by the secretariat. The dialogue will be held in a hybrid format, with connection details shared with all registered participants in due time. The dialogue will also be broadcast live for those interested in following without active participation.

The Party Nomination Form for Climate Week-1 Mandated Events which will allow Parties and observer States to nominate representatives to attend the third dialogue on-site or virtually is now open for nominations. National Focal Points can find the nomination form for the third dialogue [here](#). Details on using the portal and access code are included in the guidelines for using the INDICO platform, attached to this communication. The system will remain open for nomination of participants requiring funding support until **11 April 2025, CEST 23:59**.

This form is the only official channel for nominating participants for this event. The secretariat is not in a position to process nominations submitted by any other method. Please note that it **is imperative that a correct and unique email address be provided for each nominated participant** for swift processing of nominations and initiating registration. Once a participant has been nominated for an event, they will directly receive an email with registration details via Indico UN. Logistical details related to travel and participation will be shared directly with registered participants.

In view of the need to confirm the arrangements for the third dialogue as early as possible, nominations of participants requiring funding support received after the deadline of **11 April 2025, CEST 23:59** cannot be processed.
