Dear colleagues,

We are pleased to provide further information on the organization of the second workshop in 2024 under the Sharm el-Sheikh dialogue.

The second workshop in 2024 will take place in **Sharm el-Sheikh**, **Egypt**, **on Sunday**, **6**, **and Monday**, **7 October 2024**, **in a hybrid format**. The focus topics of the second workshop, as announced in the <u>message</u> dated 6 May 2024, will be on the role of the international financial system and of different actors within and outside the Paris Agreement, and on transparency and credibility with a focus on the avoidance of greenwashing and maladaptation. Further details, including the provisional programme and logistical information, will be made available in due course at <u>https://unfccc.int/sharm-el-sheikh-dialogue</u>.

The second workshop will take place in conjunction with a series of events that are held back to back in Sharm el-Sheikh, Egypt. All of the events will be organized in accordance with their respective mandates under the CMA and Subsidiary Bodies.

- Second Dialogue under the United Arab Emirates just transition work programme, 2-3 October
- Fourth global dialogue and fourth Investment focused event under the Sharm el-Sheikh Mitigation Ambition and Implementation work programme, **4-5 October**
- Second workshop in 2024 under the Sharm el-Sheikh dialogue on the scope of Article 2, paragraph 1(c) and its complementarity with Article 9 of the Paris Agreement, **6-7 October**
- Workshop under the United Arab Emirates–Belém work programme on indicators, 8-9 October

All of the four above mentioned events will follow separate registration processes according to their respective mandates.

Regarding participation for the second workshop in 2024 under the Sharm el-Sheikh dialogue, we are pleased to invite United Nations organizations and admitted international organizations to register for participation in the workshop.
