The 3<sup>rd</sup> meeting of the Katowice Committee of Experts on the Impacts of the Implementation of Response Measures

Pursuant to decisions 7/CP.24, 3/CMP.14 and 7/CMA.1, I am pleased to notify United Nations organizations and admitted intergovernmental organizations that the 3<sup>rd</sup> meeting of the Katowice Committee of Experts on the Impacts of the Implementation of Response Measures (KCI) will take place from 5 to 9 October 2020. Owing to current travel restrictions resulting from the COVID-19 pandemic, it will be held in a virtual format from 13:00 to 16:00 Central European Time each day.

In view of the need to confirm the arrangements for the meeting as early as possible, please be advised that the secretariat may not be able to process observer registrations received after this deadline.
