## NOTIFICATION

### Meetings of the Supervisory Body for the mechanism established by Article 6, paragraph 4, of the Paris Agreement

I am pleased to notify Parties and observer States to the Convention, the Kyoto Protocol and the Paris Agreement, United Nations organizations, and intergovernmental and non-governmental organizations admitted as observers about the upcoming meetings of the Supervisory Body for the mechanism established by Article 6, paragraph 4, of the Paris Agreement and the deadlines for submitting public comments on the issues included in the related annotated agenda and for registering as observers.

The annotated agenda for each meeting and other relevant documents will be made available **two weeks** prior to each meeting on the relevant page of the UNFCCC website (<https://unfccc.int/process-and-meetings/bodies/constituted-bodies/article-64-supervisory-body/meetings-of-the-article-64-supervisory-body>). Public comments on the matters included in the annotated agenda may be submitted to [Supervisory-Body@unfccc.int](mailto:Supervisory-Body@unfccc.int) up to **one week** prior to the meeting, and will be considered by the Supervisory Body at the respective meeting and made publicly available.

Meetings of the Supervisory Body are open to Parties, observer States and observer organizations in accordance with the rules of procedure of the Supervisory Body (see [decision 7/CMA.4, annex II, chap. VI.E](#)) and will be webcast publicly for live or on-demand viewing. To enable the widest possible representation of observer organizations, in-person attendance will be limited to one observer per meeting. Given space limitations, if the demand is too high, access may have to be limited further. Those interested in registering as observers for a meeting should forward their request to [Supervisory-Body@unfccc.int](mailto:Supervisory-Body@unfccc.int) no later than **three weeks** prior to the meeting; the secretariat will not be able to process registration requests received after this deadline.

**Distribution:** To Parties and observer States through their national focal points and diplomatic missions accredited to the Federal Republic of Germany, United Nations organizations and intergovernmental and non-governmental organizations admitted as observers by the Conference of the Parties.
