## NOTIFICATION TO NON-GOVERNMENTAL ORGANIZATIONS

The 5th meeting of the Katowice Committee of Experts on the Impacts of the Implementation of Response Measures

Pursuant to decisions 7/CP.24, 3/CMP.14 and 7/CMA.1, I am pleased to notify constituencies of admitted non-governmental organizations (NGOs) that the 5<sup>th</sup> meeting of the Katowice Committee of Experts on the Impacts of the Implementation of Response Measures (KCI) will take place virtually from 11 to 12 October 2021 from 13:00 – 16:00 CEST each day, and on 13 October 2021 from 13:00 – 14:30 CEST; and in person, in Glasgow, United Kingdom from 28 October (14:30) to 30 October (12:30).

In accordance with the modalities and procedures adopted by decision 7/CMA.1, the meeting of the KCI will be open to attendance, as observers, by all Parties and accredited observer organizations unless otherwise decided by the Committee.

To register for participation in the next meeting, representatives from NGOs nominated by the constituency focal point must register for the meeting using the observer registration form for NGOs, which is sent to constituency focal points by Monday, 4 October 2021. Kindly note that only two representatives per constituency will be permitted to participate in the virtual meeting. All other interested in the meeting may follow the proceedings via live broadcast. In view of the need to confirm the arrangements for the meeting as early as possible, please be advised that the secretariat may not be able to process observer registrations received after this deadline.
