12<sup>th</sup> Focal Point Forum of the Nairobi work programme "Diversifying economic activity as an adaptation strategy"

Katowice, Poland Wednesday 5 December 2018 18:30–21:00

I am pleased to invite Parties and observer States to the United Nations Framework Convention on Climate Change (UNFCCC) to the 12<sup>th</sup> Focal Point Forum of the Nairobi work programme (NWP), at the Katowice Climate Change Conference.

The Forum will be held under the guidance of the Chair of the SBSTA and will convene Parties, experts, and other interested stakeholders. The event will focus on economic diversification in accordance with the outcomes of the 48<sup>th</sup> session of the Subsidiary Body for Scientific and Technological Advice.<sup>1</sup>
