NOTIFICATION

United Nations Climate Change Conference 6–16 June 2022, Bonn, Germany

I wish to notify Parties and observer States to the United Nations Framework Convention on Climate Change, the Kyoto Protocol and the Paris Agreement of the forthcoming fifty-sixth sessions of the Subsidiary Body for Scientific and Technological Advice and the Subsidiary Body for Implementation (SB 56).

The sessions will be held from 6 to 16 June 2022 at the [World Conference Center Bonn](#) (WCCB), Platz der Vereinten Nationen 2, 53113 Bonn, Germany. The provisional agenda for SBSTA 56 and SBI 56 can be found on the [conference page](#).

The online registration system (available at <https://onlinereg.unfccc.int/>), which allows Parties to nominate representatives to attend sessions, is now open for registration for SB 56, and will remain open until the end of the conference. The manual on how to access and use the system is available at https://onlinereg.unfccc.int/onlinereg/public/UNFCCC_ORIS_User_Manual-Parties_and_Observer_States.pdf. ORS is the only official channel for nominating participants for SB 56. The secretariat is not in a position to process nominations submitted by any other method. Please note that it is **imperative that a correct and unique email address be provided for each delegate** for the swift processing of registration confirmations. The email that will be sent to each delegate confirmed in ORS will include a link to a page for indicating COVID-19 vaccination and recovery status. Only once this has been done will the delegate receive the acknowledgment letter. Please see annex II for further information related to COVID-19.

At SB 56, active participation in negotiations will be limited to on-site participants. Those who have received their conference badge on site but are unable to come to the venue will be able to take part in negotiations via the digital platform. Remote participants not badged on site will be able to watch broadcasts of open meetings. Remote participants not badged on site may also be able to actively participate in certain mandated events via the digital platform. Funding	<i>A separate communication will be sent to eligible Parties in due course.</i>
Visas	<p>All foreign delegates entering Germany must have a valid passport.</p> <p>Participants requiring a visa are strongly encouraged to contact the appropriate consular authorities as soon as possible following receipt of this notification. The issuance of a visa for Schengen States may take up to two weeks from the date of submission of the visa application. To facilitate the issuance of a visa, a copy of the acknowledgement letter from the online registration system must be attached to the visa application.</p> <p>Participants are advised that obtaining a Schengen visa is contingent on the participant securing comprehensive insurance that covers their entire stay. If travelling more than once, it is recommended to obtain insurance that covers the period of all intended stays.</p> <p>Participants should indicate also if a Schengen visa has been issued to them in the last 59 months. Nomination and registration online	<p>All participants wishing to attend the sessions must be duly registered.</p> <p>Online registration is now open for nomination and confirmation of representatives by Parties and observer States.</p>
COVID-19 regulations	<p>Participants will be required to fully comply with and adhere to COVID-19 health and safety regulations as mandated by the host country and the United Nations. <p>Registration at the conference venue</p>	<p>From Tuesday, 31 May, to Friday, 3 June 2022, the registration desk will be located in the Altes Abgeordnetenhaus at the United Nations Campus, Platz der Vereinten Nationen 1, 53113 Bonn.</p> <p>As of Saturday, 4 June 2022, the registration desk will be located at WCCB, Platz der Vereinten Nationen 2, 53113 Bonn.</p> <p>Upon arrival, participants will be requested to proceed to the registration desk during the hours indicated below to collect their badge for access to the conference premises.</p> <p>The confirmation letter on the participant’s registration from the online registration system and a valid passport or nationally approved identification card should be presented to the registration staff for the issuance of the badge.</p> <p>Registration times:</p> <p>From Tuesday, 31 May, to Sunday, 5 June 2022, from 8:30 a.m. to 6 p.m.</p> <p>From Monday, 6 June, to Saturday, 16 June 2022, from 8 a.m. to 7 p.m.</p> <p>Early registration before Monday, 6 June 2022, is highly recommended to avoid delays on the first day of the conference.</p> <p><u>The conference venue, including registration, will be closed on Sunday, 12 June 2022.</u></p> <p>Multiple registrations for the conference are not permitted (i.e. registration as an observer organization representative and a Party or State representative and/or press/media representative).</p>
<p>Conference venue opening hours</p>	<p>The venue will open by 8 a.m. and close at 7 p.m. for the duration of the conference.</p>
<p>Badges</p>	<p>An official UNFCCC conference badge is needed to access the premises. The badge is issued only on the basis of a confirmation from the online registration system. For security reasons, all participants are requested to wear their badges visibly at all times.</p>
<p>List of participants</p>	<p>The list of participants will reflect information as provided in the ORS during the registration process.</p>

To facilitate access, weblinks to the updates will be included in the Daily Programme.</p> <p>The side event schedule will be accessible through the UNFCCC website, CCTV screens and the free UN Climate Change mobile app. Information on outside events may also be posted on the UNFCCC website.</p> <p>The secretariat strongly encourages disseminating material electronically only.</p>
