The 28th meeting of the Technology Executive Committee 16–18 April 2024 Copenhagen, Denmark

Pursuant to the rules of procedure of the Technology Executive Committee, contained in <u>annex II to decision 4/CP.17</u>, I am pleased to notify Parties and observer States to the United Nations Framework Convention on Climate Change, the Kyoto Protocol, and the Paris Agreement of the following meetings:

- The **28**th **meeting of the Technology Executive Committee**, to be held in Copenhagen, from 16 to 18 April 2024, from 9 a.m. to 5 p.m. (Central European Summer Time) each day;
- The joint session of the Technology Executive Committee and the Advisory Board of the Climate Technology Centre and Network, to be held in Copenhagen, on 19 April 2024, from 9 a.m. to 5 p.m. (Central European Summer Time).

The meetings will be open to observers in accordance with the above-mentioned decision. In accordance with decision 23/CP.18 and with a view to informing more effective climate change policy that addresses the needs of women and men equally, the UNFCCC secretariat encourages the nomination of women participants. Owing to space limitations, access may be limited for in-person participation. However, the meetings will be webcast through the UNFCCC website.
