### Overview of GCF Programming

Country and Entity Programmes are foundation, resulting in project proposals **READINESS:** i. NDA strengthening Leveraging \$100s Project ii. Strategic frameworks of millions to PPF **NDCs** (including Country Concepts address Programmes) countries' climate iii. Direct Access support change priorities iv. Adaptation Planning

Structured Dialogues and direct access events further support funding proposal quality



### Readiness: Four Areas of Support

1. NDA strengthening

2. Strategic frameworks

Up to USD 1M per country per year

3. Support for direct access entities

4. Adaptation planning processes

Up to USD 3M per country (not per year)

# 10 Review Criteria based on good practices to date

#### 1. Focus strategically within a national vision

- Build on existing multi-sectoral planning
- Greater sectoral or geographic focus produces more precise and implementationready planning

#### 2. Plan to address specific climate impacts and vulnerabilities

- Focus most crucial climate impacts and vulnerabilities
- Avoid temptation to do same process in different countries

#### 3. Develop financing strategy for each adaptation priority

- Prioritize and design adaptation project ideas and concept notes
- Identify ways to continually fund sectoral and local planning



## 10 Review Criteria based on good practices to date

#### 4. Articulate theory of change

- Clear vision of how each output and their activities will achieve the desired result/outcomes
- Link GCF country programmes, to national development plans, to project proposals

#### 5. Avoid duplication of effort

- Use existing information (e.g. vulnerability assessment)
- Articulate how new GCF funding will build on / link with previous processes

#### 6. Engage stakeholders proactively

• Civil society, sub-national governments etc.



## 10 Review Criteria based on good practices to date

#### 7. Build gender considerations

 How social dimensions, including differences based on gender, will be integrated into the proposed activities.

#### 8. Cultivate private sector investment

Create strategies to cultivate investment in climate resilient businesses

#### 9. Monitor and report systematically

Establish results based framework and report on progress

#### 10. Coherence and complementarity with other funds

Including with GEF and Adaptation Fund



### Adaptation Planning Support Progress and Outlook

#### Challenges

Contextualizing proposals based on national context

Design attract investment, including GCF project pipeline

Limited secretariat staffing to to support growing demand

2017 progress

Established transparent review criteria

Improved timelines and consistency of feedback

Improved guidance with good practices and outcomes

2018 outlook

Increase focus on quality and impact from GCF support

Deepen guidance and knowledge sharing

More proactive support to NDAs for design of proposals with national delivery partners
