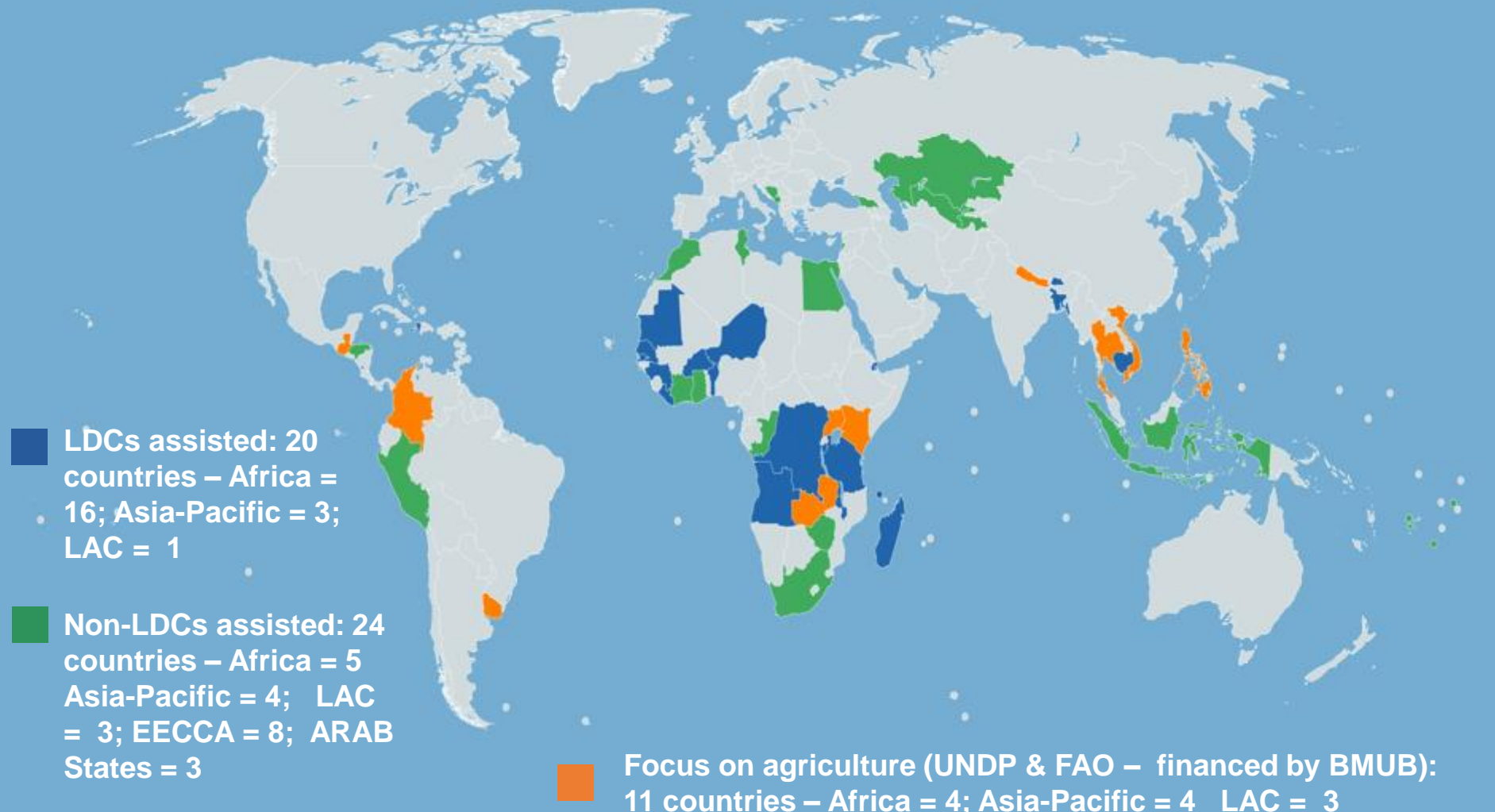

 - ✓ Pacific, LDCs in Africa in 2018 (TBC)
 - ✓ 3 others planned for 2018-2019

- Case studies on NAPs
 - ✓ Liberia, Niger, Senegal and Bhutan; Myanmar, Gambia and Malawi.

- NAP-SDG and NAP-NDC synergies explored:
 - ✓ At regional level in Asia, contributed to the research papers on SDGs
 - ✓ At global level, contributed to global NDC conference and global UNDP-UNEP-WRI publication on NDC Implementation

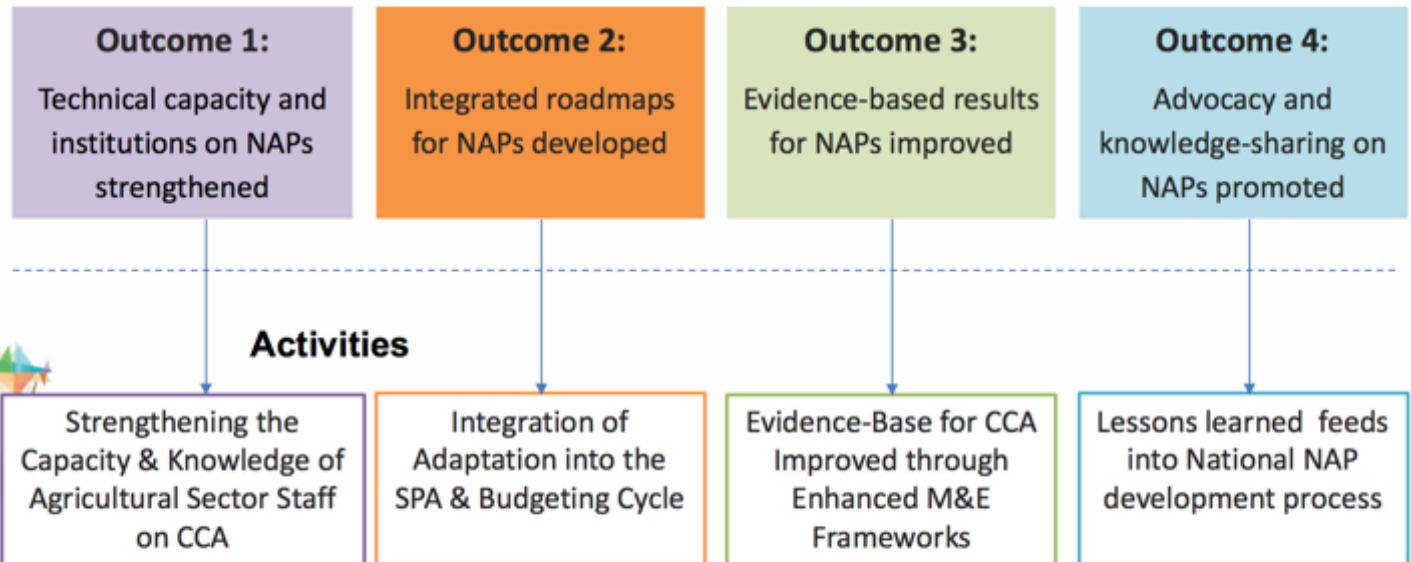

Programme Highlights

1. **Advanced the development of climate change adaptation planning strategies and frameworks in the agriculture sectors in Kenya, Philippines, Thailand and Uganda**
2. **Enhanced capacities of agriculture sector's decision-makers to appraise adaptation options, using cost-benefit analysis and impact evaluation, as a means to advance the NAP processes in Uganda, Uruguay and Zambia**
3. **Initiated the leveraging of climate finance for the implementation of climate change adaptation strategies and frameworks in the agriculture sectors in Nepal, Thailand and Viet Nam**
4. **Boosted capacity for gender mainstreaming through:** technical training; incorporation of sex-disaggregated data and gender analysis into cost-benefit analyses and impact evaluations; and development of a tool to increase women's incomes in the agriculture sector's value chains
5. **Catalysed global attention to the integration of agriculture into NAPs through engagement of NAP-Ag country representatives in:** Least Developed Country Expert Group (LEG) training workshops and meetings; side events at COP 21 and COP 22; Adaptation Committee meetings; and NAP Expos
6. Launched the **Agriculture Supplement to the LEG Guidelines**

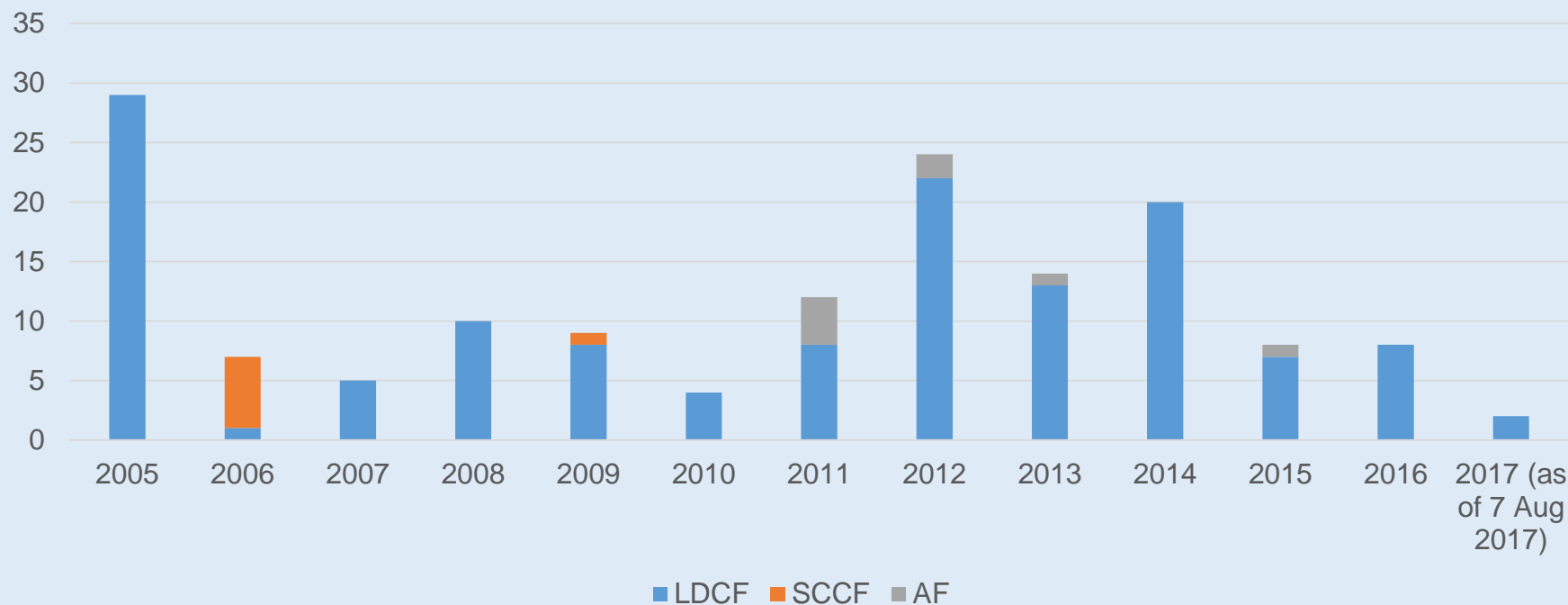

Number of LDCs accessing LDCF/SCCF/AF with UNDP Support

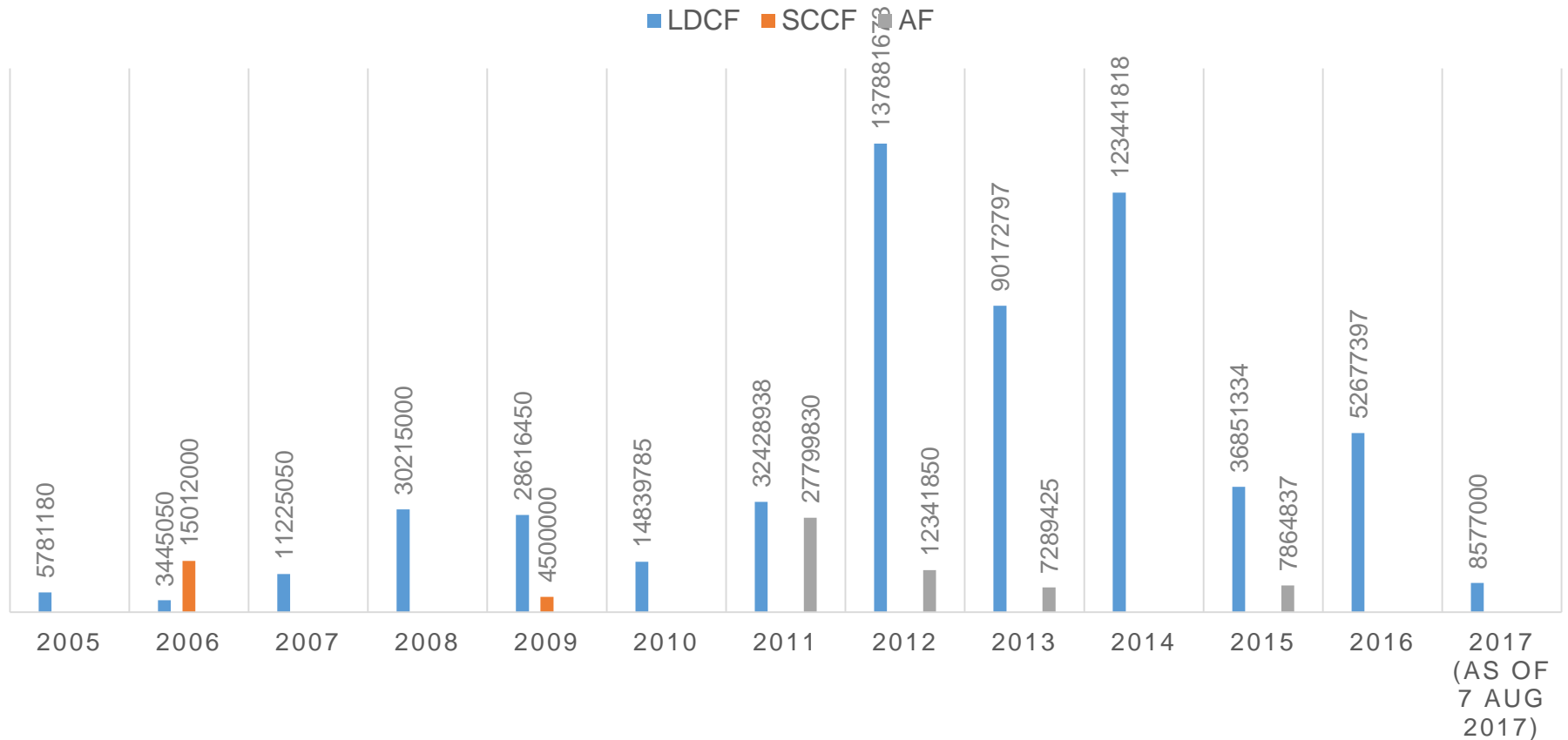

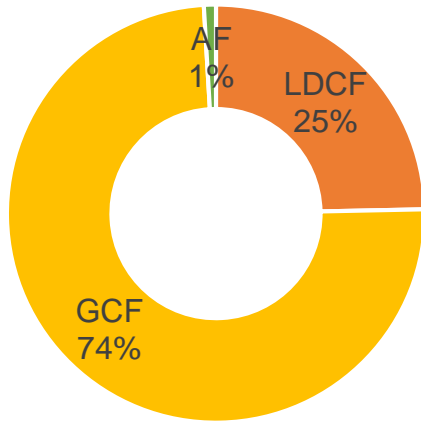

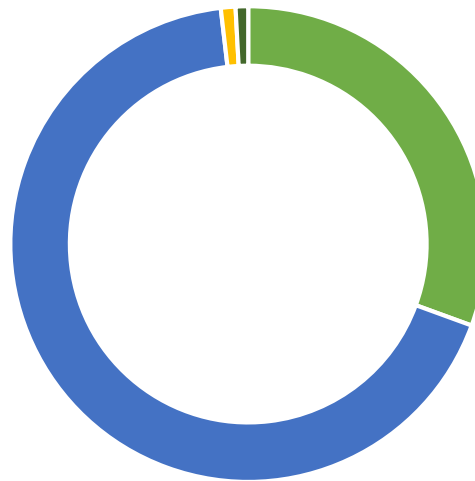
Funds distribution (% USD)



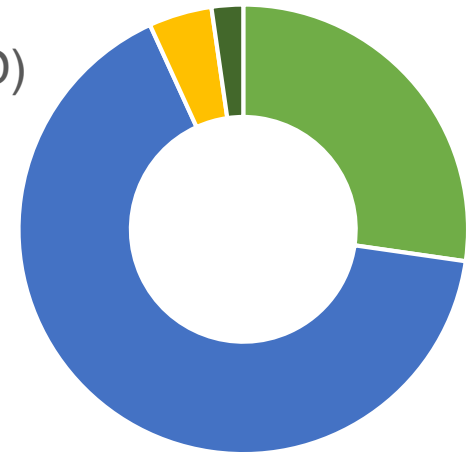

Climate Budgeting & Financing Frameworks: Use of UNDP tools and approaches for mainstreaming climate finance into budgeting and financing strategies:

- *Climate Change Financing Frameworks (CCFF)*
 - ✓ LDCs: Bangladesh, Cambodia, Nepal
- *Climate Public Expenditure and Institutional Reviews (CPEIRs)*
 - ✓ Completed: Bangladesh, Bhutan, Cambodia, Ethiopia, Kiribati, Nepal, Vanuatu, Uganda, Tanzania
 - ✓ In process: Benin, Mozambique, Zambia and Namibia
- Similar analyses being supported at sub-national level in Bhutan, Nepal, and Pakistan, and tracking integrated Climate and Disaster Risk Reduction spending in Laos, Cambodia, Thailand and Vietnam.

- Skill development in economic appraisal methods for climate change impacts on key sectors, including cost benefit analysis of investment options
- 2 regional trainings in Asia with AIT in August 2017 and March 2018
- Partnerships launched with Fletcher School of Tufts University, Commonwealth Scientific and Industrial Research Organization, and University of Pretoria to use data from ECCA to generate knowledge products and research papers

 - ✓ Nepal: significant capacity building of the NDA through targeted trainings, development of knowledge products and engagement in development of investment frameworks for CCA/CCM in high mountain ecosystems
