I. On-site participation

3. The names of participants for whom a physical badge was printed with validity dates covering at least one day of the sessions are listed in an Excel file on the UNFCCC website.¹

4. The Excel file on the UNFCCC website contains 12 worksheets; the corresponding statistics are presented in table 1. For participants with multiple nominations by different nominators, the Excel file includes only information from the last used badge, namely the last active badge. If a participant had no active badge, information from the last printed badge was used.
